## Redistricting to Change Voting Location for Some

When election day rolls around next year, most Putnam voters will continue to vote in the same precinct and at the same location as in past elections — most, but not all. Precinct 32 (Fraziers Bottom area) will disappear. A portion of 32 will be joined with a small section of Precinct 30 (Pliny area) to form Precinct 3. The southern portion of Precinct 32 will become part of existing Precinct 31 (area north of Hurricane). The division of Precinct 32 and creation of the new Precinct 3 was made necessary by the new delegate district lines which were approved by the West Virginia Legislature.

The new delegate district lines also made for changes in the existing bounds of Precincts 27,

28, 29 and 43 and the creation of a new Precinct 12 and Precinct 24. Precinct 12 will be made up of portions of Precincts 27 and 28. Precinct 24 is the portion of existing Precinct 29 which is south of the CSX tracks. Precinct 24 voting will be at Camp Appalachia.

For residents voting at West Teays Elementary (Precinct 43), the new delegate district lines will shift a small number into neighboring precincts. Some will be voting at Hurricane High School (Precinct 42), some at Mountain View Elementary (Precinct 29), and some at Valley Park (Precinct 33). Most who have voted at West Teays will continue to vote at the school.

The new delegate district lines mean new voting locations for some

## A Taste of Putnam's Past: Upper Vandalia Historical Society Meeting

The Upper Vandalia Historical Society met this last Sunday, October 31, at Bancroft Church of God Mission. Prior to the COVID pandemic, the club held quarterly meetings, but this is only the second time since the club has met since January of 2020. The theme of the meeting was show and tell, with guests encouraged to bring historical artifacts to discuss.

Ron Allen displayed a copy of an 1804 map and survey of a 2,000 acre tract of Teays Valley which corresponds to the present day area between the Teays Valley and Hurricane I-64 exits. The tract was jointly owned by heirs of William Morris and Shedrick Harriman. The surveyors divided the tract into equal portions.

The dividing line appears to be the exact location of Springdale/Cow Creek Road of today. The map and survey were formerly the property of the James W. Estes family.

Hotch Parkins of Poca brought a railroad spike from the Courtney railroad which was constructed to transport timber from areas in northern Putnam County to the Kanawha River. Mr. Parkins also showed a family tree wall hanging which he inherited from his cousin, Wayne Casto. The collection contained tintype photographs, letters, and other family memorabilia.

Joyce Hanna of Winfield shared photocopies from

Todd Hanson's book, "Plymouth," about Putnam County's coal mining history. Hanson was the speaker at the July meeting.

## Meet Some of Hurricane's Oldest Families

In 1988, The Centennial History of Hurricane, WV was published to commemorate the town's 100th anniversary. Since the Centennial History Breeze is reprinting articles from the book as space allows. This week's selection will be the 217th installment of the Centennial History.

In 1859 Laura Ingalls Wilder was writing about life in remote Minnesota. At approximately the same time, John Henry Sovine was born to John McDaniel Sovine and his wife, Catherine Taylor, in Hurricane, Virginia, on October 23, 1859.

John McDaniel came from Craig County, Virginia, to Teays Valley, Putnam County, Virginia, in 1838. He married Catherine Taylor who was born about 1838.

## Patients Counting on Blood Donors as Shortage Continues

With Thanksgiving and the holidays approaching, the American Red Cross urges donors to continue to make and keep appointments now and in the weeks ahead to help overcome the ongoing emergency blood shortage that has significantly impacted the nation's blood supply. In fact, the current blood supply is the lowest the Red Cross has seen this time of year in more than a decade.

Since declaring an emergency need for donors last month, thousands of people have come to Red Cross blood drives across the country to roll up a sleeve and help patients who are counting on lifesaving transfusions. ## W. Va. Symphony Orchestra Presents Celebration of Keys

The West Virginia Symphony Orchestra (WVSO) continues its 2021-22 season with performances of Celebration of Keys on Nov. 13 and 14 in Charleston and Parkersburg.

The WVSO will be back on stage for its second concert in the Elliot Foundation Symphonic Series on Saturday, Nov. 13 at 7:30 p.m. at the Clay Center in Charleston. The concert begins with Music Director Lawrence Loh leading the WVSO through a performance of Adolphus Hailstork's An American Port of Call. The overture, which premiered in 1985, is an ode to the energy and business surrounding Norfolk, the port city where Hailstork lived at the time. Most recently, Hailstork received a Distinguished Alumnu Award from the Manhattan School of Music, making him the first Black composer to receive such an honor.

Music Director Lawrence Loh said, "I met Adolphus Hailstork while conducting his music with the Pittsburgh Symphony several years ago. Dr. Hailstork is an important

American composer, a kind person and a unique voice in our musical landscape."

Fan-favorite pianist, Jon Nakamatsu returns to Charleston to perform Rachmaninoff's Piano Concerto No. 2. Nakamatsu is no stranger to the WVSO family, as he helped to choose the orchestra's Steinway piano years ago. The program wraps up with an epic performance of Shostakovich's Symphony No. 5.

## Snowplow Drivers Gearing Up For Winter: WVDOH Hiring Statewide

It's still October, but West Virginia Division of Highways is thinking ahead to keep drivers safe in snow and ice.

Drivers in WVDOH District 1 just finished their dry runs for winter snowplow routes.

"We want to make sure that our trucks are well-maintained, greased, and that all the equipment is working properly," said District 1 Maintenance Engineer Kathy Rushworth, P.E. Running snowplow routes early also allows drivers to familiarize themselves with their routes and get used to driving the snowplows,

which handle differently with plows on the front that they do during their summer job as dump trucks.

District 1 has 215 drivers assigned to drive plows in the snow and ice. They're the same men and women responsible for cutting grass, trimming trees, cutting ditches and doing other maintenance work during the spring, summer, and fall. For DOH, taking care of the roadways is a year-round job.

The district has 10 plows dedicated to Boone County, 10 to cover Clay County, 39 for Kanawha County, 14 for Mason County, and 13 for Putnam County. Another 38 snowplows are responsible for clearing snow and ice on US 35 and interstates 64, 77, and 79.

Rushworth said there is room for more drivers, and there are jobs available for Transportation Workers not only in District 1, but statewide.

There were seven children born to this union - John Henry Sovine being the eldest.

On April 24, 1890, John Henry married Nancy Lucretia Browder. There were thirteen children born to this couple - all born in Hurricane, West Virginia. William Hobart Sovine, the subject of this short biography, was the fifth child born to this union, being born on West Virginia's birthday, June 20, 1898.

Hobart always had a zeal to learn. He attended Signal Gap School, which was near the family home. There was not a high school in Hurricane at the time Hobart was in school. He went to Signal Gap until he was in his late teens. Then he went to work wherever there was work.

While taking census for Putnam County, William Hobart Sovine met and "courted" Birdie Dare Mitchell, daughter of the Reverend Michael Floyd Mitchell and Olivia Bowles Mitchell. Somewhat later, on September 19, 1921, they were married. To this union was born a daughter, Virginia Dare, on July 12, 1922, who married Edward Malcolm Chapman, Jr., on June 3, 1949. Edward died in 1981.

Virginia Dare and Edward Malcolm had two daughters - Melanie Kay, born July 30, 1950 and Kimberly Jane, born May 27, 1959. Melanie Kay Chapman married Darrell Lee Welker on June 18, 1968. Darrell died in 1985. They

had two boys - Jeremy Lee Welker, born on November 20, 1973, and Jared Mitchell Welker, born July 10, 1980. Kimberly Jane Chapman married Michael Wayne Edwards on August 15, 1981. They had a son, Christopher Michael Edwards, born on October 23, 1985.

William Hobart Sovine went into the store business in 1921. Hobart's first store was located on the corner of Putnam Avenue and Conner Street. W.H. Sovine General Merchandise was established in 1921. Hobart rented the store building from E.J. Qualls and his wife, Mary, until 1944 when he went out of the grocery business. In the latter part of 1945, Sovine Furniture came into existence. This was located on Putnam Avenue where the John D. Henson Senior Citizens Center now stands. The building was first owned by W.H. McCallister; then William and Nita Wheeler purchased it from Mr. McCallister. Hobart rented the building until 1964 at which time he purchased the building from Mrs. Wheeler.

Hobart Sovine was an extremely hard working, ambitious man. He, too, was charitable, benevolent, and compassionate to his customers, church, and family.

Mr. Sovine was a member of the First Baptist Church where he served as church treasurer for many years, taught the Men's Bible Class for more than two decades, and was on the

Deacon's Board.

Hobart remained in the furniture business until 1980 when he sold the store building to the Town of Hurricane, making way for the John D. Henson Senior Citizens Center.

William Hobart Sovine passed away on June 5,

1982, at the golden age of 83.

in Precinct 27. Some will vote with Precinct 41 voters at the Holiday Inn, others at Scott Teays Elementary with Precinct 25 voters, and some with Precinct 12 voters. Some Precinct 28 voters will be shifted to Precincts 11, 12 and 27.

The Putnam County Commission is expected

to approve these changes in precinct boundaries at its upcoming meeting. Failure to approve the changes would require voting multiple ballots at a single precinct.

Putnam County Clerk stated that Early Voting will remain unchanged. In 2020, Early Voting was conducted at both Valley Park and at the courthouse in Winfield.

nephew, Eric Parsons and brother in law, Gary Parsons.




He left behind his wife, my mother, Eva Fisher, his son-in-law, George Armstead, his grandson, Brad Armstead and his wife Julie, and his two precious Great-Grand children who

adored, Kelci aka "Dap's Darling," and Braeden Armstead aka "Little Man." 

## BASIC BIBLE

### Moses Prayer and God's Answer Numbers 14:13-24

"And Moses said unto the Lord. . ." (v. 13). Moses was responding to that which the Lord announced in verse 12. The Lord stated that He would smite the unbelieving children of Israel with pestilence, disinherit them, and make a great nation of Moses.

This is not the first occasion on which the Lord proposed making a great nation of Moses. When Israel turned from the Lord at the mount in Sinai to create and worship a golden calf (Ex. 32:10), the Lord stated that He would make a great nation of Moses. At that time, Moses asked the Lord to turn from His anger. Moses said that the Egyptians would think that He had led Israel out of the land to slay them. Moses asked the Lord to remember His promise to Abraham, Isaac and Jacob (Ex. 32:13). That which takes place in the text before us mirrors that which occurred in Exodus 32.

In verses 14-16, Moses stated that the nations who witnessed the Lord's power and presence as a pillar of cloud by day and a pillar of fire by night would attribute the death of the children of Israel (the Lord's people) to His failure to deliver upon His promise to bring them into the land that He had promised to the seed of Abraham.

Moses asked the Lord to pardon the iniquity of the people. He implored the Lord to let His long-suffering and mercy be seen. Moses challenged God to show His greatness by continuing to forgive the children of Israel (v. 19).

Why? Why did Moses petition the Lord as he did? It was not for personal gain. The Lord had stated that He would make of Moses a nation greater than the two million individuals whom He had led out of Egypt. Moses did not harbor doubt of the Lord's power to fulfill His word. The Lord had repeatedly spoken to Moses in a direct manner and Moses had seen all that the Lord had said come to pass. Moses knew with certainty that the Lord could make a greater nation of him than the multitude which passed through the waters of the sea.

Moses did not want God to smite the people because he feared that the Egyptians and others would interpret the demise of Israel as the Lord's inability to do that which He had promised. Moses wanted all people to know that the Lord God of Israel is a keeper of His promises and the God above all gods. Moses wanted all people to revere God because He is the one God. Moses desired that the Lord's name be lifted up. His heart's desire was Lord-directed, not self-directed.

These things are recorded such that believers might know the Lord in a more perfect way. The Lord's promise of the land of Canaan to Abraham's seed was not dependent upon His long-suffering and mercy. Moses was of Abraham's seed. The Lord could have fulfilled His promise to Abraham through Moses.

In verse 20, we see His long-suffering and mercy with clarity. The Lord pardoned Israel as Moses had asked. Moses had asked the Lord to forgive the iniquity of the people as He had done from the coming out of Egypt until now (v. 19). The Lord's forgiveness is not one-and-done. The Lord is a giver of second chances. New Testament believers, like the children of Israel, fail to love Him as He loves us. We rejoice in that God gave His only begotten Son upon the cross as payment for our every sin. We rejoice in that He is faithful and just to forgive our sins and clean us from all unrighteousness when we confess our iniquities (I Jn. 1:9).

In verse 21, the Lord swore to Moses that as surely as He is, the earth shall be filled with His glory. New Testament believers have been called to make His glory known. We are to go, and to teach, and to baptize in the name of the Father, the Son, and the Holy Spirit (Matt. 28:19).

While the Lord pardoned and forgave the people as Moses had petitioned, there would be everlasting consequences for failing to trust in Him, the Lord God. All who had seen the Lord's glory and miracles and tested His long-suffering and mercy would not see the land which He had promised Abraham, Isaac and Jacob (v. 22). Only two of all of adult age, Caleb and Joshua, would see the land.

"But my servant Caleb, because he had another spirit with him, and hath followed me fully, him will I bring into the land whereinto he went; and his seed shall possess it" (v. 24). The spirit which was in Caleb that was absent in the others was the spirit of belief. Caleb believed that the Lord had given the land to the children of Israel. Caleb acted upon his belief. He urged the people to go into the land and possess it (Num. 13:30). Caleb's belief would be rewarded. The seed of Caleb would possess the land because God is a rewarder of those who believe Him.

New Testament believers have come to God, believing that He is, and that He is a rewarder of them that diligently seek Him (Heb. 11:6). Let us diligently follow our calling. Let us declare His glory to all.
