

## County Commission to Act on Firearms Text Amendment

The County Commission will consider several proposed text amendment changes to the zoning ordinances for the unincorporated areas of Putnam County at its meeting tonight (September 30).

Before the County Commission approves a proposed change in a zoning ordinance, it first determines if the change will promote the health, safety, convenience, and general welfare of the public.

Current zoning ordinance does not allow the sale of firearms and the operation of a pawnshop within 300 feet of a residence. At its meeting, the County Commission will consider a change recommended by the Putnam County Planning Commission on September 21. At that meeting, the Planning Commission voted unanimously to recommend that the 300-foot restriction be lifted for firearms sales but not for pawnshops. The unanimous vote followed hearing from Dolores Lowe who resides within 300 feet of Valley Outdoors, a seller of firearms. Lowe stated that potential home buyers would not want to locate near Valley Outdoors because it sells firearms and ammunition. She feels less safe now than she did before Valley Outdoors began selling firearms in June.

If two of the three Putnam County Commissioners vote to approve the recommended zoning change, every resident in the zoned unincorporated areas of Putnam County whose residence is within 300 feet of a C-1 zoned area could see a gun shop pop up next door.

Commission approval of the recommended zoning change will mean that at least two Commissioners believe that firearms sales within 300 feet of a residence promotes the safety and general welfare of Continued on Page 3

## TMMWV celebrates 25 years at Buffalo

As Toyota Motor Manufacturing West Virginia (TMMWV) celebrates 25 years of producing engines and transmissions, a keen eye is looking down the road at the next quarter century and the excitement that exists as this plant contributes to Toyota's mission of "Mobility for All."

"The future of this plant is unlimited," said Srini Matam, president of TMMWV. "We are well positioned for the next 25 years as innovation and advanced manufacturing lead the way. We continue to build more efficient engines and transmissions and we are deeply engaged in hybrid technologies and robotics."

While supporting Toyota's global mission of "bringing the joy and freedom of movement to all," this plant in Buffalo has grown and expanded in the past 25 years:

Buffalo is only Toyota plant in North America that makes both engines and transmissions – it has produced nearly 20 million powertrains since 1996.

The Buffalo plant is the only plant in North America that produces hybrid transaxles for the Sienna and Highlander.

It is the only Toyota plant worldwide that produces under one roof this stable of engines: ZR 1.8-liter 4-cylinder, GR V-G 3.5-liter, and TNGA 2.5-liter 4 cylinder.

Since its inception, TMMWV has expanded 11 times.

Coinciding with the 25-year anniversary celebration, The Toyota USA Foundation has awarded a \$189,000 grant to West Virginia University Institute of Technology. The grant supports a new after-school computer science program for middle schools in four West Virginia counties: Putnam, Kanawha, Fayette, and Raleigh.

"This is an investment in our future," said Carolyn Long, WVU Tech campus president. "The program will help young people see the opportunities ahead and give them the tools to pursue interests in robotics, cybersecurity, game development and more. We hope that this will be a model program that will expand throughout the state."

Shamaya Morris, a production group leader at TMMWV, said it is a smart investment for the future.

"The first thing I tell people is that Toyota West Virginia is an advanced manufacturing facility. We program and set up robots to work around people and alleviate the burden of heavy lifting and repetitive motions. We make it safe for the team members on the floor. We use the brawn behind the robot but need the team member's brain and cognitive abilities."

Meantime, West Virginia Gov. Jim Justice points to Toyota's staying power and overall investment in the Mountain State. "I could never thank the incredible folks at Toyota Motor Manufacturing West Virginia enough for all the goodness they've brought to the town of Buffalo and our entire state over the past 25 years."

He added: "Their commitment to our communities and our people has been off-the-charts. Toyota has been a wonderful partner to our great state and is a shining example of how a global company can truly thrive in West Virginia. I congratulate them on a quarter century of success and wish them all the best in the years and decades to come."

For Matam, the common denominator for the plant's success is the 2,000 team members.

"The ability of our people to adjust and learn new advanced manufacturing principles is incredible. From our folks on the line to the engineers and across the Continued on Page 3)

THE FRANCIS MARION SOVINE FAMILY Submitted by Kathryn Coyner

Henri Sovine migrated to America from France and married a Miss Holpayne of Virginia. A son, Henry Sovine II, was born in 1802, one year before Thomas Jefferson was elected President of the United States.

When Henry II was a young man, he married Catherine Courtney Thomas. Nine children were born to this couple, one being Joseph Thomas in 1827.

anything else I needed. My car was not moved from March to August more than a couple of times. We were not in each others home during 2020... until vaccinated and then, cautiously. Eventually, I learned to order my groceries online and pick them up. Knowing my family was protecting me, and I them... made it worthwhile... we did what was expected. I know other families congregated and went on with life... so be it... we took no chances...

M y e l d e s t granddaughter who studied in Greece and Italy was in England for her junior year last semester. She was, of course, sent home and studied online with them. During the Pandemic and working from home, she and her youngest sister, delivered food from restaurants, to make money for college because, of course, she couldn’t go in and work... She did return to Purdue in the fall and graduated this year. The only ones permitted at her graduation were her parents, and the students did not walk across the stage. After studying at NYC as an intern in June, she has been hired by a publisher in NYC. She will work from home, hoping to move there in the new year... all because of Covid. Her special 21st birthday was meeting me at the park... outside... masked... her family celebrated, the five of them, at home. July 2020...

The middle grand, a junior in college this year, was sent home last year to work online. She wasn’t permitted to work at her jobs... her volunteer job at the church ended... she delivered food and groceries also, like her sisters. She is supposed to go overseas for a semester, but that is now cancelled also. Hopefully, classes will continue on campus and her jobs will continue this year... Her birthdays were celebrated quietly also.

T h e y o u n g e s t granddaughter, home schooled, was pretty much isolated... being at home with parents, working from home... her sisters... her volunteer jobs ended... she is a junior in high school and working on her driver’s license and now volunteering at church and the library... that is going well, so far... her fifteenth birthday was a drive through party... and her sixteenth, this year, was limited...

The elder grandson was in third grade at his gifted school... he learned online... stuck to a computer all day... with the teacher and other students... no Tae Kwan Do... no play dates... just the family... along with his younger brother, studying Kindergarten virtually... no activities... just like his brother...

It was especially difficult for the little boys because they were used to being around other kids... they did continue swimming in their pool, biking, and running... So far this year, the boys are in 4th and 1st at the gifted school. They recently had a drive

through celebration for Grandparents’ Day, and I was so happy to see all the little kids wearing masks... not complaining...

After I moved here to Florida in March, my first trip since Covid, and my last... the boys came... I was vaccinated... all of my family are vaccinated, but some of them have since had Covid... thankfully, they are okay... friends have passed away with it... acquaintances have... so many... (The boys are too young to be vaccinated...) My son works from home... his job is in California... my son-in-law works from home... togetherness has become important... changing our lives... After I was vaccinated, I started going to the grocery... Opening time... for fifteen minutes... and out... surprised to see others not masking... just in case.

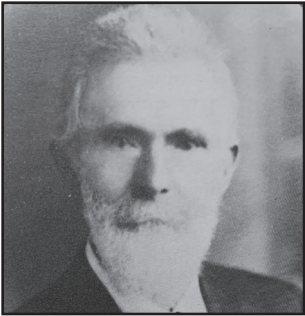
Doctors’ appointments were Facetime...dentist and eye doctor not to be... I am now going to the dentist regularly for crown replacements... and eye doctor for new glasses and contacts... have an appointment with a family doctor later in the year... life as we know it... gone for now...

Is Covid real? I have no doubt... our lives are changed... this caution does not come from lack of faith... it comes from reality... it amazes me that those who refuse to vaccinate, a great scientific breakthrough, will not hesitate to use doctors and hospitals... does that make sense to me? No... I don’t know the side effects... I also don’t know the side effects from surgeries I have had, medications I am on... I know that having seen what Covid does... I don’t want to take any chances... I am trying...

The little boys don’t remember much of life before Covid, especially the younger one... he just wants it to be over... there is only way that this epidemic will be over... for the majority of the population to take a shot... to mask... to isolate or distance. I remember lining up for the Polio vaccine... I remember taking my children to get their vaccinations before they were permitted to attend school... this is not political... it is worldwide and people are dying daily... still... I have no answers... I just want to be able to say, “I am flying to WV to see my friends...” And to be able to make that statement without saying, “When Covid is over...” because the way we were is the way we are... hopeful... praying... wishing... hoping... that others would do what should be done... The sad part of all of this... one really sad part of this... tearing friendships and families apart because instead of making this about what it is... COVID... they are making it about the rights we have... the politics... religion... all of the issues that we can’t discuss because of the problems that ensue... I believe that this is medical... just an opinion from a woman who has lived it... seen it...

moved westward, settling in Teays Valley in 1838. They made their home northward of Hurricane Bridge on Sleepy Creek, where Joseph grew to manhood.

At the age of 24, in 1851, Joseph married Amanda Young. They made their home near Joseph’s parents. The home where he reared his family is still standing (1987) and occupied by a descendant of Joseph.

Joseph T. Sovine served three terms as justice of the peace.

He was a founder and charter member of the First Baptist Church in Hurricane.

Joseph’s vocation throughout his lifetime was farming. Joseph and Amanda had ten children, the oldest being Francis Marion, who was born March 20, 1852.

In 1865 as the boys in Blue and Grey came trudging home after four years of fighting in the Civil War, Ida Mae Thacker was born in Ohio to a minister and his wife. When Ida was a young girl of 20, she traveled to Hurricane with her father who was having a revival. There she met Francis Marion, known as “Frank,” and in 1886 they were married. For a short time they lived in what is now the Allen Funeral Home, before moving to a farm on Sovine Road. This farm remained in the family for ninety-nine years.

“Frank” became known for his fruit farming, developing an apple called the “Hurricane Apple.” To help support his growing family “Frank” taught

school for many years.

“Frank” and Ida had five children, Randolph, who became a farmer and lived on the farm for 96 years. Monica who taught school in Putnam County and lived to be 97. Iva also became a teacher in Putnam and Kanawha counties and later moving to Florida for health reasons. Iva lived to be ninety-five. Ralph also became a farmer and inherited his father’s horticultural mind. Ralph was continually grafting and developing new and different plants and fruits. The youngest was Florence, who was a member of the first graduating class of Hurricane High School in 1923.

Only two of “Frank” and Ida’s children married. Florence married Clay Fleshman Carpenter, son of Dr. James Henry Carpenter and Zelinda Estelle Leonard Carpenter and Iva, who married Lloyd Harrison.

Florence and Clay gave “Frank” and Ida Mae two grandchildren, Kathryn June and James Marion. There are two great grandchildren, Laura Ann Coyner, daughter of Kathryn and Ronald L. Coyner, and Lisa Ann Carpenter, daughter of James and Jeannette Pickens Carpenter.

everyone residing in the affected area.

At the September 21 Planning Commission meeting, the owner of Valley Outdoor, Glenn Yeager II, stated that the Planning Commission recommendation did not affect him because firearms sales were ongoing before issuance of the recommendation. Valley Outdoors is located at 3034 Mt. Vernon Road in Hurricane and has been selling firearms since the third week of June.

Current zoning law requires businesses which operate as a seller of firearms to obtain a Special Permit. Valley Outdoors has never obtained a Special Permit.

In July, Judge Phillip Stowers issued an order which allowed Valley Outdoors to continue firearms sales until he rules on the matter. Judge Stowers has yet to act upon a request by attorneys for County Commission, Planning Commission, and Board of Zoning Appeals which would require Valley Outdoors to cease firearms sales at 3034 Mt. Vernon Road.



## Blood Needed

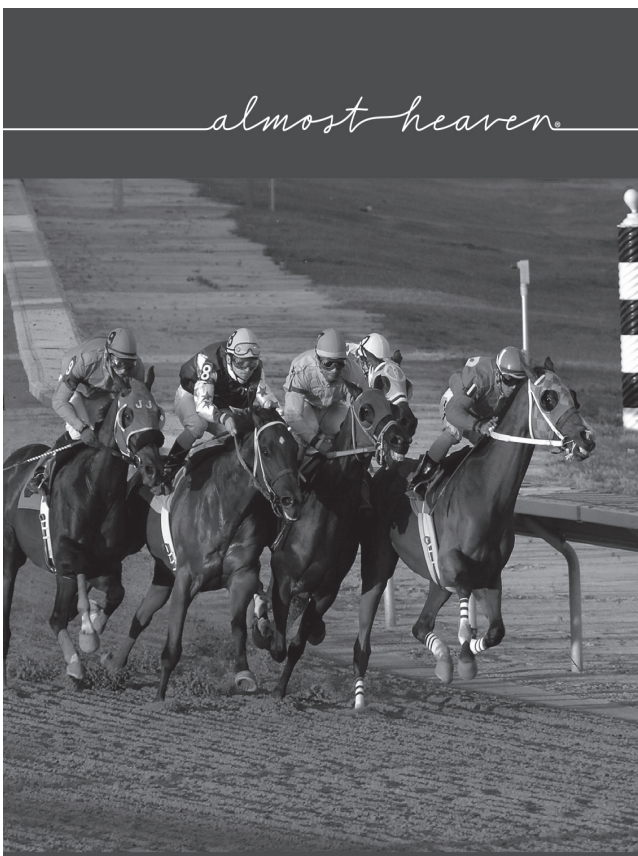
The American Red Cross is experiencing an emergency blood shortage and must collect 10,000 additional blood products each week over the next month for the blood supply to recover and meet hospital and patient needs. Donors of all blood types – especially type O – and platelet donors are urged to make an appointment to give now and in the weeks ahead to overcome this current shortage.

Blood donor turnout has reached the lowest levels of the year as many delayed giving amid a return to the workplace and in-person learning, as well as a recent surge in COVID-19 cases across the country due to the delta variant. As cases spiked in August, blood donor participation decreased about 10%, but blood product distributions to hospitals have remained strong, significantly outpacing blood donations in recent weeks.

The national Red Cross blood inventory is the lowest it's been at this time of year since 2015, with less than a day's supply of certain blood types in recent weeks. The supply of types O positive and O negative blood, the most needed blood types by hospitals, dropped to less than a half-day supply at times over the last month – well below the ideal five-day supply.

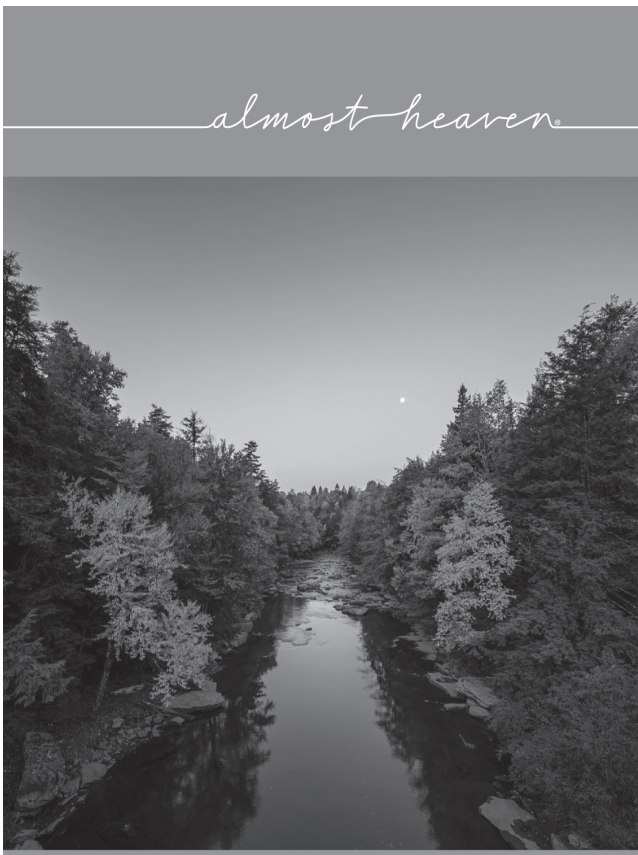
“Fall is typically a time when the blood supply rebounds as donors are more available to give than during the busy summer months, but this year has presented a unique and serious challenge,” said Dr. John Nobiletti, medical director for the Red Cross Central Appalachia Region. “While it's clear the pandemic continues to weigh heavily on our minds, the Red Cross asks the public to remember donating blood and platelets is essential to the many patients that rely on lifesaving transfusions every day.”

## Complaints About Manna

Numbers 11:4-6, 10-23

The text before us centers around manna. Both the children of Israel and the mixed multitude which were with them complained because there was nothing to eat except manna. The people had been eating manna for about one year.

Following their departure from Elim when they came out of Egypt, the Lord gave the children of Israel manna to eat when their food supply ran out (Ex. 16:1). That date would have been between the fifteenth day of the second month of the first year and the third month of the first year [the date of their arrival at the mount in Sinai] (see Ex. 19:1). The date of their complaining in the text before us was shortly after the twenty-third day of the second month of the second year (Num. 10:11, 33).

The children of Israel wept and said, “Who shall give us flesh to eat? We remember the fish which we did eat in Egypt” (v. 5). They also longed for the produce of Egypt.

Compare these words to that which they uttered one year earlier following their departure from Elim. “Would to God we had died by the hand of the Lord in the land of Egypt, when we sat by the flesh pots, and when we did eat bread to the full” (Ex. 16:3).

The two complaints are almost identical. The Lord’s response in the text before us, however, is far different from that which is recorded in Exodus 16. The anger of the Lord was kindled by the complaining multitude (v. 10). This was not the case one year earlier.

When Israel came up out of Egypt, they possessed limited knowledge of the Lord. In the year in which they camped before the mount, the Lord revealed Himself to Israel by giving them all of the instruction set forth in Leviticus. The Lord faithfully provided for their physical needs by causing manna to fall from heaven six days each week. Israel did not acknowledge the blessings of the Lord. They lusted for that which they had left behind. The Lord heard that which was in their hearts and He was provoked to anger.

Anger is an emotion common to all men. That said, different individuals express anger in different manners. New Testament believers, having the mind of Christ (I Cor. 2:16), are empowered by the Holy Spirit to respond in a manner like unto that of the Lord. The Lord did not lash out at them who provoked Him. He, figuratively, turned His cheek by supplying the flesh which they demanded. In so doing, the Lord warned them that they would have more flesh to eat than they wanted and that they would find it loathsome.

Moses reacted to Israel’s complaints by complaining to the Lord (v. 11-15). Moses wanted to know why that the Lord had tasked him with the responsibility of meeting the needs of the people. Moses pleaded, “. . . let me not see my wretchedness.”

The Lord heard Moses’ plea and responded. The Lord instructed Moses to enlist others (elders and officers) to help him. The elders and officers were to come to the tabernacle where the Lord would come down and take of the spirit that was upon Moses and place it upon them. The Lord instructed Moses to deliver His words to the people.

The words which the Lord gave to Moses to speak to the people reveal His anger. Moses was to tell them that the Lord would give them flesh to eat and that they would eat flesh for a full month. They would eat it until it came out of their nostrils and was loathsome to them (v. 20). Moses was to tell them why the Lord was angry. He was to tell them that they had despised the Lord and wept before Him, saying, “Why came we forth out of Egypt?”

Before doing as the Lord instructed him to do, Moses questioned God. Moses knew that the Lord said that He would supply flesh sufficient to feed all of the people for a full thirty days but he questioned how that the Lord might do it. Moses visualized the size of the flocks and herds which would be necessary to feed the six hundred thousand adult male population of Israel for one month and asked the Lord if all the fish of the sea would be sufficient.

The Lord answered with the question: “Is the Lord’s hand waxed short?” The Lord then declared that Moses would see whether or not His word shall come to pass.

Moses questioned the Lord and the Lord answered: Wait and see. The Lord would do as He said. The manner in which He would do it, however, was not by slaughtering the flocks and herds or by gathering the fish of the sea. Moses would have to wait and see. In the meantime, Moses was to tell Israel to prepare themselves for that which was to come.

New Testament believers wait for our Lord and Savior to return. We do not understand how that “the dead shall be raised incorruptible, and we will be changed” (I Cor. 15:52), but we, like Moses, are to tell all people to prepare for that day.

Let us do as the Lord has said.

On June 30, 2021, West Virginia-American Water Company (WVAWC) filed an application for approval of a Distribution System Improvement Plan and Charge (Application) pursuant to the direction of the Public Service Commission of West Virginia (Commission) in its February 24, 2016 Order that resolved WVAWC's 2015 rate application, Case Nos. 15-0675-S-42T and 15-0676-W-42T.

WVAWC proposes to invest approximately \$32.5 million for infrastructure replacement and system upgrades beginning March 2022 through December, 2022 throughout WVAWC's service area and to implement a Distribution System Improvement Charge (DSIC) to recover the capital costs on the proposed investments. This DSIC application primarily would cover the replacement of transmission and distribution mains, valves, hydrants, tanks, meters, booster stations and service lines. The projects proposed for 2022 are identified in the Application, which is on file and available for public inspection at the Commission's offices at 201 Brooks Street, Charleston, West Virginia, and may be viewed on the Commission website, www.psc.state.wv.us.

As with the DSIC currently in place, WVAWC proposes to recover costs associated with these investments through a separate rate component on customer bills, calculated as a percentage of the total monthly bill for service (comprised of both the minimum meter charge and the volumetric rate component).

WVAWC projects that if the program and revenue requirement are approved as requested, the 2022 DSIC will recover \$3.5 million or 2.32% over and above bills at current base rates. Compared to the 2021 DSIC rate, the average monthly bill for its various classes of customers, will change as follows:

The increases shown above are based on averages of all customers in the indicated class. Each class may receive an increase greater or less than stated here. Individual customers may receive increases that are greater or less than average. The requested rates and charges are only a proposal and are subject to changes (increases or decreases) by the Public Service Commission in its review of the filing. In addition, WVAWC has proposed new base rates in its pending base rate proceeding, Case No. 21-0369-W-42T which have been suspended until February 25, 2022. The percentage change in average monthly bills noticed herein may be higher or lower depending on the result of the Commission decision in Case No. 21-0369-W-42T. The new DSIC rate increment will become effective either on March 1, 2022 or, if ordered by the Commission, coincidental with the effective date of rates in Case No. 21-0369-W-42T, which date is currently February 25, 2022.

The Commission set a procedural schedule, including a hearing date, on the Application. The hearing will begin at 9:30 a.m. on November 12, 2021.

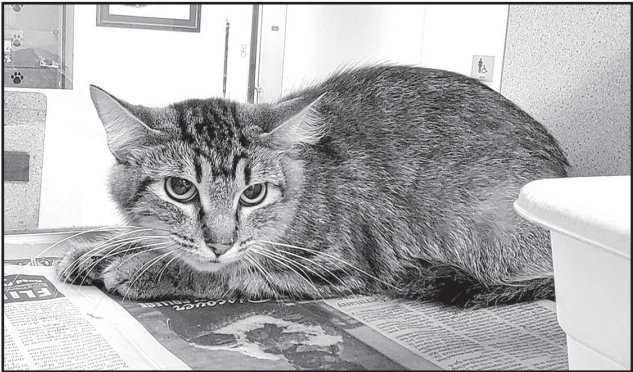
