## How the Putnam County Homecoming Came into Being

There are few alive today, perhaps none, who attended the first Putnam County Homecoming in the summer of 1929. One individual who was in attendance on that occasion was John Lyle Burnside. Mr. Burnside, now deceased, shared his memories of the event with the Breeze just prior to the 2001 Putnam Homecoming.

As an eight-year-old, Burnside was, not only a witness to the happenings of that day, but, a close up spectator to the preparations of the three prominent Winfield citizens who founded the Putnam County Homecoming. One of the three was Burnside's father, John (Peggy) Burnside. The other two were John Miller and Charlie Howell. Peggy, as he was known to his friends (he had many) was a riverman who doubled as Winfield's mayor. John Miller owned and operated the Putnam Democrat newspaper, while Charlie Howell was the president of the Bank of Winfield (which later fell prey to the Great Depression).

Burnside recalled that the idea for the homecoming stemmed from conversations which centered upon the many friends and acquaintances who had moved away. The three thought it would be great to have a community together. As an incentive to attend they decided to finance a community ox roast with their own money. The three collected the names and addresses of all that

had moved and mailed out penny post card invitations in early 1929.

The date selected was in the middle of the summer. The weather was hot but the turnout was huge. The consensus of those attending was "Let's do it again!"

It was decided to move the event to the second Sunday in September and have each family provide their own picnic lunch.

"I really liked the food," Burnside stated, "It was in short supply during the Depression, but it seemed like there was a lot of sharing at the Homecoming."

In the early years of the homecoming the roads to and through Winfield were all gravel. Burnside remembered there being lots of Model T's and not very good roads. There was no U.S. 35 (now State Route 817) or State Route 34 and there was no bridge across the Kanawha. The route of travel from Hurricane to Winfield was Teays Valley Road to the Kanawha River at Scary and then along the river to Winfield. Most motorists on the northside of the Kanawha parked their automobiles at the ferry site in Red House and crossed the river as passengers on the ferry. Homecoming was a busy day for ferry operator Steve Leach. After 1934, some northside motorists drove to Nitro and crossed the, then, only bridge between Pt. Pleasant and Charleston.

Peggy Burnside's employment required him to move his family to Marmet in 1932.

## Putnam's Covid Numbers Hit Record High

On Monday, September 5, the West Virginia Department of Health and Human Resources reported 792 active cases of the coronavirus in Putnam County, the most since December 19, 2020.

During the 7-day period from August 30 through September 5,

there was a record 374 new cases. The previous 7-day record of 317 new cases was set in the last week of November 2020.

Putnam's record new case total would have been much higher than 374 without the vaccine. The vaccines' effectiveness, while less against the Delta variant than other strains of Covid, does reduce infection rates.

Statewide, 80% of Covid hospitalizations are not vaccinated.

Putnam's vaccination rate is higher than the state average. 54% of the county's residents are partially vaccinated and 46.7% are fully vaccinated.

The vaccine is not recommended for children under 12. The DHHR reported Tuesday that

4,607 Putnam adolescents between age 12 and 18 were partially vaccinated. Children under 12 are without protection. That lack of protection was particularly evident last week as students at George Washington Elementary are now under quarantine and on remote learning until at least Monday, September 13.

for veterans.

The quilts came from all over the state, and nine were presented to veterans.

"When the quilts are presented to veterans, we wrap the quilt around them so that when they are having a bad day, they will know that

someone loves them and appreciates what they did," said Jody Postalwait, West Virginia Chapter of the Quilts of Valor.

The Quilts of Valor display was originally intended to be held on Saturday, but inclement weather conditions

prevented it.

After Sunday's display at the state capital, the quilts will be going to the Amish Country of Ohio for the Ohio Amish Country Quilt Festival in Mt. Hope from September 9 through 11. The quilts will then return to West

## September is National Voter Registration Month

Since 2002, the National Association of Secretaries of State (NASS) has recognized September as National Voter Registration Month to encourage eligible Americans to register to vote or to update their voter registration information. The WV Secretary of State's Office is proud to join NASS in this annual effort.

WV Secretary of State Mac Warner will use the entire month of September to work with County Clerks and high schools to encourage eligible West Virginians to register to vote. Warner is scheduled to visit more than 25 of the state's 55 counties this month to also encourage those already registered to be sure that their voter registration is accurate.

"Voting is a right guaranteed to every eligible citizen. But you have to be registered first," said WV Secretary of State Mac Warner. "In West Virginia, we're making it easy, safe and secure to register online and in-person."

According to Warner, over the last four years by working closely with the state's County Clerks, more than 255,880 eligible West Virginians

have been registered to vote. That number includes nearly 67,000 high school students.

"Those are incredible numbers given the small size of our state. Our efforts to make it easy to register and easy to vote in West Virginia have been recognized throughout the nation," Warner said.

Today, eligible voters can register online anytime by going to the WV Secretary of State's safe and secure website at [www.GoVoteWV.com](http://www.GoVoteWV.com). Warner said that eligible voters can also register to vote in person by going to their local County Clerk's office.

"Or, you can call your County Clerk to request that a paper Voter Registration Form be mailed to you. You can also find a County Clerk's Directory at [www.GoVoteWV.com](http://www.GoVoteWV.com)," Warner said.

National Voter Registration Day is Tuesday, September 28. Warner said that he challenged all 55 County Clerks to host a voter registration drive outside of their courthouse that day to bring awareness to National Voter Registration Month.

## Adolescents Are at Increased Risk of Gambling Disorder

The Problem Gambling Help Network of West Virginia, the group that operates the 1800GAMBLER helpline, has announced grant awards to several prevention groups. The Regional Family Resource Network (FRN) of Hurricane received one of these grants. They will use the grant money to teach middle and high school youth about the risks of problem gambling.

According to the National Council on Problem Gambling, youth are more than twice as likely as adults to develop a gambling problem. Studies show that by high school, most kids have gambled for money. In a recent survey done by West Virginia youth gambling prevention groups, about half the youth indicated they had gambled, with nearly one in five saying they have bet on sports. Youth who gamble are at risk for many other problems, including addiction and depression. Young people often make bets among themselves or within apps or video games.

Many have access to their parent's credit card

or mobile account and gamble online without their parents having a full understanding of the activities taking place.

Jennifer Davis-Walton, Director of the Problem Gambling Help Network of West Virginia, says gambling addiction affects many people in West Virginia, and youth are not immune. She explained that convergence in gaming and gambling has increased the concern about youth gambling. She said, "Young people spend a lot of time playing games online, and many of these games have gambling elements, such as loot boxes. At the same time, they see constant advertisements for mobile gambling, and many of those apps look like the games they play."

1800GAMBLER offers a 24-hour helpline and online chat. Callers are offered several treatment options, including free private therapy, telehealth, support groups, and self-help material.

Despite his absence from Winfield, he remained involved in every Putnam Homecoming. "Dad would take vacation and spend the entire week prior to homecoming in Winfield getting everything ready," Burnside stated. "He would stay with his sister Betty who was a lifelong resident of Winfield. During that week, he would be busy building bandstands for speakers and performers. Entertainment has always been part of the Homecoming."

Burnside could not remember a Homecoming without a parade or the selection of Miss Putnam County. The first parade would have featured horse drawn wagons which earlier in the day transported local families to the event.

his Dad did not encourage the participation of politicians in the Homecoming but politicians have long been a part of it.

Burnside attended every Putnam Homecoming up until World War II when he served in the Marine Corps. Gasoline rationing and dedication to the war effort caused the homecoming to be discontinued during the war. The Putnam County Homecoming is 92 years old, but there have only been 88 or 89 homecomings.

Peggy Burnside was part of Putnam Homecoming until the time of his death in the early 1960's. John Lyle Burnside passed in 2008. The Putnam County Homecoming, carried by the momentum of penny postcards and an ox roast, continues onward.

Both Harvey and Gertrude died in early adulthood.

Lyman and Nora moved to the Hurricane area in the late 1920's where all their children attended school and grew up. They farmed for a while and Mr. Smith did various jobs, while Mrs. Smith stayed at home raising the family. When Union Carbide Corporation began operations in the Kanawha Valley in the 1930's, Mr. Smith was employed there, where he worked until his retirement.

Mr. and Mrs. Lyman Smith moved to 2930 Putnam Avenue, Hurricane, where they resided for many years. Later they moved to Hurricane Avenue where they lived the remainder of their lives. During the Depression Years, Mr. and Mrs. Smith, like most families of that era, worked hard but enjoyed the work providing for their family. They raised big gardens and preserved, pickled and canned every kind of food available. They made barrels of kraut and other pickled vegetables. They also were experts in preserving unusual foods, such as barrels of sulphured apples, a procedure which their neighbors learned from them and sometimes followed. Dale and Barbara Smith are parents of three sons-Rickey, Kevin and

Matthew. Their son, Rickey, has two children - twins, Brian and Brandon.


James and Shirley Smith have five children - Jerry, Kathy, Jeffrey, Robin and Jamie. Their son, Jerry, has two children - Crystal and Travis. Another son, Jeffrey, is father of two - Joshua and Kelly. Their daughter, Mrs. Robin Rymer, has three daughters - Mamie, Sarah and Mary.

Lyman E. and Nora Coe Smith spent the greater part of their lives in the Hurricane area, where they made many friends and contributed greatly to their community. They are survived by four sons, one daughter, eight grandchildren and nine great-grandchildren.



#### Skewers:

- Nonstick cooking spray
- 2 chicken breasts (6 ounces each), cubed
- 1 ham steak (6 ounces), cubed
- 6 bamboo skewers (8 inches)
- 1 tablespoon Dijon mustard
- 1 teaspoon pure maple syrup
- 1/4 teaspoon ground black pepper
- 1/4 teaspoon paprika
- 1 teaspoon extra-virgin olive oil

#### Sauce:

- 2 tablespoons butter
- 2 tablespoons flour
- 1 cup lactose-free 2% milk
- 1 teaspoon Dijon mustard
- 1 cup shredded Swiss cheese
- salt, to taste (optional)
- pepper, to taste (optional)

To make skewers: Preheat broiler to 500 F. Line broiler pan with foil and spray with nonstick cooking spray.

Thread cubed chicken pieces and cubed ham pieces onto skewers.

In small bowl, combine Dijon mustard, maple syrup, black pepper, paprika and oil.

Brush mustard mixture on skewers.

Broil about 5 minutes, flip and cook 5 minutes, or until chicken is cooked through.

To make sauce: In small saucepan over medium heat, melt butter. Whisk in flour and cook 1 minute, whisking constantly. Gradually add milk, whisking constantly. Add Dijon mustard. Continue cooking 5 minutes, or until thick. Reduce heat to low and stir in cheese, whisking until melted.

Add salt and pepper, to taste, if desired.

Serve chicken and ham kebabs with sauce.

Sept. 9, 1839: Anderson "Devil Anse" Hatfield was born in Mingo County. He was the patriarch of the Hatfield family and their leader during the Hatfield-McCoy feud.

Sept. 10, 1782: Frontier heroine Betty Zane is credited with saving Fort Henry in Wheeling during an attack by the British and Indians. According to one account, Zane sprinted across a field to retrieve gunpowder from the Zane family cabin.

Sept. 10, 1861: The Battle of Carnifex Ferry took place on the Gauley River. Union General William Rosecrans sent in brigades one at a time as they arrived at the battlefield, allowing the outnumbered Confederates to repulse the piecemeal attacks.

During the night, the Confederates decided to retreat before they could be defeated in the morning.

Sept. 10, 1996: Movie and television actress Joanne Dru died in Los Angeles. Dru was born Joan Letitia Lacock in Logan, West Virginia. Her movie career included more than 40 films.

Sept. 11, 1913: Ritter Park in Huntington opened. During the Great Depression, the Works Progress Administration contributed to constructing the roads and stonework around the park.

Sept. 12, 1861: The Battle of Cheat Mountain was fought near the

Randolph-Pocahontas County line. Gen. Robert E. Lee came into western Virginia to give support to Gen. William W. Loring, commander of the Army of Northwestern Virginia, but the battle ended in a defeat for the Confederacy.

Sept. 12, 1872: The Great Bend Tunnel was completed. The tunnel, also known as Big Bend Tunnel, is the place where John Henry defeated the steam drill, becoming one of the world's great folk heroes.

Sept. 12, 1952: A group of local youths were startled from a game of football by a fireball streaking across the sky. The fireball fell to earth just beyond a hillside at Flatwoods. This sighting led to the legend of the Braxton County Monster.

Sept. 12, 1974: Kanawha County schools were closed for four days because of an escalation

in violence during the Kanawha County Textbook Controversy. Throughout October and November, sporadic violence continued as protesters demanded the resignation of pro-textbook board members and the superintendent of schools.

Sept. 13, 1844: Milton Humphreys was born in Greenbrier County. During the Civil War, he enlisted in the Confederate service as a sergeant. At the battle of Fayetteville, Humphreys fired his cannon at Union artillery from behind an intervening forest. This demonstration set a precedent for modern warfare by the use of indirect fire.

Sept. 13, 1848: Attorney "J. R." Clifford was born in present Grant County. In 1887, Clifford became the first African-American admitted to practice law before the West Virginia

Supreme Court of Appeals. He was one of the first lawyers in the nation to challenge segregated schools.

Sept. 13, 1862: Confederate and Union forces clashed in Charleston. Southern artillery gained the high

ground on Fort Hill and smashed the federals who were lining the west bank of the Elk River.

Sept. 13, 1910: Musician Leon "Chu" Berry was born in Wheeling. He was one of the most highly regarded saxophonists of the Swing Era.

## BASIC BIBLE

### Death of Nadab and Abihu

Leviticus 10:1-7

The text before us was written for new Testament believers. "All scripture is given by inspiration of God, and is profitable for doctrine, for reproof, for correction, for instruction in righteousness" — II Tim. 3:16.

The deaths of Nadab and Abihu served as a stern warning to Aaron and his sons concerning their priestly service. The account of their deaths also serves notice to New Testament believers of the manner in which our spiritual sacrifices are to be offered up to the Lord.

Let us focus upon that which is certain. We know that Nadab and Abihu did not do as the Lord commanded — they offered strange fire before the Lord (v. 1). We know that their actions cost them their lives.

In verse 3, Moses stated why fire went out from the Lord and devoured them. Moses said, "This is it that the Lord spake, saying, I will be sanctified in them that come nigh me, and before all the people I will be glorified."

The Lord knows the innermost thoughts of men. God knew that Nadab and Abihu did not come before Him with thoughts of sanctifying Him. Nadab and Abihu did not think to glorify God before all the people. Nadab and Abihu defiled the sanctuary. Their offering of strange fire was an act of disobedience; their act was an expression of their hearts.

When Moses stated the reason that Nadab and Abihu perished, Aaron held his peace. Silence is deafening. Aaron knew Nadab and Abihu were guilty as charged.

In verse 4, Moses commanded the sons of Aaron's uncle to remove the bodies of Nadab and Abihu from the sanctuary. Touching the dead caused one to become defiled, to lose sanctity. Aaron and his sons were not to defile themselves in any manner. They were made outwardly holy by God. They were washed by Moses (one empowered by God). They were dressed in garments designed and manufactured by God's instruction, and were anointed with holy anointing oil. They were to remain outwardly holy. That which was outward was to be testify of that which inwardly existed.

New Testament believers have been given spiritual understanding. We know that one is filed by that which comes from the heart, not by that which touches the flesh (see Matt. 15:11).

All Israel saw the dead bodies of Nadab and Abihu removed from the tabernacle and carried out of the camp by Mishael and Elaphan. Their action was an exception to the law which states that none shall be defiled for the dead except mother, father, son, brother or virgin sister (Lev. 21:1-3). The exception was ordered by Moses (God's representative) such that Aaron and his sons perform their priestly duties without interruption. Service to the Lord is first. All else is secondary.

The Lord Jesus made known to would be followers that their discipleship would be above all else when He replied to one who sought first to bury his father, saying, "Let the dead bury their dead: but go thou and preach the kingdom of God" (Lk. 9:60).

The instruction which Moses issued to Aaron and his sons Eleazar and Ithamar in verses 6 and 7 was from the Lord. Aaron and Eleazar and Ithamar would die and God's wrath would come upon all the people if Aaron and his sons were to mourn for Nadab and Abihu. They would die because the anointing oil of the Lord was upon them. The anointing oil, like the garments which they wore, was an outward expression of that which was to exist inwardly. The scent of the oil was linked to their priestly service within the tabernacle.

New Testament believers are anointed, not with oil, but, with the Holy Spirit such that we may be empowered to do the Father's will. We are ever close to God because we are the temple of God and the Spirit of God dwells in us (I Cor. 3:16).

The constraint that the Lord will be sanctified in them that come near Him applies to New Testament believers. We experience a closeness to the Lord God that Israel never experienced. We come spiritually close to God through Christ. We are brought close to God the Father, not by that which we do, but, by that which the Lord Jesus has done. We come near to God in our priestly service when the righteousness of the Son is seen in us. One comes close to God when one loves others as Christ loves us.

Believers draw close to God when we do that which the Son commands. We draw close when we go and teach all nations and baptize them in the name of the Father, the Son, and the Holy Spirit (Matt. 28:21).

It is our priestly duty to do as He commands. Let us ever place Him before all else.


