

# World Championship

Lenon Hodge, a 10 year old student at Hurricane Elementary School, has qualified for the 2021 NASP World Archery Championship. Hodge qualified for the Championship World by finishing in the top 100 in the United States in the NASP National Tournament.

National The Tournament was held virtually this Spring. Hodge took second place in the state of West Virginia in the National Tournament and he took 54th place in the United States among the elementary division. A record 15,683 archers 1,053 schoolscompeted in the 2021 Nationals.

Hodge began shooting a bow in the 2019-2020 school year by participating in the National Archery in Schools Program (NASP). In early 2020, he won the West Virginia State Tournament by taking 1st place among all

elementary students. Hodge and his team brought the very first championship archery trophy to his school. February 2020, Hodge took 1st place in the Cabell Midland Invitational. Archery Additionally, he took 1st place in the West Virginia State University Archery Invitational and 3rd place in the Elkview Middle School Archery Tournament held at Marshall University in 2020. Hodge has two finishes.

# Forty Years Ago

Oat Bias Kept Law and Order During **Depression**

Editor's Note — This article, first printed in the May 28, 1981 issue of the Breeze, captures a picture of law enforcement during the Great Depression.

Law and order was not so big a problem during the Great Depression era of the 1930's. Possibly most folks had enough to do just to keep body and soul together and in trying to find something to put on the table for the next meal to get out and do a lot of law-

Policemen were more respected then than they are now, also. I do not remember ever hearing our policemen being called a "pig," nor did I ever hear of "police brutality." Another thing we didn't hear much about was "rights. Everyone had "rights" so long as they obeyed the law; and when they broke the law, they were put in

Of course, during the Depression there were murders both in Hurricane and throughout the country; but these crimes of violence could usually be attributed to domestic problems

personal fights between individuals. I do not remember any crimes during the Depression whereby anyone killed someone for the fun of it or for the purpose of robbery. There could have been people who were robbed and killed; but I cannot recall an instance such as that.

Some of the local stores

were burglarized; but the robbers were caught and sent to jail. In fact, the most outstanding robbery I can remember was when a grocery store was robbed on Putnam Avenue. The robbers were from Huntington. Petty stealing was a problem, but not a very big one. I cannot remember a case which was burglarized, or any armed robbery of any kind in Hurricane the 1930's. during Chicken stealing was big. Just about everyone who had chickens would eventually go to the hen house some morning and find that they had no chickens to feed. Those chicken thieves very skillful, being able to pluck a fat hen off the roost without evoking a cluck, a cackle or a cockledoodle-doo. My brother told me about some very well-known boys from respectable families in town who would rob the hen houses of local chicken growers and then sell the chickens to Mr. Lem Burdette, who had a store and who also would from time to time buy back unknowingly some of his very own chickens. My brother DID NOT steal chickens; but if I told you the names of the ones who did, you would be shocked. No, I will not tell you, because some of

Oat died in the 1960's and was well over ninety vears of age. If he ever had an automobile, I never saw it. Neither did he have a scanner, radio equipment or a walkietalkie. He always lived It was a good town, then. in the center of town and was on duty seven days a week and twenty-four hours a day. I do not remember that he had a vacation or even that he was off sick. He welked all over town on his patrol, but mostly, of course, his beat was on Main Street, where there were usually located three beer parlors. Her had a way of dealing with drunks and those beer parlor would habitues who every often decide to test their strength against another beer drinker. There were lots of fights, lots of arguments and sometimes the little jail behind the present City Hall would have overnight guess. Most usually, would separate the fighters, settle them down real good and start them for home. Many a Saturday afternoon we would see Oat supporting a drunk or drunks and walking them up Putnam Avenue toward Hurricane Creek Road (or just near the city limits sign) and telling them in his authoritative voice, "All right, you Laddy Bucks, if I catch you back in town, you are going to jail." I do not believe he would have had any patience with the drug scene, the juvenile delinquency, the speeding and the general society today. Hurricane was a little town with small ideas: everyone knew everyone for miles around; and actually there was not so much crime and law-breaking.

My mother had a little Boston bulldog named Corky during the 1930's. Corky was a house dog; and Mom was just crazy about him as we all were. Well, Corky was prone to act like any other dog, enthusiastically entering into local dog fights and dog romances at each and every opportunity which presented itself. Whenever Corky would get out of the house and run away from home to engage in dog activities, Mom would just go into a tizzy. She was afraid Corky would get killed. Oat Bias knew how much Mom liked corky; and during spring and fall seasons he would faithfully watch out for Corky. Lots of men who were too proud to take charity (which is what they called relief) fed and clothed their families by making moonshine; and many others supported their families by bootlegging the finished product. I knew a lot of moonshiners and also some of the bootleggers. I liked them all; they were just like other people; and they had a strict code of honor and honesty that was not found in some of the people who condemned them. I never could see why it was wrong for an individual to make and sell good whiskey to support his family and why it was right for a state to sell it. It seems that it was not really a moral or legal issue, but was rather just another way for the state to collect taxes. Well, I never did use the booze in any form; but I never could see where the payment of taxes could whitewash something that was supposed to be wrong. I still can't.





# **Ministry to Unbelievers**

Romans 15:15-27

In the text before us, Paul comments upon the things which he has written in this epistle. In verse 15, the apostle states that he has written boldly. Paul's words suggest that he may have written more boldly in this epistle than the manner in which he wrote in his previous epistles.

Romans reads differently than Paul's epistles to believers at Corinth or Galatia or Ephesus and elsewhere. In Romans, Paul cites passages from the books of Moses, the Psalms, and from the prophets more than fifty times, twice the total of all passages cited in his other epistles combined. In verse 14, the apostle makes it clear that his boldness was not triggered by any lack of goodness or knowledge on the part of the Romans. Paul's reason for boldness is not to correct. His boldness stems from the grace which God has given him. His boldness is linked to his having been chosen by God to deliver the gospel to the Gentiles.

Paul states that his boldness is because of the grace which God has given to him. God revealed to Paul that he was chosen to be the minister of Jesus Christ to bring good news (the gospel of God) to the Gentiles such that "the offering up of the Gentiles might be acceptable, being sanctified by the Holy Ghost" (v. 16).

The offering up of the Gentiles is the offering up of spiritual sacrifices to God by the Gentiles which sacrifices are holy and acceptable (see I Pet. 2:5, Rom. 12:2). Neither Jew nor Gentile possesses the capacity to manufacture anything that is holy and acceptable. No man, Paul included, possesses this ability. Paul's role was to deliver the gospel to the Gentiles such that they might hear, believe and receive. Upon believing, one receives the Comforter (the Holy Spirit) who acts as an intercessor of prayers. The Holy Spirit helps believers overcome our failings by interpreting our innermost feelings (Rom. 8:26). God the Father sees only that which the Holy Spirit has filtered — that which is holy and acceptable.

Awareness of God's grace was given to Paul by revelation from God such that His purposes might be realized. It is and was by revelation that Paul was given the understanding necessary to expound upon that which is recorded in the books of Moses and the Psalms and upon the words of the prophets. Moses, the Psalms, and the prophets, all proclaim the coming of a time in which God shall establish a new relationship with a people who are not a people. The Gentiles are that people.

In verses 17, Paul states that he has cause to glory through Jesus Christ in "those things which pertain to God." Those things which pertain to God most certainly include the fulfillment of that which Moses and the prophets spoke. Paul was the chosen vessel to be the apostle to the Gentiles. Paul does not glory in that which he has done. He glories in that which Christ has done by him (v. 18). Paul is glorying in the work of God the Son.

Paul states that his ministry was powered by "mighty signs and wonders, by the power of the Spirit of God" (v. 19). Paul's boldness in writing that which he wrote is, likewise, powered by the Holy Spirit. It is not by coincidence that Paul links his boldness in writing to his preaching of the gospel in places where it had never before been preached (v. 20-21). Paul's epistle and the grace which he received

work together for God's purposes. In verse 23, Paul states that he has no more place in these parts. These parts consist of the region extending from Jerusalem to Illyricum (see v. 19). Paul's presence is no longer needed there because the people who were no people from Jerusalem to Illyricum

had heard and received understanding (see v. 21). Paul states his great longstanding desire to visit them (v. 23) and to be "brought on my way thitherward by you" (v. 24). Thitherward is Spain, Paul's destination after visiting Rome. Paul was moved by the Holy Spirit to ask believers in Rome assist in bringing the

gospel to Spain. Paul states that he must first go to Jerusalem to deliver a donation which will be used to meet the material needs of the saints there (v. 25-27). The Gentile believers in Macedonia and Achaia were moved to send a monetary gift which was designated to meeting a material need. Paul states that believers, once empowered by the Holy Spirit

to offer up acceptable spiritual gifts, are also obligated to provide for the material needs of other believers. The epistle to the Romans is for believers in every place and of every era. All believers are to assist in bringing the gospel to people who are no people such that they, too, may offer up that which is

holy and acceptable. It is our reasonable service (Rom. 12:1).



May 28, 1998: The Robert C. Byrd United States Courthouse in downtown Charleston was dedicated. The 440,000-square-foot building incorporated Neoclassic, Egyptian, and Art Deco designs.

May 29, 1778: Dick Pointer, a slave, helped save about 60 settlers who were attacked by Indians at Fort Donnally near Lewisburg.

May 29, 1961: Elderson
