## County Commission Spring on Main Brings Festive Atmosphere to Hurricane

### Enters into \$700,000 Design Agreement

The Putnam County Commission met on Thursday, April 29, to consider six agenda items of note. The biggest dollar item by far was a \$700,000 agreement for the design of a 5-G Fiberoptic Broadband Network.

The commission entered into an agreement with S&S Engineers to design the system. The agreement awards \$700,000 (based upon a project total of \$10 million) to S&S for seven phases — \$15,000 for Study and Report, \$235,000 for Preliminary Design Phase, \$200,000 for Final Design Phase, \$25,000 for Negotiating Phase, \$100,000 for Construction Phase, \$25,000 for Post Construction Phase, and \$100,000 for Additional Services. When complete, 5-G Broadband service will be widely available in the county.

The commission also approved a bid of \$146,940 by Benchmark Construction of Hurricane to make an emergency repairs to a failing culvert near Lake Chadesa. Wiseman Construction of Charleston submitted a lower bid (\$146,046) but the commission opted to go with Benchmark because it is a Putnam County business. The commission was not obligated to go with the lowest bid because an emergency condition exists. The commission did not consider an email submitted by Benchmark after the bidding deadline of a revised lower cost

estimate. Commissioner Foster recused himself from the proceedings because of business dealings with one of the companies that submitted bids.

In an item held over from its April 20th meeting, the commission voted to purchase the property located at 6321 Poca River Road South with grant money provided through the Hazard Mitigation Grant Program. Adjacent property in the area had been purchased with FEMA funds. Future use of the land is restricted to recreational use. Commissioners Andy Skidmore and Brian Ellis went on record stating that they would not support future purchases of such property. The total acreage of all Poca River Road South purchases is approximately seven acres.

The commission did not act upon a request by Timothy Spradling to have his property at 1006 and 1012 Mt. Vernon Road, Hurricane, rezoned from R-1 to C-1. Spradling withdrew his request after commission attorney Larry Frye informed the commission that he had discovered errors in the property description which could serve as a basis to challenge any decision. Frye stated that recording errors were, in part, the fault of the county. The commission voted to waive Spradling's filing fee to resubmit his request.

K9 demonstration with Corporal Adam Robinette and police dog Reaper. Robinette put Reaper through his paces, showing off the strict obedience training which police dogs undergo. Patrolman Justin Rakes acted as a criminal,

pretending to threaten Robinette so that the audience could see how a police dog can take down an aggressor. Reaper, a three-year-old Belgian Malinois, can track objects or missing people, seek out narcotics, and protect his assigned

officer. Children could have their photos taken in a police car, explore a fire truck, tour the inside of an ambulance, and visit the fire safety trailer. Emergency workers taught children what to

The Putnam County Farmer's Market opened its 2021 season at Valley Park in Hurricane on Saturday, May 1, at 9 a.m.

The market allows area farmers to offer homegrown produce, eggs, meat, baked goods, and preserves to the public. The market also offers local artists and craftsmen the opportunity to sell their unique creations.

Vendors included Market Manager

Elizabeth Mosteller stated that 17 vendors were on hand for the first market and that the number will grow as the season progresses. Vendors were from Putnam, Cabell, Lincoln, Mason and Kanawha counties.

Fresh produce offerings were made possible by early plantings in greenhouses and high tunnels. Saturday's produce included collards, romaine, broccoli, green onions, kale, and carrots.

FRANCIS (FRANK) WILLIAM PIERCE Submitted by Kathryn Simms Foster

Francis (Frank) William Pierce (1863-

1940) was the son of Royal and Margaret Pierce. Royal Pierce was the son of Franklin Pierce, who was born in Wales, England and later lived in Pomeroy, Ohio.

Francis Pierce had a brother, Jim, who lived in Ohio and a sister, Ellen Rupe, who had three daughters: Lillie, Lula Sumner and Mary Walk. He married Margaret Viola Phelps (1866-1954) in 1882. Margaret was the daughter of Samuel and Margaret Phelps. Samuel and his wife, Margaret had seven children: John,

The Spring 2021 issue of GOLDENSEAL magazine is now available. Since 1975, GOLDENSEAL has been West Virginia's Magazine of Traditional Life. Attached is a list of retailers where GOLDENSEAL magazine is available.

This issue's cover story examines Black gospel and blues music. Doris A. Fields, better known as Lady D, one of our state's most gifted singers, traces the history of this poignant music from the slave plantations of the Deep South to the West Virginia coalfields. She discusses how gospel and blues formed the foundation of modern popular music and how they have changed in some ways while remaining true to their roots.

This edition covers a wide range of other historical and cultural topics from across our state. State Folklorist Emily Hilliard writes about singer and storyteller extraordinaire W.I. "Bill" Hairston of Charleston. Edwin Daryl Michael looks at the evolution of rural photography through the lens of his Marion County family in the early 20th century.

Lawrence "Larry" Cabell remembers the perilous task of digging coal from a community mine when he was a kid in Boone County in the 1930s. The late Bob Barnett, in his final article for GOLDENSEAL (dating back to 1983), tells of Parkersburg's Greasy Neale, one of our state's greatest athletes and coaches. Aaron Parsons writes about television news pioneer Bill Kelley. Miriam Ralston reflects on founding MAW, the first magazine solely about Appalachian women, in Huntington in the 1970s. Ben Calwell relates the story of a mass comic-book burning at Spencer Grade

School (Roane County) in 1948. Nancy S. Hoffman pays a visit to the family owned Ruggles Orchard in Hampshire County. Jeffrey Shade shares how undercover state troopers brought down the longtime red-light district at Cinder Bottom (McDowell County) in the late 1960s.

Two articles are dedicated to WAVES (Women Accepted for Voluntary Service) who served our country during World War II. Barb Howe writes about Greenbrier County native and former Tucker County resident Jessie Luckie and Isabel Lobb Jones, who recently passed away in Morgantown at age 101. Sara Bragg Aikin recalls the life of Ansted (Fayette County) native Ernestine Hess Davey, who died a few months ago at 99.

In his regular "Back Roads West Virginia" column, Carl E. Feather drops by the Lenox Store, Preston County's oldest continuously operated business. Michael Evans Snyder salutes the late Lincoln County native Gen. Chuck Yeager, the first person to break the sound barrier. Author Kathleen M. Jacobs and Ellen Lambert offer some personal recollections from their lives, and Audrey Pitonak-Goff writes about the Appalachian Children's Chorus, which just celebrated its 30th anniversary.



Jim, Len, Riley, Margaret Viola, Bertha and Mary.

Samuel's parents came from Holland. They were granted land in Pennsylvania; however, they were not happy there and traveled down the Ohio River on a raft to West Virginia where they homesteaded one thousand acres of land on Buff Creek. While Samuel was away in the Civil War, Margaret used her government allowance to purchase another farm. When Samuel came home from the War, he was pleasantly surprised and was able to present each of his children one hundred acres of land when he/she married.

Francis William and Margaret Viola Pierce were married fifty-eight years. They had twelve children: Hurmy (1882-1949); Sady McCallister (1885-1903); Arilla (1887-1903); Denver (1889-1942); Grace L. Burdette (1891-1979); Maude Thompson (1894-1986); Hobart (1897-1980); Addie (1900-lived four months); Allie Mooney

(1900-1978); Verba Simms (1903-1976); Delpha McCallister (1907-1955). These twelve children had twenty-eight grandchildren.

When Francis William married Margaret Viola Pierce, her parents gave Frances one hundred acres of land. He built a small house which was soon outgrown and then a larger house which still stands on the farm on Buff Creek.

Frances William gave up farming after a while and traveled the six miles in to Hurricane to work as a clerk in a general store. In 1906 he built an even larger house on Second Street in Hurricane and moved his growing family from Buff Creek. At the same time, he built a store building which was two stories high. The second floor served as a meeting room for both the Odd Fellows and K of P Lodge. He was also a member of the Hurricane Baptist Church. He was a charter member of both the Odd Fellows and the Masonic Lodges.

In early years, Francis served a term as Mayor of

expect in the case of a house fire, how to alert authorities, and how to escape from a burning building.

Hurricane, built and sold houses, inspected lumber for the C&O Railroad, and was a prosperous merchant until The Depression forced him out of business. His youngest child graduated from Hurricane High School soon after it was completed in the 1920's.

All of Francis Pierce's children enjoyed prosperous lives. They traveled and lived in such places as St. Louis, Chicago, New York, Cleveland, New Jersey, and the state of Washington. All of his children but one, however, were buried at home in Hurricane.



## Fully Vaccinated Advise

By Ron Allen

On April 27, the CDC published "Interim Public Health Recommendations for Fully Vaccinated People." Here are the key points:

Fully vaccinated people can:

Visit with other fully vaccinated people indoors without wearing masks or physical distancing

Visit with unvaccinated people (including children) from a single household who are at low risk for severe COVID-19 disease indoors without wearing masks or physical distancing

Participate in outdoor activities and recreation without a mask, except in certain crowded settings and venues

Resume domestic travel and refrain from testing before or after travel or self-quarantine after travel

Refrain from testing

before leaving the United States for international travel (unless required by the destination) and refrain from self-quarantine after arriving back in the United States

Refrain from testing following a known exposure, if asymptomatic, with some exceptions for specific settings

Refrain from quarantine following a known exposure if asymptomatic

Refrain from routine screening testing if asymptomatic and feasible

For now, fully vaccinated people should continue to:

Take precautions in indoor public settings like wearing a well-fitted mask

Wear well-fitted masks when visiting indoors with unvaccinated people who are at increased risk for severe COVID-19 disease or who have an unvaccinated household

member who is at increased risk for severe COVID-19 disease

Wear well-fitted masks when visiting indoors with unvaccinated people from multiple households

Avoid indoor large-sized in-person gatherings

Get tested if experiencing COVID-19 symptoms

Follow guidance issued by individual employers

Follow CDC and health department travel requirements and recommendations

did not act upon a request by the WVU extension service to restore funds cut from the 2021-2022 budget. The commission decreased its budget from \$72,000 to \$25,000 for the agricultural agent. Commissioner Foster stated that the extension service should seek more funding from the school board. "The county only receives 20% of tax revenue while the school board gets 80%," Foster said. Foster indicated that he is not opposed to supporting the Putnam County Fair and 4-H programs but he wants regular updates on the services that the extension service is providing.

The commission approved the transfer of EMS service from the county to the City of Hurricane and the Teays Valley Fire Departments for calls in their respective districts. The change is slated to become effective on August 1st.

The next Putnam County Commission meeting is scheduled for Tuesday, May 11th.

## BASIC BIBLE

### Elected by God

Romans 9:6-20

In the opening chapter of Romans, Paul stated that he desired to impart "some spiritual gift" to them such that they (the believers at Rome) might be established. In the text before us, cites passages from Genesis, Exodus and the prophet Malachi such that all believers might be established in knowing God.

When Paul states that they are not all Israel which are of Israel in verse 6, he is speaking of two different groups, spiritual descendents of Abraham and physical descendents of Abraham. Paul and the Jews within the church at Rome were members of both groups. Gentile believers at Rome consisted only of Abraham's spiritual descendents. Before knowing Jesus Christ as Lord and Savior, Paul and the Jews to whom Paul speaks, were physical descendents only. They became spiritual sons of Abraham when they experienced a spiritual birth. What causes some to be second born and others not? Paul answers this in verse 6. The word of God causes some to believe and some to turn away.

Believers, both Jews and Gentiles, read the scriptures with the guidance of the Holy Spirit. Nonbelievers read Genesis 21:12 differently from believers. Both Isaac and Ishmael were sons of Abraham according to the flesh but only in Isaac would Abraham's seed be called.

In verse 8, Paul states that being of the flesh does not make one a child of God. Isaac was both a child of promise and a child of Abraham according to the flesh. While being a child of Abraham according to the flesh does not make one a child of the promised blessing, God counts every child of promise as Abraham's seed. Paul's words are directed at Jews within the church who believed that they possessed a special standing with God because they were sons of Abraham according to the flesh. Paul makes it known that what counts with God is not DNA but BLA (Believing Like Abraham).

Isaac, not Ishmael, was the child that God promised. In verse 9, Paul states God's promise to Abraham. The promised seed of Abraham would be Sarah's son. The promise links the Lord's coming with the miracle birth of Isaac. It is God, not man, who links His coming to a miracle birth. It is through and by the Holy Spirit that believers know that Isaac's birth is a picture of the future virgin birth of Christ.

In verses 10 through 13, Paul reveals that God used the birth of Esau and Jacob to demonstrate that God favors the second born. Rebecca did not conceive of twins by accident of birth. God made it happen. Rebecca sensed that the activity within her womb was not normal and she went to God in prayer. God told her that she would bear twins and that the older would serve the younger. Paul notes that the unborn twins were equal in regard to sin. Neither had done good or evil. Yet God announced that it would be the second born that would have favor with Him. Again, the second born, not the first born, that found favor with God. The second born had favor with God before he was born. It is by His design, not accident of birth, that God would favor the second born over the first born. The Holy Spirit reveals God's way to all who believe.

God preserved Jacob but not Esau. In verse 14, Paul asks if God's unequal treatment of Esau constitutes unrighteousness. God forbid. God answers to no man but God has the answer for all men: "I will have mercy on whom I will have mercy, and I will have compassion on whom I will have compassion." God chose the second born because God, in His foreknowledge, knew the second born before he was born. God chose all who would believe upon His only begotten Son before they believed upon Him. Paul confronts the Jews in the church at Rome with an undeniable truth. God did not choose them because they were physical descendants of Abraham, Isaac and Jacob. God does not grant mercy and compassion because men desire (will) it or because of that which men do (runneth). God's mercy and compassion are not rewards for that which men may do. One is the beneficiary of God's mercy and compassion because God is God and knows who shall believe and who shall not.

God does not hide His ways from men. Far from it. He boldly declares His ways in His scriptures. God openly declared His way to an unbelieving Pharaoh in Exodus 9:16. The Lord God elevated Pharaoh to head the most powerful nation on earth for a specific purpose: "(T) hat my name might be declared throughout all the earth."

God has mercy on whom He will have mercy, and hardens whom He will harden for a purpose. God desires that all men should know Him. He is not willing that any should perish but that all should come to repentance (II Peter 3:9). God reaches out with love to all who shall believe. God made all men to believe but chose to give His love to those who would believe.

He has bestowed His love upon us such that we might declare what He has done. We are called to be agents of His purpose. He has chosen us that others may believe.
