## 'Moonshine Bill' Work by Night . . . Awaits State Senate Approval

On Monday, January 24, the West Virginia House of Delegates on a vote of 74-22 sent House Bill 2972 to the State Senate. If the bill (I call it the Moonshine Bill), is approved by the senate and signed by Gov. Justice, all households with two sober adults of 21 years of age or older will be permitted to manufacture 100 gallons of white lightning per calendar year for home consumption.

Actually, the would-be-law does not state that the participating manufacturers must be sober. I added that because I do not believe that anyone consuming 50 gallons of 'shine in the space of 365 days would know how many gallons that they had produced or consumed. Fifty gallons is 400 pints. That is more than a pint a day without allowing Sunday as a day to rest. Might be wrong, but I don't think someone doing that much consumin' would know one day of the week from another.

The action of our elected and selected delegates did not surprise me. I first caught wind of the Moonshine Bill on Thursday, January 20, Day 9 of the 60-day regular legislative session. The bill was slated for a second reading on Friday and third reading (passage) on Monday. I knew that the bill was on the fast track because its sponsors included Eric Householder (R - Berkeley) and Mike Pushkin (D - Kanawha). Householder is the House Finance Committee Chairman and Pushkin is


vice chairman of the West Virginia State Democratic Executive Committee. With support like that I knew the Moonshine Bill was a done deal before Monday's vote.

Tom Fast (R - Fayette) was the only delegate to speak out against the bill. He thought 50 gallons was too much and offered an amendment limiting annual production to just 15 gallons per 21 year old adult. His amendment was rejected. Fast also sought to add language to the bill such that the homemade liquor could not be offered, transferred or gifted to non-family or non-household members. His suggested addition fell on deaf ears.

I had to wait until Monday's vote to learn whether or not Putnam's delegates thought that an allowance of 100 gallons of white lightning manufacture per household was a good idea or not. Here's their votes: 13th District - Pinson (R) - Nay, Crouse (R) - Yea; 14th District - Wamsley (R) - Yea; 15th District - Foster (R) - Yea; 22nd District - Maynard (R) - Yea, Jeffries (R) - Yea; 38th District - Graves (R) - Nay.

To be fair, voting "yea" or "nay" should not be interpreted as favoring or not favoring a specific amount of homemade liquor production. The intent of the legislation is to eliminate the section of state code which blocks the production of homemade liquor. State law already allows for home production of beer or wine. The Moonshine Bill adds moonshine to that which any household is allowed to produce.

Historically, restriction upon home-

## Kentucky Man Arrested in Hurricane Robbery Attempt

Joseph Mcgranahan, 39, of Ashland, Kentucky, was arrested by Sergeant R Poe and Patrolman J Rakes on Monday, January 24, in an attempted robbery at the

Walgreens in Hurricane. Mcgranahan entered the store just after 9:30 a.m. and proceeded to the pharmacy where he demanded OxyContin Xanax pills.

Mayor Scott Edwards reported that Mcgranahan has been charged with armed robbery because he presented a note threatening to shoot if employees did not comply with his demand. He also picked up a pill counter and used it as a threatening weapon. Mcgranahan was apprehended by the officers as he was exiting the store. Edwards said the first officer arrived 60 to 90 seconds after the

## Covid Update - How Bad Is It?

Putnam's Covid-19 active case number dropped to 736 on Monday after hitting 902 on Sunday, January 23, 2022. The 902 active cases were the highest since December 9, 2020, when 969 active cases were reported by the DHHR.

The Omnicron variant is every bit as infectious

as promised. Total confirmed and probable cases since the onset of the pandemic in Putnam was 14,124 on Tuesday of this week. Of that total, 22.3% or 3,152 were registered since January 1 of this year.

How bad is Omnicron? It is bad but only bad enough to increase to active case number by 250. The 3,152 new cases

since January 1 has only produced a 250 increase in active cases. This low increase means that bouts with Omnicron are shot and the vast majority of its victims are experiencing rapid recoveries.

Sadly, four county residents succumbed to the disease between January 1st and the 24th. Putnam's Covid death total stood at 151 on the 24th.

## This Week in the House of Delegates

For the week ending Jan. 21, 2022

The second week of the regular legislative session has concluded, with members of the House of Delegates continuing to introduce and discuss bills each day.

A mid-week presentation from West Virginia University economist John Deskins helped lawmakers keep the state's big-picture financials front of mind while they look toward their work of finalizing the state's budget for the next fiscal year.

"We always look forward to presentations from Dr. Deskins and utilizing his research and data in what we do here to help make West Virginia the easy choice," said House Speaker Roger Hanshaw, R-Clay. "It was helpful to hear his message of caution to be wise with how we invest the deluge of federal dollars we have coming our way and be sure we're choosing things with long-term impact and payoff."

"We have momentum on our side from the state's biggest jobs announcements in history last week, and as we move through this legislative session, we must continue to look at the best ways we can allocate all our available resources."

The House Finance Committee continues to hear budget presentations from state agencies as it does at the start of most legislative sessions. This week's update from the West Virginia Higher Education Policy Commission was of note to Committee Chairman Eric Householder, R-Berkeley, who said it seemed especially thoughtful.

HEPC Chancellor Sarah Armstrong Tucker told committee members the state's higher education system soon would be operating with a new funding formula that will be more incentive-based. Under the new, performance-based method, an institution's funding will only be affected by its own outcomes and a three-year rolling average will be utilized to protect against large annual swings. The new formula also has provisions to tie in workforce outcomes, which Tucker said would help align degree production outcomes with state priorities.

"I could tell Chancellor Tucker worked hard to build consensus on that proposal," Householder said. "It's not easy to make wholesale changes and overhaul a system that has always treated each institution as equal, but rarely does one size fit all in West Virginia, and we think it makes good sense both financially and in terms of workforce readiness to choose to reward positive outcomes with more dollars."

The House Energy and Manufacturing Committee advanced House Bill 4002 late this week. The measure would create the certified sites and development readiness program, which lead sponsor Clay Riley, R-Harrison, said would help secure the state's position among site selection consultants to help land the next big

economic engine.

"I've personally been involved in those interviews with site selection consultants, and I've heard them say they want to recommend West Virginia, but we've had too many unknowns or it's not worth it to bring a client to a site without knowing there's a realistic plan for infrastructure," Riley said. "This business used to be done by picking up the phone, but now much of it's done online, just like most other businesses, and with site selection consultants doing 90% of their research, information gathering and filtering before they ever contact a representative from our state, we must be able to give them what they're looking for and move at the speed of business if we want to have a shot at competing for major projects."

Riley said 37 other states have site certification and/or site readiness programs, including three of West Virginia's surrounding states. House Bill 4002 would establish the program to be administered within the Department of Economic Development to generate criteria and site certification levels based upon the developmental readiness of a site. Landowners must apply to participate in the Certified Sites and Development Readiness Program, and if the Department selects a property to evaluate, a report will be provided to the applicant outlining site deficiencies and strengths as well as suggesting a prioritized list of suggested improvements. The program proposal also includes a micro-grant program, which would help sites make improvements.

A total of 957 bills have been introduced in the House, and three House Bills have passed the full House as of Jan. 21. The last day to introduce bills in the House is Feb. 15.



10	Nonstick cooking spray
10	large eggs
1	cup shredded cheddar cheese
1	cup cooked quinoa
1	cup tomatoes, quartered
1/2	cup finely chopped broccoli florets
1/2	cup finely chopped cauliflower florets
2	tablespoons finely chopped fresh basil (optional)

Preheat oven to 350 F. Lightly oil or coat 12 muffin cups with nonstick cooking spray and set aside.

In large bowl, crack eggs. Whisk until well combined. Stir in cheese, quinoa, tomatoes, broccoli, cauliflower and basil, if desired, until well combined.

Use 1/4-cup measuring cup to divide mixture evenly into prepared muffin cups.

Bake 16-18 minutes until eggs are set. Allow to cool slightly before serving.

Refrigerate leftovers up to 3 days or freeze up to 1 month.

## BASIC BIBLE

### Jesus' Arrest

John 18:1-13

Each gospel tells the same story but is different in emphasis. John's account of Jesus' arrest is markedly different from the rest in that no mention is given to Judas' kiss of betrayal. John's gospel is also different in that it reports a scene omitted from the others, a scene in which Jesus asks, "Whom seek ye?"

These differences are not by accident. John wrote his gospel more than two decades after those of Matthew, Mark and Luke. John would have possessed full knowledge of the other gospels and the epistles of Peter, James and Paul. The reason that John's gospel reads differently is by design. The Holy Spirit is the real author of all scripture.

Before examining that which John was moved to record, let us review the sequence of events leading up to and following Jesus' arrest. Matthew, the human author of the gospel bearing his name, was on hand to witness the same things which John witnessed. The timeline of John is found in the text before us.

John's timeline: Jesus and the disciples enter the garden of Gethsemane (v. 1). Judas accompanied with men dispatched from the chief priests approach Jesus and the disciples (v. 3). Jesus interacts with the arresting party (v. 4-8). Peter draws his sword and strikes the high priest's servant and severs his ear (v. 10). Jesus is arrested and bound (v. 12). Jesus is led off to appear before Annas (v. 13).

Matthew 26 documents the following sequence: Jesus and the disciples arrive at a location within Gethsemane (v. 36). Peter, James and John are separated from the presence of the other disciples (v. 37). Jesus tells the three to remain where they are while He goes a short distance to pray (v. 38-39). Jesus returns to Peter, James and John, finds them asleep, and admonishes Peter (v. 40). Jesus, again, separates from the three to pray twice more, each time returning to find them asleep (v. 40-45). Judas and the armed multitude approach (v. 47). Judas betrays Jesus (v. 49). Peter draws his sword and strikes the high priest's servant and severs his ear (v. 51). The disciples flee (v. 56). Jesus is led off to Caiaphas (v. 57).

While both John's and Matthew's accounts begin and end with the same happenings, that which falls in the middle is not the same. John describes that which He witnessed before Jesus' identity was revealed by Judas. Matthew skips this scene and focuses upon the kiss of betrayal which identified Jesus to the arresting party which accompanied Judas. Everything that Matthew reported and everything that John reported transpired as set forth in scripture.

Did Matthew and John see different things? Both saw the kiss of betrayal. John, Peter and James, however, as documented in Matthew 26:37, were in closer physical proximity to Jesus than the other disciples. John, possessing a front row seat, would have seen more if more were to be seen.

We need not speculate upon that which is not stated. John recorded the words which Jesus spoke to those who approached in the dark of night. Jesus asked, "Whom seek ye?" (v. 4). Jesus knew whom they sought. Jesus knew and had made known to the disciples that which would transpire that night. Jesus, knowing all things, knew that they would reply, "Jesus of Nazareth." Jesus also knew that that they would fall backward to the ground when He said "I am he."

John was moved by the Holy Spirit to report the things which he saw and heard such that all believers might know the Father through the Son as he, John, knew the Father through the Son. What did John see? He saw those armed with swords, staves and torches fall backward. What did John hear that caused them to fall? John heard "I am he." John heard the words which Jesus spoke, not in KJV English, not in the Greek which he penned his gospel. John heard that which Jesus spoke in Aramaic, the language of the land, the language of the scribes, the priests, and Pharisees. John did not hear the "he" of "I am he" because "he" was never said; "he" was produced by the scholars who translated the Greek of John's gospel into English. There is no "he" in the Greek text. Jesus spoke two words, "I am," and He spoke them in Aramaic.

In the course of time, languages change and pronunciations are altered. The words which John heard, the words which caused the multitude to fall backward, "I am," are a close cousin to the Hebrew words "I AM THAT I AM" which God spoke to Moses from the burning bush. John heard what Moses heard. John heard the voice of the self-existent God.

The party led by Judas sought Jesus of Nazareth. Jesus answered, "I am," and they fell backward. This is the picture that the Holy Spirit directed John to record. Jesus cannot lie. Jesus of Nazareth was the "I AM" manifest in the flesh.

John knew what he had beheld. The Holy Spirit speaks to all believers through John. I AM in the flesh, possessing the power to make men fall backward before Him, willing gave Himself into the hands of them who knew Him not. I AM became flesh to die in the flesh such that all who believe might rise with Him and be one with Him. Such is the Son that John knew. Such is the love of God.
