

WV DOH Releases I-64 Pothole Update

The WVDOH Contractors were back on the scene on Friday, Feb. 4, 2022, with DOT Industrial Grade Mortar, a fiber-reinforced, cement-based material to fill the potholes. Brayman Trumble had both westbound lanes reopened Friday evening. More permanent repairs must wait until the weather improves and temperatures rise. The WVDOH is in discussions with a local asphalt plant to see if the plant can open early. Asphalt plants don't usually open until early March. Pothole filling on both eastbound and westbound lanes will require intermittent lane closures. The WVDOH has posted message boards in the area to notify drivers of road conditions. Motorists are urged to adhere to the posted speed limits. Those whose vehicles may have been damaged on the stretch of interstate may file a claim with the West Virginia Legislative Claims Commission. For more information, call toll-free 1-877-562-6878.

WVDOH responded by sending maintenance crews from the Scary Creek garage to the scene. Brayman Trumble, the contractor tasked with the I-64 upgrade to 6 lanes was directed to make repairs. The Division of Highways closed the westbound slow lane to allow repairs. Because asphalt plants are shut down for winter, the contractor was unable to get hot asphalt to fill the potholes. Cold patch (unheated asphalt) could not be used fill the potholes because it does not hold up to heavy traffic.

Special Olympics Benefits from Hurricane's Polar Plunge

Over a hundred daring individuals braved the

freezing temperatures of last Saturday to jump into an icy pool for the West Virginia Special Olympics' Polar Plunge.

A crust of ice formed when the pool was partially filled on Friday night. Chunks of ice remained following the last addition of water on Saturday prior to the 5 p.m. plunge.

The fundraiser was held at the Hurricane

City Park on February 5, and featured a costume contest for jumpers who like to dress up, as well as an after party at Fireside Grille in Teays Valley.

Among the 102 plungers was Peyton Edwards, daughter of Hurricane Mayor Scott Edwards. At the Monday, February 7 Hurricane City Council meeting, Edwards said that Peyton reported that her polar

plunge caused her to lose her breath.

Jason Knapp served as the master of ceremonies for the Polar Plunge, and directed the jumpers preparing to make the plunge into the frigid pool. An ambulance was parked nearby with emergency crews on the scene in case of accidents.

This is the fifth year that the Polar Plunge has been held in Hurricane. The West Virginia Special Olympics holds Polar Plunge events throughout the state in the months of January and February. Proceeds from these fundraisers go towards providing training for athletes with intellectual and physical disabilities.

The 2022 Hurricane Polar Plunge made over \$20,000 for the West Virginia Special Olympics.

No two Hurricane City Council meetings are the same. The February 7 meeting was different in a different way in that it provided a forum by which Steve Deweese could present his resumé to the city's elected officials. Deweese stated that he last addressed Council in this manner in 2012 when he was seeking election to the office of Putnam County Sheriff. Deweese

is now seeking to serve Putnam's citizenry as County Commissioner.

Current mayor Scott Edwards, recorder Linda Gibson, and council members Reggie Billups and Marshall Ginn were in office when Deweese addressed council in 2012. Deweese has added to his resumé in the last ten years. He was elected Sheriff and served in that office from 2013 to 2021. Prior to serving as Sheriff and Treasurer of Putnam

County, Deweese was a deputy sheriff and active military with stints in Iraq. In total, Deweese has logged thirty years in law enforcement and thirty years in the Army (10 years active duty).

Deweese said that improved broad band infrastructure would be his top priority. He stated that he would be voice for safety, well-being and home values when zoning issues come before the

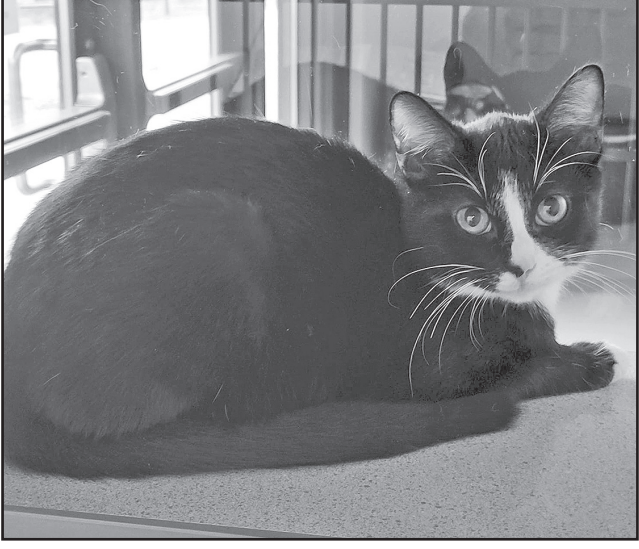

Susanna America Smith, daughter of Bartley and Nancy Thomas Smith was born near Big Hurricane Creek, Putnam County, Virginia, in 1843. In November, 1860, she became the bride of George P. Thomas, son of William and Susan Thomas, of Giles County, Virginia. The first of the young couple’s two children, Araminta Frances, or ‘Minty’ as she was more commonly known, was born in December, 1861. A son, Allen Benton, was born in March, 1864.

Not long after little Ben’s birth, the family moved to Gallia County, Ohio, where George enlisted as a private in Company ‘H’ of the 43rd Ohio Volunteer Infantry Regiment. He saw active service throughout eastern Tennessee, Georgia, and the Carolinas. Unfortunately, however, tragedy struck in August, 1865, when George died from wounds received in battle some months earlier. Records indicate that he was convalescing at Newton Hospital, North Carolina at the time.

Faced with the prospect of rearing two small children with no means of support other than charity, Susanna filed a widow’s pension claim with the government, and began receiving benefits shortly thereafter. In the winter of 1865, she met Reuben Leadman, who lived in nearby Green Township. Reuben, who had served with Company ‘L’ of the 7th Ohio Cavalry Regiment, was some twenty years her senior, and according to some, possessed a violent temper. Despite this, the couple was married at Gallipolis, Ohio, on February 14, 1866.

The family first took up residence in Clay Township, Gallia County, Ohio. In early 1867, the first of eight more children, James Franklin, was born. He was followed by Nancy Alice in 1871, Reuben C. in 1872, and Mary Matilda in 1874.

It was about this time

that the family moved back to Putnam County, West Virginia. Shortly after their arrival, another daughter, Lizzie M., was born 1877. In May, 1878, Reuben purchased a farm containing some 438 acres on Big Hurricane Creek. It was here that the rest of the Leadman children were born - Pearl C. in 1880, Valera L. in 1884, and John in 1886.

As the children grew older, they each married into families that were well known throughout the Hurricane community. Minty Thomas married Peter C. Davis in 1886, and Ben Thomas married Mahala Ann Sovine in 1890. Marriages of the Leadman children included James Franklin to Leah East in 1890, Nancy Alice to Ezra Meadows in 1892, Reuben C. to Cora A. Sovine in 1894, Mary Matilda to Solomon D. Gilfillen ‘in 1891, Lizzie M. to Aaron Gibson (date unknown), Pearl C. to Robert L. Swann in 1901, and Valera to Robert Neal in 1902. At present, it is uncertain to whom John was married, but it is known that he was a resident of Lincoln County for several years.

Susanna America Smith Thomas Leadman passed away June 10, 1894, and was buried next to her parents in the Smith Family Cemetery. Reuben had by this time, grown quite feeble. Having suffered a gunshot wound at the Battle of Franklin, Tennessee, in 1864, he qualified for and received a disabled veteran’s pension, and was able to live his declining years in reasonable security. He passed away in October 1898, after a long period of illness, and was buried next to Susanna in the family burial plot.

THIS WEEK IN THE HOUSE OF DELEGATES

For the week ending Feb. 4, 2022

Members of the House of Delegates finished the third week of the regular legislative session having taken a big step toward diversifying the state’s economy.

The House completed legislative action Jan. 31 on Senate Bill 4, sending it to the Executive for action. The bill repeals a 26-year ban the Legislature had enacted to ban nuclear power and allows for the possibility of nuclear energy production rounding out West Virginia’s power portfolio and indicating to the global economy that the state is successfully transitioning its economy.

“Technology is moving quickly, and West Virginia has to keep up to compete on a global scale, which also means meeting the global economy’s demands,” said

House Speaker Roger Hanshaw, R-Clay. “We don’t think the fossil industry is going away any time soon, nor do we want it to. Our fossil industry will continue powering the country for the foreseeable future, but we want to be sure West Virginia is providing options and signaling to the rest of the world that we’re a great place to consider doing business of all kinds.”

Hanshaw created the Coalfield Communities Workgroup at the conclusion of the 2021 regular legislative session to focus on ways to solve the problems facing coal communities. Members of the workgroup traveled throughout the state listening to community members and compiling a report of both the struggles and

suggestions. The Select Committee on Coalfield Communities was created last week to formalize and continue the group’s efforts. That committee reported out its first bill this week, House Bill 4479.

House Bill 4479, the Coalfield Grant Facilitation Act of 2022, would create a commission to administer

the necessary matching funds to secure federal, private or nonprofit grants for coalfield community organizations or entities to fund development projects. The new commission also would coordinate with higher education institutions throughout the state to help in applying for those grants.

Pilate: What is Truth?

John 18:28-40

All four gospels record Jesus’ being brought before Pilate following His arrest and trial by the Jewish religious leaders, but only the Gospel According to John gives the detailed exchange between Jesus and Pilate. The things that John wrote were written so that men might believe that Jesus is the Christ, the Son of God; and that by believing men may have life through His name (Jn. 20:31).

“Then led they Jesus from Caiaphas unto the hall of judgment . . .” (v. 28a). Caiaphas, the high priest, presided over the Sanhedrin which found Jesus guilty of blasphemy. Caiaphas sent Jesus to the hall of judgment, the headquarters of the Roman governor, Pontius Pilate.

Jesus was brought before Pilate such that He would be put to death (v. 32). The penalty for blasphemy under the law of Moses is death by stoning. Had Judea and Jerusalem not been under the Roman authority, the Jews (Caiaphas and other religious leaders) would have executed Jesus by stoning. Because of excesses by the Sanhedrin more than twenty years earlier (6 A.D.), Rome initiated a policy that gave Roman governors, alone, the power to exercise capital punishment.

Just prior to departing from Perea for Jerusalem, Jesus told His disciples that He would be crucified and rise again on the third day (Matt. 20:19). Jesus knew that He would be executed under Roman law.

The crucifixion was prophesied by David more than 900 years earlier. David’s Psalm 22:16 reference, “they pierced my hands and my feet,” clearly refers to crucifixion. All scripture is authored by God, omniscient.

Normally, the events which are recorded in the verses before us would have been conducted behind closed doors. The religious leaders would not enter Pilate’s headquarters on this occasion because entering the house of a Gentile made one ceremonially impure and unable to partake of the passover feast. The righteous views that prevented them from entering into the house of a Gentile moved them to execute the Messiah. Pilate accommodated the leaders by moving proceedings to an open area outside of his quarters.

One found guilty of sedition under Roman law would be executed by crucifixion. The line of Herodian kings was established to rule Judea by Roman edict. It is apparent from his line questioning (v. 33) that Pilate was intent upon determining if Jesus were guilty of sedition by attempting to rule in Herod’s place.

Pilate in asking Jesus if He were king of the Jews was asking Jesus if He were seditious. Jesus, in asking Pilate if he asked this question of himself (v. 34), forced Pilate to rephrase the question. Pilate, as a qualified Roman governor, was schooled in Judaism. He knew that if a Jew asked Jesus if He were king of the Jews that the questioner was seeking to know if Jesus were the Messiah. Rome had no law forbidding the existence of the Jewish Messiah, only laws which forbid the Messiah or anyone else from opposing Rome rule.

Jesus then testified before Pilate and to all present that He did not claim a kingdom of this world, that “but now is my kingdom not from hence.” Pilate was not satisfied with this answer and asked, “Art thou a king then?”

Jesus answered that He was a king but that his kingdom was one of truth and composed of only those who heard the voice of truth. Pilate asked, “What is truth?” The question is not answered. The truth is the opposite of a lie. All who believe the lie (that which Satan said in Genesis 3:4) cannot answer because they do not believe God.

All present —Pilate, the Jewish leaders and their followers, and future followers of Jesus— heard the words which Jesus spoke, but only the future followers of Christ would hear the voice of truth. God’s word is put before all men, but not all men shall hear truth. Pilate could not answer his own question.

Pilate, having determined that Jesus was innocent of any crime against Rome, turned to those who had found Him guilty of blasphemy and asked if he should release “the King of the Jews” unto them. They chose Barabbus, a robber.

All who truly hear Jesus, look to the day when He shall reign as king from the throne of David in Jerusalem. The voice of truth that proclaimed His crucifixion more than 900 years prior to His coming in the flesh (Ps. 22) proclaims that He shall return. All who are of His kingdom look to that day.

God has given us His word that His truth may be made known to all who shall hear. Let us not hide the light which He has entrusted to us.



(1) Grand Prize Winner – will receive \$10,000 to be shared with their school/district.

(4) Grand Prize Finalists – will receive \$5,000 to be shared with their school/district.

(10) LifeChanger Award Winners – will receive \$3,000 to be shared with their school/district.

(1) Spirit Award Winner – This award is given to the nominee whose community demonstrates the most support for their nomination. The winner will receive \$5,000 to be shared with their school/district.

(1) Capstone Award Winner - This award is given to a nominee retiring at the end of the 2020-21 school year. The winner will receive \$3,000 to be shared with their school or district.
