Toyota Announces \$73 Million Investment at Buffalo

Hybrid transaxle and engine capacity boosted

Toyota announced an additional \$73 million investment at its Buffalo plant in Putnam County on Friday, February 11.

This investment comes on the heels of the \$240 million investment announced in November and will increase hybrid transaxle production capacity to 600,000 units per year. With this funding, TMMWV will also begin assembling an estimated 120,000 rear motor stators per year, a key component in electric motors. Currently, a team of more than 2,000 build approximately one million engines and transmissions annually for many of Toyota's North American-assembled vehicles. Toyota has invested more than \$2 billion in its Buffalo plant.

Toyota has committed to offering an electrified option across its entire

lineup of both Toyota and Lexus vehicles by 2025. Advancing the production of electrified vehicles and their components, including hybrid transaxles, plays an important part in helping Toyota achieve its goals for carbon neutrality.

Hybrid electric vehicle systems combine two separate sources of propulsion or motive power, such as an internal combustion engine and an electric motor, to take advantage of their respective benefits while also compensating for their respective limitations. While hybrid systems are more complex than a conventional vehicle and add vehicle mass due to the addition of components, the same system allows the vehicle to be more energy efficient as the hybrid transaxle can effectively transfer power seamlessly between the engine, electric motor and wheels in any number of combinations.

New Hurricane Dollar Tree Set for April 7th Opening

Dollar Tree, Inc. announced Monday, February 14, that its Dollar Tree store, at

270 Progress Way in Hurricane, will be relocating to 3114 Teays Valley Road. The new 11,210 square foot location is scheduled to open on Thursday, April 7.

Dollar Tree stores provide extreme value every day, along with more thrills, more fun, and new items every week. The broad assortment of merchandise includes seasonal and home décor, household products, Hallmark greeting cards, balloons and party supplies, dinnerware,

other software providers were not afforded the opportunity to submit bids.

At its February 8 meeting, the Commission approved the low bid of \$763,600 by Telconn, Inc. for construction of the Confidence 911 tower. Premier Construction Group and Meridian Communications submitted bids of \$886,685 and \$1,169,751.00, respectively.

Two previous bid openings for the Confidence 911 tower were conducted on July 29, 2021 and September 14, 2021. No bid was accepted on July 29 because there was only one bid, \$768,341 by Premier Construction. All September 14 bids were rejected because the low bid excluded construction which other bidders

County Commission Conditionally Approves Bid for Software

At its January 27 meeting, the Commission approved a Komax bid of \$22,550.00 for software for the Planning Commission providing the bid met all requirements. Komax and CDI were the only bidders.

CDI presented three bids: (1) an onsite server

with a bid of \$45,110.00, (2) an onsite server with a bid of \$65,280.00, and (3) an offsite server with a bid of \$22,550.00. Komax presented two bids: (1) an onsite server with a bid of \$24,025.00 and (2) an offsite server with a bid of \$25,225.00.

Komax provided a software bid on November 9, 2021, but the bid was rejected because

it did not include the capability for the public to search, view, and print documents as required. When it was determined that Komax did not meet requirements, the company submitted a solution that would meet requirements with a revised bid of \$25,225.00. The Commission did not accept the revised bid at that time because

WVDOH Sponsors STEAM Bridge Design Contest

The 2022 West Virginia Bridge Design & Build Contest is now underway! All West Virginia students in grades 6 through 12 are encouraged to submit bridge designs for a chance to win cash prizes, including a Grand Prize of \$500.

Participation in the contest is entirely free and open to students in public school, private school, or who are home-schooled. Everything a student needs to compete, including a free download of bridge design software and a tutorial by Secretary of Transportation Jimmy Wriston, P.E., is available at the Bridge Design & Build Contest website, <https://wvbridgedesignandbuildcontest.com>.

Students have until Sunday, Feb. 27, 2022 to register and submit their bridge designs.

The contest, sponsored by the West Virginia Division of Highways, BridgeWalk, and West Virginia Department of Education, pits middle school and high school students against one another to see who can design the best bridge using standardized design software. The goal is the build a safe, well-engineered bridge for the least cost, just like engineers at the DOH do

every day.

"Anyone who is interested in science, engineering or anything like that should take the opportunity to learn about bridge design and engineering," said Garrett Ferguson, a Frankfort High School Student who is a past winner of the contest. "There are a lot of things you wouldn't get to learn in normal school."

In its 21st year, the contest is designed to encourage STEAM education and inspire tomorrow's engineers today. The WVDOH co-sponsors the annual contest to support education, and hopes that participation will inspire middle school and high school students to pursue a career in engineering.

Every student who makes it to the finals receives \$100. First place high school and middle school winners take home \$500, second place winners receive \$400, and third place winners get \$300. Every student who participates in the contest gets a free BridgeWalk tour for themselves and their families.

Contest finals will be held Saturday, March 26, 2022. Finalists will be notified no later than March 4, 2022.

WVDEP Accepting Applications For 2022 State Make It Shine Spring Cleanup

Applications are now available for the 2022 West Virginia Make It Shine Spring Statewide Cleanup. The annual event is sponsored by the West Virginia Department of Environmental Protection's (WVDEP) Rehabilitation Environmental Action Plan (REAP).

This year's event will be held during the first two weeks of April (April 2nd through April 16th) and applications are due March 11th.

The Make It Shine program will provide resources such as cleanup materials, waste hauling, and landfill fees to community groups volunteering to conduct litter cleanups in state streams or on public lands.

The WVDEP encourages all volunteers to wear a mask and stay socially distant during their cleanups in order to help prevent the spread of COVID-19.

More than 4,800 volunteers from nearly 170 groups participated in the 2021 statewide spring cleanup, removing just over 754,000 pounds of litter, and collecting 1,850 tires from 737 acres of public lands and 46 miles of streams, while remediating 144 dumps.

Once your project is approved, REAP staff will coordinate delivery of cleanup supplies and waste hauling and disposal. THIS WEEK IN THE HOUSE OF DELEGATES

For the week ending Feb. 11, 2022

Members of the West Virginia House of Delegates continued their efforts to ensure the state is considered for the kinds of investments that bring generational change to its economy as the regular legislative session passed the halfway point this week.

The full House passed House Bill 4003 Monday. The measure would establish a clear legal right of title to the chemical compounds, elements and substances derived from the treatment of acid mine drainage as well as setting definitive roles in the cleanup and extraction of rare earth elements from those coal waste piles. West Virginia has a vast array of coal waste piles, and those abandoned treatment solids contain concentrations of the rare earth elements in high demand because of their essential role in making most electronic and automotive products.

The bill passed the House by a near-unanimous vote and now is with the Senate for debate.

"We remain committed to creating a business climate that turns heads and catches national attention for opening up avenues previously thought to be restricted and off the table in West Virginia," said House Speaker Roger Hanshaw, R-Clay. "I will continue to repeat to anyone who will listen that we are an

economy in transition, and we are a welcome economy for investments, expansions and new industries right here in the Mountain State."

In addition to Senate Bill 4, a reversal of the state's nuclear power ban, becoming law this week, the House adopted House Resolution 13. HR13 creates the Select Committee on Tourism and Economic Diversification for the remainder of the 85th Legislature to maximize the economic development efforts taking place within the Legislature.

Hanshaw appointed House Speaker Pro Tempore Gary Howell, R-Mineral, as Chairman of the new Select Committee. Other members include: Vice Chairman Delegate Eric Householder, R-Berkeley; Delegate Josh Holstein, R-Boone; Delegate Sean Hornbuckle, D-Cabell; Delegate Riley Keaton, R-Roane; Delegate Clay Riley, R-Harrison; House Minority Leader Doug Skaff, D-Kanawha; Delegate Johnnie Wamsley, R-Mason; Delegate Bryan Ward, R-Hardy; Delegate John Williams, D-Monongalia; and Delegate Mark Zatezalo, R-Hancock.

"I'm honored to add the important work of this Committee to my duties this year as we continue to develop a more diverse economy and do everything we can to make

West Virginia the easy choice for job creation and prosperity," Howell said.

The first meeting of the Select Committee on Tourism and Economic Diversification will be at 5 p.m. Monday, Feb. 15 in Room 460M. Three bills aimed at creating narrow tax credits for specific investments are on the agenda.

House Bill 4098, which would make it clear in state code that geothermal energy may be developed in West Virginia, also passed the full House of Delegates overwhelmingly this week. The measure outlines the ownership rights of geothermal resources and would put any regulatory oversight of development and exploration of those resources under the West Virginia Department of Environmental Protection.

"This is a new chapter in West Virginia's history,

and this is part of the all-in energy program that we are following currently," Zatezalo said in support of the bill during debate on the floor Thursday.

House Judiciary Chairman Moore Capito, R-Kanawha, explained to Delegates the measure was brought forward strictly as a preventive move to ensure public safety is in place before any commercialization or utilization of the state's geothermal resources occurs.

"I think there was a desire to sort of investigate this source of energy, if it has potential down the road," Capito said before the vote.

As of Feb. 11, a total of 1,286 bills had been introduced in the House and 14 bills had completed legislation. The regular legislative session ends at midnight March 12.





Feb. 17, 1735: Morgan Morgan was commissioned a captain of militia in the 201st Field Artillery, which is considered the oldest military unit in the United States.

Feb. 18, 1890: Ellison Mounts, a cousin to the Hatfield family, was hanged for murder, ending the Hatfield-McCoy Feud.

Feb. 18, 1969: Hundreds of miners in Raleigh County went on strike over the issue of black lung. Within days, the walkout spread throughout southern West Virginia.

Feb. 19, 1908: Orval Elijah Brown was born near Lizemores in Clay County. Brown, a free-spirited individual, gained notoriety as the "Clay County Wild Man" during the Great Depression for his untamed physical appearance that included a flowing beard and the wearing of little more than a self-made loincloth.

Feb. 19, 1943: Author

Homer Hickam was born in Coalwood, McDowell County. Hickam's second book, Rocket Boys: A Memoir, was published in 1998 and became a runaway bestseller.

Feb. 20, 1875: The West Virginia Legislature approved a bill to move the state capital back to Wheeling.

WVDEP, WVCA, Coal River Group partnering on habitat enhancement project

The project aims to help restore habitat and recreational value to two miles along Coal River. A public meeting is set for February 17th

The West Virginia Department of Environmental Protection (WVDEP) is partnering with the state Conservation Agency (WVCA) and the Coal River Group (CRG) on the Coal River Habitat Enhancement Project, which aims to restore habitat and recreational value to the mainstem Coal River. The project includes roughly two miles of bank stabilization work intended to increase fish habitat abundance and complexity and enhance recreational opportunities on the river. The WVCA will serve as the lead for the project, with WVDEP providing funding and support.

Originating at the Forks of the Coal River, the project extends approximately two miles to the Lions Club Park in Alum Creek and will involve utilizing heavy equipment to strategically place wood and boulder structures throughout the reach using natural stream restoration techniques. Approximately 100 structures are to be installed and will serve

to create pockets of habitat, restore channel corridors, protect at-risk banks, and benefit aquatic organisms by increasing the movement of fine sediments. Work on the project is expected to begin in late 2022 and carry on through Spring 2023.

The WVCA is hosting a public meeting for residents and landowners along the Coal River to provide more information on the project and stream restoration practices. The meeting is scheduled for Thursday, February 17th at 6 p.m. at the Alum Creek Lions Club located at 4452 Coal River Road, Alum Creek, WV 250003. To register, contact the WVCA at 304-558-2204.

The WVDEP, WVCA, CRG, the state Division of Natural Resources (DNR), and other stakeholders have worked together to restore habitat to over 20 miles of the Little Coal River in recent years, making significant improvement to the river and its fisheries. Enhancement of habitat along the Coal Mainstem, coupled with the previous restoration work on the Little Coal, will provide an added benefit to a historically degraded watershed.








Crucifixion and Death

John 19:16-30

"Then delivered he him . . ." (v. 16). Pilate delivered Jesus to be crucified after the chief priests had proclaimed, "We have no king but Caesar." While all four gospels present an account of the crucifixion, only Luke and John were moved by the Holy Spirit to include the superscription, Jesus of Nazareth the King of the Jews, which Pilate had affixed to the cross above Jesus' head. Both Luke and John recorded that the superscription was written in Greek, Latin and Hebrew. John's account, however, provides details which Luke omitted.

John reveals that the chief priests objected to the wording of the superscription. John's gospel was written twenty or more years after the others. All that is recorded in John, but not in the others, is recorded such that believers might be given additional understanding — an understanding of why Pilate wrote that which he wrote.

In verse 20, John states that the title above Jesus was read by many of the Jews. The title would have been read by both Jews and Gentiles. The many who read it would have reported it to others. They would have told all that Pilate had written "Jesus of Nazareth the King of the Jews" in three languages. Hebrew is the language of the Jews, Latin is the language of Rome, and Greek was the international language, the language of commerce and the language of the learned. The message is loud and clear. The King of the Jews, the Messiah was crucified here! It is a message by which the uncertain is made certain. It is a message to believers that sixty-nine weeks of years have passed and the Messiah has been cut off as prophesied by Daniel (Dan. 9:26). It is a message that Jesus died, not for Himself, but for all who shall believe. It is a message that declares "Yet it pleased the Lord to bruise him; he hath put him to grief: when thou shalt make his soul an offering for sin" (Isa. 53:10). It is the message that declares God's plan of salvation, the plan which God put in place before He laid the foundations of the earth (1 Pet. 1:20).

Pilate proclaimed Christ, and Him crucified. That was not the purpose for which Pilate wrote that which he wrote. Pilate wrote "Jesus of Nazareth the King of the Jews" because he was afraid (see v. 8). Jesus had been delivered to him to be executed for blasphemy. Blasphemy against the God of the Jews was not an offense against Rome. Roman law did not allow the Jews to execute anyone for any reason. Pilate caved to the Jewish religious leaders because he needed their assistance in keeping the people in line. Pilate wrote "Jesus of Nazareth the King of the Jews" in three languages to provide notice that Jesus was executed for sedition, a capital offense. Pilate refused to change the wording of the superscription because the rewording would declare that Jesus was executed for blasphemy. Unknowingly, Pilate declared a truth which would be heard by all who believe or ever believe.

"Then the soldiers . . . took his garments" (v. 23). All four gospels state that the soldiers cast lots for Jesus' garments as prophesied in Psalm 22:18. John alone reports the reason. The soldiers did not cast lots for the Messiah's clothing because they sought to fulfill prophecy. They cast lots for one particular item of clothing, the coat that was without seam. A coat without seam is not held together by stitching. A seam is no stronger than its stitches — more stitches yield greater strength. The strength of a garment without seam exceeds the strength that can be produced by close stitches.

Think about it! God, in His foreknowledge, knew the very clothing which "my righteous servant" (Isa. 53:11) would be wearing when his soul would be made an offering for sin. The Holy Spirit moved David (Ps. 22), Isaiah (Isa. 53), and John (Jn. 19) to write that which they wrote such that we might know God, God Omniscient. God declares Himself to us such that we might declare Him to all who have the ears to hear.

"Woman, behold thy son . . ." (v. 26). All four gospels report the presence of the women at the cross. Only John records the words which Jesus spoke to His mother and to John. We see the Father through the Son. The Son directed the disciple whom He loved to provide for the needs of His mother. The Father knows our needs. He provides our daily bread. He directs us to love one another as He loves us.

"It is finished . . ." (v. 30). God the Son took on a body of flesh such that men might be made free from sin. Jesus came into the world to fulfill the law (Matt. 5:17). His mission was completed when He gave up the ghost. His soul was made an offering for sin (Isa. 53:10). He was the Lamb without blemish whose blood has covered our iniquities. He fulfilled every jot and tittle of the law. He fulfilled the words of the prophets. He delivered the full measure of the Father's love. He is our peace.

West Virginia State University Alumnus a Writer, Editor on new CW TV Show

A 2005 communications graduate of West Virginia State University (WVSU) is a writer and story editor for a new TV drama premiering later this month on The CW.


Jeff Thomas, originally from Hurricane, West Virginia, now resides in Los Angeles. He's using his experience at a Historically Black College and University (HBCU) to help write and edit screenplays for the upcoming teen drama "All American: Homecoming."

The new show is a spinoff of "All American" and focuses on the character Simone Hicks, who is a tennis star now attending an HBCU in Atlanta. Simone was introduced in the second season of "All American" and this new series follows her story. The show premieres on The CW February 21.

"When I heard the pitch that there was a show about teenagers going to college on The CW, I thought I was the worst fit," Thomas said. "Then, they told me it was about an HBCU in the south and I thought, 'if that doesn't hit home, I don't know what does.'"

While working with other writers on the project, Thomas said he feels he can represent a perspective that nobody else in the room can because of his roots and experience at WVSU.

"It's about the

importance of HBCUs, especially in today's America," Thomas said. "It's a show about how important community is and how community becomes the biggest factor in raising tomorrow's leaders. I think that's the thing that makes the most sense for me because when you come from West Virginia, there is this unmistakable sense of community and it wraps you up like a blanket."

When people in Los Angeles talk to Thomas about West Virginia, he said many, especially those from the East Coast, have stories about driving through the state and about how beautiful it is.

"But they don't say anything about stopping

in West Virginia," he said. "There are a lot of people who know West Virginia is trees and mountains, but there are very few people who know that West Virginia is West Virginians."

Thomas has lived on the West Coast since 2008 when he was accepted into a screenwriting program at the University of Southern California. His previous TV writing credits include the show "Titans" on the DC Network.

West Virginia Raptor Center Restructures and Moves Forward with Its Mission

Formerly known as the West Virginia Raptor Rehabilitation Center (WVRRRC), the WV Raptor Center is in the process of restructuring. While renovating and making a slight name change, its basic goals of rehabilitating birds of prey, training educational ambassadors, providing public environmental education programs, and supplying scientific data to share with other facilities and academia, will never change. The center's headquarters will move to Tucker and Randolph Counties, WV, while the Fairmont, WV location will still be utilized during the summer months after renovation has been completed on that facility.

The non-profit (501-c-3) WVRRRC was established in 1983 by founder Michael Book. After 38 years of caring for injured, orphaned and sick birds of prey, and providing environmental educational programs to the public, Book made the

difficult decision to close the doors of the WVRRRC in July, 2021. All the birds housed at the center at the time were transferred to another facility. Just when it looked like this was the end of a much needed service, Master Class Falconer Collin Waybright, unaware of the closure, contacted the center after receiving a call to pick up an injured raptor. Devastated upon learning the center was not in operation, Waybright decided to take on the challenge of keeping the doors open. Encouraged by Book, he took over the huge task of reorganizing, renovating and continuing the strong legacy of the center in providing a much needed service.

Before assuming the role of Executive Director, Waybright had volunteered since 2014 at the WVRRRC in many different capacities, thus aware of its mission and goals. His interest in falconry came at an early age and he earned his falconry permit in 2014 at

the age of 14. Since then he has trained many birds to become educational ambassadors, such as Shera, an American Kestrel currently at the Carnegie Museum of Natural History in Pittsburgh PA, and Mr. Spectacular, a Bald Eagle used for educational programs who has since been transferred from the WVRRRC to another facility. At 22, Waybright is one of the youngest Master Class Falconers in the state of West Virginia.

After lots of planning and establishing a committed Board of Directors consisting of individuals from the professional/scientific community and the general public, Waybright has started renovations at the former WVRRRC in Fairmont, WV. "We have a good solid Board of Directors that are all invested in seeing the WV Raptor Center succeed in its goals," said Chairman of the Board Marsha Waybright. The additional existing Board
