We know that God watches over us...every day...every hour...that is the only reason I am writing this...He took care of my family when I could not... Weekends I spent at the

roller rink in the valley... thanks to the Hodges... After church on Sundays, I often ate a meal at the home of Linda's mom... I was suffering PTSD... hardly getting through. My sweet daughter helped me as much as she could... my son also...

One of my favorite GSC professors, Dr. Craig Etchison, wrote me... Mike brought me the letter... Dr. E. told me he had gotten me financial aid at GSC... I was astonished. I hocked a couple of items, packed my daughter's old car, and moved into that horrible first place I lived at Glenville, keeping the little apartment in Hurricane... eating three days a week, no telephone, few clothes... I kept the Hurricane place so daughter could visit every other weekend from Indiana University... son in Texas at college and law school.

The first place at GSC was so bad, I finally moved into an old house, sharing with two other women. I had one room... \$75.00 per month. I couldn't

The Way We Were, The Way We Are By Brenda Burke wait to get to my valley

> apartment on weekends. I remember water running onto the floor in that house... anytime we used the kitchen sink... I am not sure the door locked... I used a sheet as a curtain... Dr. E. and his wife loaned me an electric blanket... it was so far from what I was used to when married... having it all... to having little... financially. I was fulfilling my dream finally... I took

> more hours than one should... I was determined to graduate as quickly as I could. I had gone part time for the Associate Degree, counting some hours I had from WVSC in 1965. I needed three years... I did it in two... plus I worked in the English Department at GSC, and I continued to go to our Burke's Hallmark as much as I could in Summersville... WV Strong...

> Those years are almost a dream... some of them nightmarish... it was difficult for me to accept that Mother was gone. So young... I kept dwelling on that... also, I had no way to help my kids, but we had helped them somewhat... they pretty much did the college thing on their own... after our lives dissolved as we knew them... I am so proud of those two... Nathan graduated from Texas Christian University... he was almost a senior when Mother died. Kathy was a junior at Indiana University... both graduated... despite the turmoil they were going through, losing their beloved Grandma... and experiencing the divorce of their parents... totally surprised.

There were times at GSC that I didn't think I could make it through a class... I walked hours at night... around town until a police officer told me it was too late to be walking... I continued to walk... but at the football field. The exercise help get through the pain... we lost so much in the first year... more than I can ever write about. college The

administrators gave me permission to move into faculty housing where I would be more comfortable. The rent was somewhat more, so I had to let the little apartment in Hurricane go. That meant that when Kathy and I traveled to see one another, we had much longer to drive. However, we did it... I missed going they helped me cope.

to that home on weekends, skating... seeing Linda, Phyllis, and their mom... I knew that I could not continue with little money, so I talked the college into letting me take more and more hours... in May of 1994, I received my degree... English/Language Arts and Psychology... in debt, owning not one piece of furniture... an old car falling apart... wondering what I would do next... my children were making it the best way they could. (All of my money working in Burke's Hallmark went to help the kids in college... and the first two years they received free tuition as valedictorians in a WV school... then they moved out of state where they always wanted to go.)

They did graduate with

a few loans... Nathan

put himself through law

school... never asking for

anything. The three of us graduated college within a year of each other...

Never realizing how tough life would be after losing Mother and going through the divorce, I was a basket case. I never dreamed what the future held... I knew I had a degree... my kids had theirs... we would get through whatever we had to... I remember going to Ohio to speak to the church there on a church anniversary (Mike and I and other friends started the church.) and I told those in the sanctuary... don't think that something bad won't happen to you because you sit in this church on these pews that we and our friends sacrificed to purchase... it can... but don't worry... God will watch over you... take care of you... be there for you as He has been for our family... was not mouthing platitudes... I was speaking the truth as I experienced it. I digress. After graduating, I

spent the summer looking for a job... at a job fair in the south, I was offered several. West Virginia did not have job openings for teachers at that time, and I realized I would have to go out of state. My first job as a teacher, after 40 years of dreaming... was at Ronald E. McNair Jr. High in Lake City, SC... 7th grade. In July, I packed all

my belongings in that small little Chevy Nova... headed for Florence where I rented an apartment. I had a bedroom suite loaned to me by my daughter and a few other pieces of furniture that were given to me. It was a lovely apartment, and my drive to school was quick. However, it was not an easy job for a brand new teacher, and I thought, at times, I would never make it. Also, I was so far from

While Nathan was in law school, our family spent time in the summers and at Christmas with him... we were not a me think... helped me family unit anymore, but we did not care... we wanted to be together when we could... we did... it helped us all get through a difficult time.

As I write this journey

I repeat WV Strong... we come from good stock... Mother prepared me for any future I might have... knowing her daughter better than anyone could. If my readers are still reading... my message is to have faith... to stay close to God... He will be there always... no matter how bad it gets... let me tell you, it was bad for us at times... we make



## **BASIC BIBLE**

### **Members of Christ**

I Corinthians 6:12-20

In the text before us Paul addresses the need for personal discipline of members within the church. Paul states, "All things are lawful unto me, but all things are not expedient" (v. 12a). While the use of the pronoun, me, is specific to Paul, every believer is "me" in the sense that we are all washed in the blood of the Lamb and are justified in Him and have the Holy Spirit of God in us (see v. 11). While all things may be lawful, not all things are expedient.

Paul, in writing to the church at Corinth, is speaking to all Christians of every era. His words are for all who have been saved or who ever will be saved from the judgment that awaits unbelievers. Christ has made us free of the law and its consequences. Not all things, however, are in keeping with the purpose for which we were made free of the law. Paul vows that he will not let freedom from the law to have power over him. We, like Paul, must face and deal with non-expedient choices.

It is apparent that there were many in the church at Corinth who were doing the very thing that Paul shunned — non-expedient things. What is a non-expedient thing? For Paul, it was indulgences which could have power over him.

In verse 13, Paul addresses a specific indulgence that troubled the church at Corinth: fornication. Fornication refers to any kind of sexual misconduct or sexual impurity outside of the bounds of marriage. In

the text before us, fornication is the translation of the Greek word

porneia.

There were some within the church who regarded fornication as meats for the belly and the belly for meats. Tasty foods are provided by God and God has given us an appetite for tasty food. Both food and our appetite for food are temporary; they are destroyed when life is taken from the body. The relationship between fornication and the body, however, is not the same as the relationship between food and appetite. The body of the believer is a duplex. It is both the house of our old self which was under the law and the house of the Holy Spirit which is of God. It is not expedient to reside in both sides of this duplex. It is expedient that believers should reside in the half that is forever.

The dead body of the believer shall be transformed. We have the promise that we shall be raised up by the power of God in the same manner that God raised up Christ, our Lord. The problem in the church at Corinth was simple: they did not regard their physical bodies in the same manner as does God. The Holy Spirit of God moved Paul to ask: "Know ye not that your bodies are the members of Christ?" God views our bodies as members of Christ. God views us as joined to Christ. In God's eyes we are joined to Him who knew not sin. We are the bride of Christ. We are joined as one flesh (see Gen. 2:24).

In verse 15, Paul uses the pronoun, I, in asking if he shall make the members of Christ into the members of a harlot. There is only one individual member of Christ (Paul, himself) that Paul could possibly join with one flesh to a harlot. The apostle recoils from the very thought: "God forbid." In verse 12, Paul stated that all things were lawful to him. Paul (and all who are joined in the body of Christ) are made free of the law. The law does not apply to fornication because we are not governed by the law. We are not governed; we are bound as one to Him who is without sin. We are not independent of Christ. All who are saved are joined to the Lord in one Spirit (v. 17). The Holy Spirit cannot be divided. Paul could not divide the Spirit that bound him to Christ and we cannot divide the one Spirit that joins us to Him. Every sin is a sin which is outside of the body (outside of Christ). Fornication, while outside the body, is a sin which joins that which is pure to that which is not pure. It is a sin against one's own body.

Paul implores the Corinthians (and us) to flee fornication for this reason. Fornication is a sin against that which God shall raise up. It is a sin against the temple of the Holy Ghost. It is a sin against the temple that houses the Holy Spirit which is given of God. It is a sin which is against that was purchased with a price. It is a sin which is against that which was purchased by God's love. It is a sin against that which was purchased upon the cross of Calvary. It is a sin which joins in one flesh that which was purchased by God to that which is impure.

We, like the Corinthians, need be mindful of the fullness of the price of our purchase. We, like the Corinthians, were purchased for a price. We are not our own. We are called to glorify God in body and in spirit. We are called to glorify God with that which He has purchased and that which He has given. In his epistle to the Romans, Paul was moved to write: "I beseech you therefore, brethren, by the mercies of god, that ye present your bodies a living sacrifice, holy, acceptable

unto God, which is your reasonable service" (Rom. 12:1). Let us do what is expedient. Let us do our reasonable service.
