Council Meeting **Goes Overtime**

Hurricane City Food Truck Friday Event **Returns to Hurricane Gazebo**

The June Hurricane City Council meeting was brought to order by Colton Brown, an autistic 11-year-old, hammering the gavel for Mayor Scott Edwards. Colton was given the honor of opening the meeting because his grandma, Carrie Varney Huff, contacted Edwards earlier this spring and suggested that the City conduct a First Responder Meet & Greet for kids with autism. Edwards liked the idea and has a Meet & Greet scheduled at the Fire Station on Thursday, June 9. The Mayor said that the Meet & Greet will become an annual event that will be held during April (National Autism Awareness Month) Hurricane in future years.


Following the call to order, Council recognized Hurricane High School junior Lily Haught for her performance at this year's State Track and Field Meet in Charleston. She won both the 100-meter and 300-meter hurdle races.

The Monday, June 6 meeting was much longer than most monthly meetings. The session was extended by public comment concerning a request for a variance to operate a business in a residence at 1113 Fieldcrest Drive and a rezoning request for property Avenue.

Council determined The Mayor also noted that

variance to operate a spa from her home. Wolfe's neighbors, testifying in support of the variance, stated that the deeds to their respective properties made no mention of a protective covenant which would preclude Council from granting the variance. There is, however, a protective covenant which would forbid a business to operate from a residence which applies to a different section of the Moss Creek Subdivision of which Fieldcrest Drive is a part, which section was developed at a later date than was Fieldcrest Drive. The matter is slated to be reconsidered at the July council meeting.

Council rejected the recommendation of the Planning Commission to rezone the Montana Avenue property from R-1 to R-2. Multi-family structures are allowed in R-2 zones but not in R-1 zones. The Planning Commission recommended rezoning after viewing proposed plans for the multi-family dwellings. A number of residents expressed concern that the rezoning would result in increased traffic and water runoff problems. Mayor Edwards stated that R-2 zoning is more restrictive in that on-street parking is not allowed. Edwards said that water runoff plans located at 2509 Montana must be approved before any construction can begin. originally was composed

the house builder of early Hurricane. His mother was Henrietta A. Ellis Wise, a descendant of one of the Putnam County's first residents. Fred, later as a young boy, adopted the middle name Eugene.

Fred Wise, through most of his formative years, was without a mother, Henrietta having died in 1904 from cancer while the Maggie and Fred Wise are: family lived at Diamond in Lloyd H. Wise, presently Kanawha County. He had at Milton, West Virginia; a few years schooling in Frances Lorraine Wise Putnam County Schools, Paxton, presently but went to work with his father at about thirteen years of age, as a carpenter and cabinet maker. David Wise and Fred Wise built many houses in and around Hurricane, as well as many other types of structures. At one time in 1917, Fred Wise owned three houses in Hurricane, two of which were on Putnam Avenue. Fred Wise built houses, barns, store buildings, churches, banks, and school buildings. He built these and other types of buildings from Hurricane to Logan and from Huntington to Montgomery. For a time his family lived in South Charleston, where he was employed on construction at the Union Carbide Plant, and later, at the Naval Ordinance Plant. At the time of the Great Depression, he maintained his own construction company which went under as did many other small and large companies. In 1916, Fred Wise Maggie met Morris Harshbarger while he and his father were building a house just below Milton, West Virginia, and they married in November of that year. They moved immediately to Hurricane where they began their married life together in one of Fred's houses on Putnam Avenue. The small cottage is still standing today (1987). At this place their first child Lloyd Hale Wise was born in 1917. During the Depression, Fred sold

Other communities in which the Fred Wise family lived include: St. Albans, Brushton, Montgomery, Milton, East Bank, Marmet and Kenova. His four children all graduated from East Bank High School.



his being called to deliver God's messages to Judah and to all men.

The seraphim are in the presence of God and continually declare His holiness and His glory. Isaiah may not have understood the details of what he was shown but one thing that he certainly understood was that he was in the presence of God Almighty and that he was unworthy to view the things that he beheld. Isaiah's reaction was: "Woe is me!" Isaiah confessed that he was a man of unclean lips and that he dwelled in the midst of a people of unclean lips. No man can look upon God and live. Isaiah fully expected to die.

The unexpected happened. One of the seraphim flew to Isaiah with a coal from the altar where burnt offerings were offered up to the Lord. The coal speaks of the sacrifice which was offered for sin. An innocent animal had been sacrificed for Isaiah's sin. The seraphim touched the coal to Isaiah's lips and announced that his sins were forgiven. The prophet deserved death but received mercy instead. It was by the grace of God that the animal sacrifice was counted sufficient to take away sin and satisfy the death penalty.

The picture presented to Isaiah and us is easy to understand. Isaiah's sin was great but the grace of God is greater. The seraphim's action demonstrated this truth to Isaiah and to us. God wants men to know that His grace is sufficient for all whom come to Him in repentance.

Isaiah stated: "I heard the voice of the Lord" (v. 8). In verse 4, Isaiah reported that the doorposts shook and the house was filled with smoke when the Lord spoke. What a difference! Before his sin was taken away, Isaiah knew that the Lord was speaking but he did not hear what was said. The house was filled with smoke. Isaiah could not see clearly or comprehend the words of the Lord until his sins were removed.

Isaiah heard the Lord ask: "Whom shall I send, and who will go for us?" When the seraphim touched the coal to Isaiah's lips, his lips were purified. It was with purified lips that Isaiah responded, "Here am I; send me."

Today, men are called to the Lord's service in similar manner. The preliminaries are the same. One must recognize his unworthiness before God —even realize that one is deserving of death. One must then realize and accept that his death penalty has been served by Christ Jesus. One must partake of the coal from the altar of sacrifice. Then, and only then, can one listen with a pure heart and receive the plan that God has for him. One cannot hear until one is cleansed.

Isaiah was to "go" and to "tell". The Lord's instruction to us is the same — "Go ye therefore, and teach all nations, baptizing them in the name of the Father, and of the Son, and of the Holy Ghost" (Matt. 28:19). Isaiah did not purify himself. God did! Isaiah confessed his sin and let God do the rest. God empowered Isaiah to hear His voice. God empowers each and every believer with the Comforter, the indwelling Holy Spirit. New Testament believers are vessels the Spirit that speaks to and convicts the lost.

The live coal that touched Isaiah's lips was on the altar waiting to purify him before he confessed. God commended His love toward Isaiah (and us) in that Christ died for us while we were yet sinners (Rom. 5:8). Let us confess such that His Spirit might always lead, guide and direct.



West Virginia Attorney to be certified or to be Division at 800-368-8808, General Patrick Morrisey is warning consumers to be cautious when responding to offers to become secret or mystery shoppers.

Mystery shopping endeavor. A company will offer you the opportunity to shop at your favorite stores and get paid for it. However, scammers have learned to take advantage of people's desire to be part of such a venture.

shopping "Mystery can be a valid way to make some extra money," Attorney General Morrisey said. "But consumers need to have their wits about them or they can get ripped off.'

Real secret shopper opportunities can be found through the mystery shopping trade group, Mystery Shopping Association. Providers Scammers, however. will set up fake websites, post newspaper ads, and use emails to convince consumers that the money is free and easy.

Typically, the fake mystery shopping company will send you a check to deposit and then ask you to "shop" for gift cards and send the company the cards or the PIN codes or ask the consumer to test a wire transfer service by sending the money to someone else. Then the check is identified as fake and the consumer is responsible for the money they spent. Or the fake mystery shopping company will want interested parties to pay a program fee
