## Cannon Appointed to Vacant House Seat

Jarred Cannon of Hurricane became the newest member of the West Virginia House of Delegates on Wednesday of last week. House Clerk Stephen Harrison administered the oath of office on June 15th. Gov. Justice appointed Cannon to fill the seat left vacant by the resignation of Joe Jeffries (R-Culloden). Jeffries announced earlier this month that he would be moving to Florida for employment reasons.

Jeffries was one of the two Republicans who represent the 22nd Delegate District. The district currently includes parts of Boone, Lincoln, Logan and Putnam counties. The portion of Putnam County in the 22nd District consists of precincts in the City of Hurricane and precincts south of Hurricane. These same precincts along with some precincts formerly in the 14th and 15th Delegate Districts make up the new 21st Delegate District.

Cannon defeated two other candidates in the May Primary to become the republican nominee for the 21st House of Delegate seat and his name will be on November General Election ballot.

Cannon is a 2016 graduate of Hurricane High School and a 2020 graduate of West Virginia University. He owns the public relations firm Athena Consulting, serves on the board of the Ohio-West Virginia Youth Leadership Association and also as an organizer for Camp Lincoln, a conservative youth program.

"I'd like to thank Governor Justice for his confidence in appointing me to represent the 22nd District in the House of Delegates," Cannon said. "It's an incredible honor and I am ready to get to work with the Governor and legislative leadership on day one to help make West Virginia the best place in the country to live, work, and raise a family."

Many people have unique stories about their cars. Thirty years ago, Kenny Lewis of Teays Valley rebuilt a 1935


Chevy, which he painted Copenhaegen Blue. He sold it after five years, but later regretted his decision. He tracked the vehicle down, and bought it back in 2016.

## Winfield High Student Is \$160,000 Scholarship Recipient

Each and every year, MetroNews awards a four-year scholarship that includes tuition, fees, room, and board for undergraduate study at West Virginia Wesleyan College in Buckhannon to a West Virginia high school junior. On Wednesday, June 15, MetroNews announced via radio station WCHS that Brayton Boggs of Winfield High School is this year's winner. Boggs will enroll at Wesleyan in the fall 2023 semester. His scholarship is for four consecutive years and will terminate at the end of the fourth consecutive school year. The total estimated value of Boggs' scholarship is \$160,000.

MetroNews promises applicants that they will have the chance to win their dream. To win that dream, applicants must

submit transcripts and test scores and are subjected to a screening process which includes answering essay questions and being interviewed. One of the essay questions Boggs had to answer was what he would like to contribute to the state of West Virginia. Boggs told MetroNews that he forwent this year's prom to answer this question. The application period began February 15th and ended April 30th.

Boggs stated that he plans to contribute through political involvement or by pursuing law career following college.

West Virginia Wesleyan Interim President James Moore said, "We have students here who want to go to law school and become doctors. They want to change the world. "We've got health

care challenges in this state. We've got a teacher shortage we have to solve. We've got access to higher education issues all around the region and Wesleyan needs to be apart of those solutions. We can lead the way in so many ways," he said.

In 1988, The Centennial History of Hurricane, Putnam County, West Virginia area. According to a descendant, Emily Agnes (Young) Tincher, daughter of Joseph "Weep" Young and Rosa Ann (Robinson), Jacob was born August 26, 1790. He married first Nancy Stephenson. He married second at age seventy to Cynthia Higgenbotham on May 21, 1869. Jacob's home stood on the James River and Kanawha Turnpike (on what now is U.S. 60) at Sams Fork and Snag Creek.

## West Virginia Maple Syrup Production

The West Virginia Department of Agriculture (WVDA) has released the 2022 maple syrup production numbers for the State. Production totaled 13,000 gallons in 2022, unchanged from the previous year. The number of taps, 77,000, and yield per tap, 0.169 gallons, were unchanged as well. On average, the maple syrup season opened on February 6 and closed on March 12, with the average season length coming in at 34 days. The first date of recorded sap collection was January 10 and the last day was April 20.

"Weather remains a key factor for how successful our maple seasons end up. If it is too warm, it can severely hinder the sap's flow resulting in lower production levels," said Commissioner of Agriculture Kent Leonhardt. "We are happy to see continued syrup production from our producers. Their effort helps us reach our goal of making West Virginia a cornucopia of specialty products."

The average price per gallon was \$47.70 in 2021, up from \$30.20 per gallon in 2020. Bulk prices in 2021 were \$2.50 per pound, up from \$1.90 per pound in 2020, and \$27.60 per gallon, up from \$21.00 per gallon the previous year. Percent of sales by type in 2021 was 50% bulk, 41% retail and 9% wholesale.

United States maple syrup production in 2022 totaled 5.03 million gallons, up 35% from the previous season. The number of taps totaled 14.3 million and yield per tap was 0.352 gallon. On average, the season lasted 34 days, compared with 27 days in 2021. The 2021 United States average price per gallon was \$35.90, up \$3.90 from 2020. Value of production came in at \$134 million for 2021.

said most students who applied expressed interest in moving West Virginia forward. Waltz said the scholarship isn't solely based on academics. # Defenders of the Save Women's Sports Law Celebrate Upcoming 50th Anniversary of Title IX

WV Attorney General Patrick Morrisey, State Del. Margitta Mazzocchi, Lainey Armistead, West Virginia University women's soccer alumna, and Christiana Kiefer, an attorney with Alliance Defending Freedom, on Tuesday, June 21, gathered at the State Capitol to celebrate and commemorate the upcoming 50th anniversary of Title IX's guarantee of equality in women's sports.

Title IX was signed into law on June 23, 1972. It prohibits sex-based discrimination in any school or any other education program that receives funding from the federal government.

"The impact of this law on women's sports has been profound. Before the law, just one in 27 young women played sports—

today that figure is two in five," Attorney General Morrisey said. "This short and simple law demands that girls and women get their fair share of opportunities in Education and Title IX's regulations made it clear that this could be accomplished in school athletic programs by having 'separate teams for members of each sex' where the teams are based on competitive skill and for contact sports."

Among the speakers in Tuesday's news conference were State Del. Margitta Mazzocchi and Lainey Armistead, West Virginia State University women's soccer alumna.

Attorney General Morrisey also updated the media on the state's fight to protect women's sports. He argued that the case

Lewis Tackett deeded to Jacob R. Young 100 acres land there.

By his first wife, Jacob had nine children:

1. James Young, born September 15, 1811. He married Rebecca Stephenson on July 27, 1839.

2. John Valley Young, born 1813. He married Paulina Franklin on January 18, 1840. He died on November 13, 1867.

3. Alexander Young, born 1815. He married Sarah Ann Stephenson. He died on December 2, 1871.

4. Margaret Young, born 1816. She married James Cyrus in 1839. She died on November 24, 1866.

5. Lewis Norman Young, born July 29, 1820. He married America Hart, who died on May 15, 1899.

6. Malinda young, born 1821. She married John Prouse on January 29, 1850.

7. Sarah A. Young, born August 10, 1825. She married Thomas Sims February 23, 1847.

8. Samuel Early Young, born July 26, 1826. She married Moriah Hart on February 12, 1852. He died April 27, 1918.

9. Nancy Young, born July 26, 1828/9. She married Van Buren Stephenson on January 21, 1857. She died in 1867.

Jacob and Nancy's son, Alexander Young and his wife, Sarah Ann (Stephenson) built their home where the Alexander Young Cemetery sets now. Old Jacob deeded 25 A

land to Alexander in 1840. That tract lay on the north side of U.S. 60 and west of Coal Mountain. Later Jacob deeded two more tracts to Alexander: One was 50 acres; the other was 25 acres.

Alexander and Sarah (Stephenson) Young also had nine children:

1. James L. Young, born 1843. He married Mary Frances Henderson on June 1, 1863. James L. died on July 2, 1874.

2. Nancy A. Young, born 1843. She died of consumption on February 27, 1867, single.

3. William Leftrich Young, born 1895. He married Mary F. Brown.

4. Amanda J. Young, born 1847. She died on June 13, 1871, single.

5. Madison Young, born 1849. He died on November ca. 1872/73 of tuberculosis, single.

6. John W. Young, born October, 1853. He died on November 30, 1854.

7. Benjamin F. Young, born August 27, 1855. He died at age fifteen.

8. Emily F. Young, born April 24, 1857. He married April 9, 1883. He died ca. 1925/26.

9. David Stephenson Young, born December 24, 1859. He married February 17, 1892, in Summersville, Nicholas County, West Virginia. He died ca. 1945/46.

was about basic fairness for female athletes and needs to be upheld.

"This is about fairness for women's sports, plain and simple," Attorney General Morrisey said.

On April 28, 2021, West Virginia enacted H.B. 3293, which was designed to maintain the integrity of girls' and women's sports in both secondary and postsecondary public schools. This was in furtherance of Title IX's efforts to promote athletic opportunities for female athletes.

On May 26, 2021, the ACLU and Cooley, LLP filed a lawsuit on behalf of a Bridgeport middle schooler seeking to invalidate this law and open up girls





sports to male athletes who identify as female athletes. The Attorney General, on behalf of the State, intervened and asserted the law protects female athletes' safety and keeps female sports competitive for female athletes, consistent with Title IX and

the Constitution.

The parties in the lawsuit have filed motions for summary judgment but the judge has not ruled on those motions. If the case is not resolved through those motions, a trial is scheduled for four days beginning on July 26.

"Opportunities for girls and women on the field are precious," Attorney General Morrisey said. "We must honor and defend the success of Title IX to guarantee its benefits flow to the generations of girls and women to come."



## BASIC BIBLE

### The Service of Godly Leaders

Ezra 6:13-22

The book of Ezra is an historical account of events which transpired between 538 B.C. and 458 B.C. The text before us most likely took place in 516 B.C. The completion and dedication of the temple is an event that was prophesied by Zechariah. Unlike incidents in which the keeping of God's promises require His direct intervention as in the release of the children of Israel from Egypt and their preservation in the desert for forty years, the rebuilding of the temple did not involve a miracle. It could be argued that the rebuilding of the temple is an event that could have happened with or without input from God. The fact is, however, is that God knows the future and chose to make the future known through the prophet Zechariah. Zechariah stated that the temple would be rebuilt in Zerubbabel's time and under Zerubbabel's direction (Zech 4:9). The Lord of yesterday is the Lord of today.

One can look at the prophecy which was fulfilled in the twentieth century and argue that the events could have just happened. The most significant event of the 20th century is not the advent of undreamed of technologies or the world wars and cold war which have shaped the present political boundaries. The most significant event of the century is the advent of the Jewish nation in the land which God promised to the seed of Abraham through Isaac. Israel's existence in the promised land like the rebuilding of the temple can be explained away by sceptics.

Looking at verse 14, we see that the Jews prospered during the prophesying of Haggai and Zechariah. Haggai told the people that prosperity had been withheld from them because they had put their material needs before their spiritual need. They had delayed in rebuilding the temple because of poor economic circumstances. By coincidence or divine design, the economy prospered after they set out to rebuild the temple. Virtually every fundamentalist Christian would declare that God's hand was evident in directing the rebuilding of the temple. The world may argue that Cyrus, Darius and Artaxerxes had a big role in making it happen. The world will also deny the word of God (Proverbs 21:1) which declares that the king's heart is in the hand of the Lord, as the rivers of water, God turns the king's heart in what manner he chooses.

Verse 15 states that the temple was completed in the sixth year of Darius. This is less than one third of the time that was required to complete the building under Solomon. Zerubbabel completed the task in a fraction of the time that the building of the original required and with far fewer resources than were available to Solomon.

A comparison of the sacrifice offered at the dedication of the original temple with the sacrifice offered when Zerubbabel completed the temple underscore just how few resources that Zerubbabel had. At the dedication of Solomon's temple 22,000 oxen and 120,000 sheep were sacrificed. The second dedication involved the sacrifice of one hundred bullocks, two hundred rams, four hundred lambs, and twelve he goats. Was it by coincidence that Zerubbabel was able to rebuild with less and more quickly than was Solomon able to do? Or do we see the hand of God who is the author of all history?

Similar questions can be asked of the unfolding of history in the 20th century. Was it by coincidence that Hitler's attempt to wipe out the Jewish people actually resulted in their establishment in the promised land? Was it coincidence that in World War II the Allies were able to produce a devise that could break an unbreakable enemy code?

In verses before us, temple worship is once again established. Temple worship ended with the destruction of the temple in A.D. 70. A look at the prophetic words of Jesus in Matthew 24 indicate that temple worship shall once again be in place in Jerusalem during the last days.

With the technology of today, the few would marvel at the rebuilding of the temple in Jerusalem in a fraction of the time that Zerubbabel required. Zerubbabel was able to do that which he did because the Lord "... turned the heart of the king of Assyria into them" (v. 13, 22).

The study of the verses before us confirm that God is the author of history. God's word has already recorded what is to come, but far too many fail to receive His message. Believers know Christ shall return and reign from the throne of David. We also know that there shall be a falling away from the faith that shall precede His return (II Thess. 2:3). Let us not be distressed or grow weary. Let us do as He has instructed. Let us declare His truth to others.
