City Gifted with Piece of Its Past

The Hurricane City Council meeting of July 5 commenced with Sandy Larch presenting the City with a special clock. The clock was taken from the Hurricane C&O Depot on Main Street when the structure was torn down in 1969. The clock was passed on from Sandy's grandfather to her father and then to her following his death in 2003.

Mayor Scott Edwards announced his plan for the clock's future. Edwards stated that he envisions converting the Fire Department on Main Street into a structure that will house a restaurant and two businesses. The building will be named The Depot and will serve as the home of the clock. The projected new home is about one hundred feet from the original Hurricane Depot.

Also prior to regular business, the City honored five high school students from Arts in Action. The students were inducted into The National Honor Society for Dance Arts in May. Claire Pifer, Kelsey Sherman, Miranda Stuart, Isabel Al Zoubi, and Olivia Jacobsen were named to the National Society because they achieved a high level of artistic merit, fulfilled hours of community service hours, and had a 3.6 or higher grade point average.

Council also recognized the State Champion Hurricane High School Boys and Girls Tennis Teams and the Hurricane High Bass Fishing Club which won the Bass Nation West Virginia High School Championship.

The Boys Tennis Team was undefeated in regular

season competition, Conference Champions and Regional Champions in addition to winning the State title. Individual State honors went to Jacob Smolder - All State Team, Curry Taylor - State Champion @ #3 Singles, Kellen Pauley and Elias Kave - State Champion @ #3 Doubles.


The Girls Team went 12-1 in the regular season, were Conference Champions and Regional Champions in addition to winning the State. Winning individual honors at the State Championship were Lexi Smolder - State Champion @ #1 Singles & All State Team, Katy Limanen - State Champion @ #2 Singles & All State Team, Savannah Allen - State Champion @ #3 Singles, Lexi Smolder & Katy Limanen - State Champion @ #1 Doubles.

HHS Bass Fishing Club consists of Wesley Allen and Riley Hendricks. The two won the Bass Nation West Virginia High School Championship which took place on the Ohio River in Ravenswood. They received first place and the big fish with a total weight was 5.35 lbs. and big fish of 3.93 lbs. They will compete with other high school teams at the National Championship in Lake Hartwell, SC in August. Last year, around 250 boats competed in the National Championship.

Putnam Republican Seeking State GOP Vice-Chair

The West Virginia Republican Executive Committee will be selecting new leaders on July 30 in Charleston. Current GOP Chairman Mark Harris faces allegations of misbehavior and is not seeking reelection.

Ohio County Republican Executive Committee Chairwoman Elgine McArdle and Putnam County Republican Executive Committee Chairman Tony Hodge announced that they are running as a team for chair and vice-chair.

Hodge, a Hurricane

resident, told MetroNews that McArdle and he are going to bring respect to the leadership.

McArdle and Hodge have both served on the Rules and Bylaws committee and are well-versed in the management of the party. "I'm the current Bylaws chair, when she was the Bylaws chair she oversaw the biggest overhaul in 42 years of the party, and during our last meeting we passed some pretty big amendments as well," Hodge said.

Hodge said that he is not interested in running for the chair because it is not the right time. "I have young children and being a chair of a party is very demanding on your time. Anyone who knows me knows that my family is

first," Hodge said. Both Hodge and McArdle were delegates to the Republican National Convention in 2020.



DOH Gives November Date for Culvert Unplugging

High Water signs are posted to warn motorists of danger ahead. The high water sign 1.9 miles from the beginning of Hurricane Creek Road (State Route 19) has become a permanent fixture on the road. The sign is necessary because the culvert carrying runoff from the Old Orchard Manor area became totally plugged more than one year ago.

Before Friday (July 8, 2022), 24-hour, 7-days per week posting of high

water at the location was not necessary because a channel parallel to the stopped-up culvert had developed and was sufficient to accommodate the flow of the stream during rain-free periods.

The deluge which produced wide-spread flooding on Friday caused that channel to disappear. Water now flows continuously over the road, day and night.

A local resident complained to the DOH. The resident was told by the Hurricane DOH that November 9 has been set

for corrective action.

Currently, hundreds of drivers choose to drive through the flowing stream rather than take an alternate route. For some residents, an alternate route is more than twenty additional miles.

Editor's Note:

Beckett (1885-1960) and my mother, Lula Lawson Beckett (1889-1968) were also born in Putnam County near Hamlin, West Virginia. The mailing address, at that time, was Eggleton, West Virginia. My father, Ahas W. Beckett, was a farmer and a carpenter.

Blood drive safety

The Red Cross follows a high standard of safety and infection control. The Red Cross will continue to socially distance wherever

possible at blood drives, donation centers and facilities. While donors are no longer required to wear a face mask, individuals may choose to continue to wear a mask for any reason. The Red Cross will also adhere to more stringent face mask requirements per state and/or local guidance, or at the request of blood drive sponsors. Donors are asked to schedule an appointment prior to arriving at a drive.

How to donate blood

Simply download the American Red Cross Blood Donor App, visit RedCrossBlood.org, call 1-800-RED CROSS (1-800-733-2767) or enable the Blood Donor Skill on any Alexa Echo device to make an appointment or for more information. All blood types are needed to ensure a reliable supply for patients. A blood donor card or driver's license or two other forms of identification are required at check-in. Individuals who are 17 years of age in most states (16 with parental consent where allowed by state law), weigh at least 110 pounds and are in generally good health may be eligible to donate blood. High school students and other donors 18 years of age and younger also have to meet certain height and weight requirements.

Blood and platelet donors can save time at their next donation by using RapidPass® to complete their pre-donation reading and health history questionnaire online, on the day of their donation, before arriving at the blood drive. To get started, follow the instructions at RedCrossBlood.org/RapidPass or use the Blood Donor App.

Most folks like cornbread with their pinto beans... I like plain bread just as much... pinto beans and cornbread...

No one on this earth can make pinto beans like my mother did except Linda and her mom... Yes. Linda still makes them... When I visited WV, before the big C (Covid), she made them for me. She and Mother and her mom...

exceed the industry average increase. Skidmore said that the City will work with CAMC in an effort to reduce future costs.


Skidmore reported that the paving for the new Fire Department station and the paving of the parking area for the football field at Bridge Park is now one project and is expected to be completed in September. Skidmore said that the new Fire Department station is now slated to be complete by the end of February of 2023.

In business leftover from the June council meeting, the Council approved the recommendation of the Hurricane Planning Commission that a request for a variance to operate a business in a residence at 1113 Fieldcrest Drive be denied.

In other business, Council approved the annexation of 0.53 acres on U.S. 60 (the old Speedway property).

Council held the Second Reading of an edit to City Code Section 521.05 — Excrement. Prior to the edit, dogs were allowed to do on public property that which they were forbidden to do on private property. Dogs are now forbidden to dirty either public or private property.

Council approved the appointment of Dan Lauffer as the Citizen Representative to the

The following events happened on these dates in West Virginia history. To read more, go to e-WV: The West Virginia Encyclopedia at www.wvencyclopedia.org.
July 14, 1861: Union troops under Gen. Jacob

Cox drove Confederate militia and cavalry out of Barboursville during the Battle of Barboursville. Union forces remained in control of Barboursville for the remainder of the war.
July 15, 1988:

Interstate 64 was completed when the final section between Sam Black Church and the West Virginia Turnpike was opened to traffic.

July 16, 1869: Philanthropist Michael Late Benedum was born in Bridgeport. He made a fortune in the oil and gas business, but he is best remembered for the establishment of the Claude Worthington Benedum Foundation.

July 17, 1861: The Battle of Scary Creek took place in Putnam County. It was one of the earliest battles of the war and one of the first Confederate victories.

July 17, 1914: Singer Eleanor Steber was born in Wheeling. She made her debut with the Metropolitan Opera in 1940.


July 18, 1776: The Methodist bishop Francis Asbury first set foot in present West Virginia outside of Berkeley Springs. He worked extensively in what is now the Eastern Panhandle, preaching and lecturing almost every day, before continuing farther into western Virginia.

July 18, 1893: Spencer State Hospital opened. With its connected brick buildings, a quarter-mile in length, the hospital was sometimes referred to as the longest continuous brick building in America. Spencer State Hospital remained in operation until June 1989.

July 19, 1863: A Confederate raid led by Gen. John Morgan came to an end on Buffington Island, near Ravenswood. The Confederates were overtaken by federal troops, local militia, and three U.S. Navy gunboats.

July 19, 1946: Author Stephen Coonts was born in Morgantown. After graduating from West Virginia University and serving in the navy during the Vietnam War, Coonts became a best-selling action and adventure novelist with the 1986 publication of Flight of the Intruder.

Huntington, West Virginia, our son, David Lee Beckett, married Patty Durham. They have two sons, Christopher and Justin. Our daughter, Pamela Ellen Beckett, married Tim Stinespring. They have two daughter, Katlin and Emily. My brothers and sisters are Ruby Beckett Rappold (1910-1992), Clinton Beckett (1916), Alberta Beckett Henderson (1920), and Clyde Beckett (1922-1960).

My grandparents were William A. Beckett & Catherine Spurlock Beckett and Henry Lawson & Drucilla Hall Lawson. They lived on Harvey's Creek and Big Creek in Putnam County near Hamlin, West Virginia. They were tobacco growers and sold cattle along with other farm duties. My great grandfather, Ahas Beckett, was a shoe cobbler and made shoes and boots

for the soldiers. Some of the soldiers wanted their shoes to squeak when they walked so Great Granddad Beckett would put the slick sides of the leather together on soles which made them squeak.

The late "Uncle Tom Lawson" from Hurricane was my great uncle.

"M. L Beckett's Market" located on U. S. Route 60 and Sycamore Road was owned and operated by me and my family from 1955 until 1983. After retiring, we moved to Thompson Road, which is near the "old store location". I have many hobbies: gardening, fruit trees, turkey hunting and fishing. I am also active in I.O.O.F. 

- 3/4 cup evaporated 2% milk
- 3 tablespoons spicy brown mustard or Dijon mustard
- 3/4 teaspoon coarsely cracked black peppercorns
- 1/2 teaspoon all-purpose flour
- 4 boneless pork loin chops (1 1/4 pounds), cut 3/4-inch thick
- 1/4 teaspoon salt
- 1 tablespoon vegetable oil
- 1 teaspoon minced garlic
- 1/4 cup reduced-sodium chicken broth
- cooked noodles or rice (optional)
- chopped fresh parsley (optional)

In bowl, whisk milk, mustard, peppercorns and flour. Set aside. Pat pork chops dry with paper towels. Sprinkle both sides of chops with salt. In large nonstick skillet, heat oil over medium-high heat. Cook pork chops 3-4 minutes, or until browned. Turn and cook 3-4 minutes, or until thermometer inserted in thickest part of chops reads 145 F. Transfer chops to serving platter. Loosely cover with foil to keep warm.

Add garlic to drippings in skillet. Cook 15 seconds. Stir in broth. Cook, stirring constantly, until most liquid evaporates. Stir in milk mixture and any accumulated juices from cooked pork. Cook and stir until just boiling. Immediately remove from heat and spoon sauce over chops. Serve with noodles or rice, if desired. Garnish with parsley, if desired.





Habakkuk Praises God's Faithfulness

Habakkuk 2:1-5; 3:17-19

Habakkuk lived in a day in which wicked men ruled Judah. He saw sin go unpunished. He saw the righteous trodden down by the unrighteous. He saw God's law impugned.

When was this day? Scholars are uncertain but believe that it was just prior to or just after the reign of King Josiah. Josiah ruled from 641 BC to 610 BC.

The first two chapters of Habakkuk are a dialogue between the prophet and God. Proper understanding of the text before us requires a knowledge of the full exchange between Habakkuk and God.

Habakkuk was upset. He cried out to God seeking an answer (1:1-4). God answered. God would use the Chaldeans to bring judgment. The judgment would come in the form of a sudden, swift, overwhelming military force that would possess the land and take many captives. God told Habakkuk that the Chaldean king would wrongly attribute his victory to his god.

The prophet then questioned God's use of the ungodly Chaldeans to punish the more godly nation of Judah. After questioning the Lord, Habakkuk states, "... (I) will watch to see what he will say unto me, and what I shall answer when I am reproved."

Habakkuk voiced his concern that he will be subject to correction because he had challenged God. Instead of correction, God issues the command: "Write the vision, and make it plain upon tables, that he may run that readeth it." God does not want His answer hidden. He does not hide His ways from men. God rewards those who seek the truth by giving them the truth they seek.

God stated that there is an appointed time at which the things that He has declared shall come to be. Of this appointed time, God states, "though it tarry, wait for it; because it will surely come, it will not tarry." To men, God's appointed time will appear to be past due and perhaps an unkept promise, but to God, the appointed time shall come without delay.

In verse 4, there are two classes of people: the lifted up and the just. God identifies five characteristics of the lifted up in verse 5. They are drunkardness, pride, restlessness, greed, and power mongering. The Lord uses only one characteristic to describe the just. The just shall live by faith.

The lifted up are not just in God's eyes. They are motivated by indulgence, self image, unsatisfied needs, a desire for more, and a need to exalt themselves. These characteristics contrast sharply with the one characteristic of the just. The just live by faith — faith in God to fulfill His every promise.

In God's sight, men are either just or unjust. The unjust look to themselves, while the just look to God in faith. The unjust trust in their own works, while the just trust in God's works.

The just live by faith. Living by faith does not mean living a life devoid of works. Faith produces works. Christians profess to live by faith. Works which are generated by faith are of God. Works of the flesh are not of God.

In the closing verses of his book, Habakkuk reflects upon that which he has seen. He is distressed by that which would come. Jerusalem would fall to the king of the Chaldeans and the land of Judah would be left desolate. These things would happen, but, he would rejoice in the Lord.

Habakkuk had prayed for revival. God answered with a vision in which He communicated a double message: Remember what I have done and be reminded that My will shall be done.

God's answer was sufficient. Habakkuk declared, "I will joy in the God of my salvation."

Habakkuk could rejoice because he was confident of the God of his salvation. As an act of faith, the prophet cast his cares upon the one who cares for him.

Habakkuk could declare victory in God because he lived by faith. The prophet knew "God is my strength, and he will make my feet like hinds feet, and he will make me to walk upon mine high places." Habakkuk claimed the promises of God. Christians are called to demonstrate a similar faith. "If God be for us, who can be against us?" (Romans 8:31).

Let us live the living faith that God has freely given.

Historian Philip Hatfield to Speak on Local Union Soldier

Local historian Phillip Hatfield will be speaking on the Civil War service of Captain John Valley Young of Putnam County on Saturday, July 16. Hatfield has written a book about Young, which is entitled *Sacrifice All for the Union*. The talk will be held at 11 a.m. at the Hurricane City Hall. There will be a book signing afterwards.

The story of Captain John Valley Young personifies the body of rugged Union Army volunteers from West Virginia during the Civil War: highly resilient, stubbornly independent, and fiercely patriotic. Using Captain Young's wartime letters to his wife, Paulina Franklin Young, and his daughters, Sarah and Emily Young, along with his diary and numerous other original soldier accounts, this book reveals the experiences of a Union soldier and his family who were truly willing to "Sacrifice All for the Union."

Young, a farmer and Methodist-Episcopalian minister prior to the Civil War, during April 1861 raised a company of Union volunteers at the strongly pro-Southern village of Coalsmouth, Virginia, (modern St. Albans, West Virginia). He was adamantly opposed to slavery, yet often expressed a bitter ire at having to fight a violent civil war because his beloved nation had thus far failed to eradicate the awful practice. His company became Company G of the 13th West Virginia Infantry and was later transferred to the 11th West Virginia Infantry.

While he displayed an unshakeable desire to preserve the Union, Young's convictions were severely tested as he and his family faced constant dangers from guerillas and Confederate raids in the Kanawha Valley. Captain Young also participated in more than one hundred skirmishes and eleven major engagements in the bloody Shenandoah Valley, and at Petersburg, and Appomattox; more than any other Union officer from West Virginia. He died from tuberculosis in 1867, a sad irony after surviving some of the bloodiest battles of the Civil War.

"...Stand firm to the good old Cause. I have just come from Charleston, and found while there that there will be a change of Commanders in the Department of [West] Virginia. The authorities feel determined that we shall have protection. But if we cannot have better protection than we have had, the country is ruined. But I assure you there will be a change for the better. I don't know how you will get up to see me now. Well, we must bear it the best we can. Sacrifice All for the Union." - Captain John Valley Young, Letter to his wife, February 3, 1862
