SIXTY ACRES ADDED FOR COMMERCIAL DEVELOPMENT

County Commission Approves Rezoning

On Thursday, July 28, the Putnam County Commission voted to rezone 60 acres in Fraziers Bottom to C-2 (High Density Commercial). The property, owned by Linville Enterprises Golf, was previously zoned OPI (Office Park Industrial) and R-2 (Multi-Unit Residential).

The zoning change makes the 60 acres available for a wide variety of commercial usages that could affect abutting property which is zoned Residential.

Zoning change procedures require the County Commissioners to state specific reasons for their vote. Commissioner Brian Ellis stated that more land was needed for business development and the change would be for the betterment of the entire area. Commissioner Ron Foster said that the announcement of Nucor's decision to build a steel mill in Mason County has increased the need for more commercial property in Putnam County. Commission

president Andy Skidmore stated that commercial is the highest and best use of the property.

For Linville Enterprises Golf, the unanimous vote ended a process which began on February 28th of this year with the filing of the rezoning application. Nucor announced their intent to build the \$2.7 billion Mason County steel mill on January 12, 2022.

In other business, 911 Director Mikyle White informed the commission that a slip has occurred in the access road to the proposed 911 Tower site on the Kale property on U.S. 35 near the Putnam-Mason line. White stated that the commission had a choice of two unknowns — the cost of fixing the access road or the cost of building an access road to an alternative location off Plantation Road.

Jessie Parker of S&S Engineers told the commissioners that \$20,000 for core drilling would be necessary before the cost of slip correction could be determined. Parker stated that an access

City of Hurricane Responds to Kentucky Flood Disaster Needs

The City of Hurricane

Mobile Infrastructure August 1st, to assist the Response Team hit the town of Whitesburg, road at 10 a.m. on Monday, Kentucky, in its effort to

recover from devastating flooding. The response team is equipped with a 1,000 gallon water buffalo for potable water distribution and a dump truck, generators, and other equipment needed to make repairs and get the Whitesburg water treatment plant back up and running.

"Water lines are running free flowing everywhere. There's either no pressure or low pressure because

there are leaks everywhere. Our crew will go out, find those leaks, cap them off, and do whatever is needed," Hurricane Mayor Scott Edwards said. "They have cots, food, and lots of clothes as we are not sure how long they will be there."

The team consists of seven members of the City's utility department and two members of the street department. The City of Hurricane formed its Mobile Infrastructure Response Team in 2014 such that the City would be prepared to handle emergencies like the 2012 dorecho which left Hurricane without power for more than a week.

REV. WILLIAM HARRISON CURRY

William was the son of Thomas & Susanna Johnson Curry, and was born in Fayette County (now) West Virginia, April 11, 1846. His parents died in 1854 when he was 8 years old. He enlisted in the Civil War in September 1861, at the age of 15, serving in Company B—34th Battalion, Virginia, Volunteer Mounted Rifleman. He was a soldier on the Confederate side and participated in the battle at Blue Springs, Lynchburg, Martinsburg,

WVU Medicine celebrates West Virginia Donor Day

WVU Medicine was proud to join Donate Life West Virginia and organizations around the state in celebration of West Virginia Donor Day on Aug. 1. Hundreds of West Virginians are waiting for a life-saving organ transplant. Unfortunately, in West Virginia and across the country, there is a critical shortage of registered organ donors.

West Virginia Donor Day is celebrated on Aug. 1 each year in recognition of the eight lives that can be saved by one organ donor. With about 500 West Virginians and more than 100,000 individuals nationally on the transplant waiting list currently on the transplant waiting list, the need for more registered organ and tissue donors is a public health crisis — but it's one that can be changed.

"Organ donation is a powerful way to help others in the event of your death," Lynsey Biondi, M.D., WVU Medicine Transplantation physician director and kidney transplantation surgical director, said. "However, it's important to remember that organ donation isn't just an end-of-life decision, healthy people can also safely donate a kidney while they are still living."

On Donor Day, organizations across the state come together to support organ, eye, and tissue donation and help create a unifying moment across the state where everyone works together

to educate and encourage others to register as organ donors.

"Registering as an organ donor only takes a few minutes but can make a life-long impact on someone who has been waiting for a transplant," Mike Shullo, Pharm.D., WVU Medicine Transplant Alliance vice president, said. "Talk to your friends and loved ones about the choice to become an organ donor and make sure you are registered. These simple steps can make a difference in ensuring your organs can help someone."



Piedmont, Brandy Station and Gettysburg. In 1865, when the war was over, he returned to the area, purchased 272 acres of land, mostly woodland and farmland in the counties of Lincoln and Putnam near Big Creek, 6 miles north of Hamlin.

He became ordained into the ministry of the Baptist faith in 1870. He served as pastor at Trace Fork and Mt. Moriah churches. He was very sincere about his faith and was a constant reader of the Bible. He also had acquired a knowledge of carpentry and worked at this skill whenever he could.

There was a large area at the head of Big Creek that wasn't being served by any church. With .50 in his pocket, he proposed to a good friend that they take their letters and go to this area and start a church. Several others joined in when they heard about the project. The Central Big Creek Church was organized in 1897 and met in the school house until the church was finished in 1902.

The trees had to be cut and hauled by horse and wagon to the sawmill. After the lumber was cut it had to be planed by hand. Manpower and funds made progress slow. As soon as the church was completed, they then began to think of the pews and other needs for the inside.

When everything was completed, Rev. Curry served as the first pastor until 1909, without any pay. In 1909, they voted to pay him \$36.00 annually. He served 1897-1911, 1913-1918, and 1920-1922.

He built a pretty log home on Harvey's Creek, meanwhile and married Parthenia Lawrence, daughter of Charles B. & Sarah Jane Spurlock Lawrence. Parthenia was born in Boone County (now) West Virginia, April 28, 1851 and married Rev. Curry, September 8, 1869. They had nine children. Three died in infancy. Others were: Cora McGhee, Ben, Minnie Young, Charles Thomas, Martha Ellen and George Washington. The latter known as "Uncle Wash", and his wife, "Aunt Ellen" ran the Curry Hotel in Hurricane for many years. Parthenia died April 8, 1883.

In 1884, a beautiful stately young woman entered Rev. Curry's life. Isabelle Lawson was born March 12, 1863, and lived with her mother and dad at the head of Harvey's

Creek. Her parents, Joseph and Lucy Lawson also had three sons, Henry, Julian and Tom.

It, no doubt, was love at first sight since there was 17 years difference in their ages and only 9 years difference in Isabelle and Cora, the oldest living child. Responsibility for five children was indeed a challenge for Isabelle.

In the meantime, they grew to be almost self-supporting. Isabelle was a good manager, a good farmer, a good cook and a wonderful mother with a great sense of humor.

The orchard back on the hill, in its early days, furnished apples, cherries, peaches and pears. They had cows for milk and butter and lambs, chickens and turkeys for meat.

The large vegetable garden always supplied a bounty of vegetables to eat and can. The hillsides flourished with all kind of berries to be used for jams and jellies. Corn was raised for feed for the animals and also taken to the mill to be ground into meal. Wheat was ground at the mills into flour for bread.

There was a small gas well in the bottom that supplied free gas for heat, cooking and lights. They received a small check from the well each month also.

While there have not been any local emergencies which have resulted in outages like that of 2012, the Response Team assisted the City of Richwood in 2016 and the Town of Pine Grove (Wetzel County) in 2017. The visit to Whitesburg is the team's first out of state response.

Edwards stated, "While other communities have resources like Hurricane, we have the people who are eager and willing to volunteer to reach out to others."

Whitesburg, the county seat of Letcher County, had eight of the town's and sheriff department's cruisers destroyed in the flooding. The City of Hurricane donated a fully functioning cruiser which was recently retired from service to Whitesburg Police Department. The cruiser was delivered on Sunday and is now in service.

until they remarried. They continued to raise part of one family until they died during an epidemic. One grandson they raised until he was grown.

During the morning, Isabelle worked in the garden. As soon as dinner (noon) was over with, she changed her gingham garden bonnet to her dress black sateen bonnet. She would fill her little basket with goodies and go to call on a sick relative or neighbor.

Their home was now covered with siding to make it warmer. All beds were supplied with feather beds for Winter and straw ticks for Summer.

Rev. Curry was much in demand for special services. It was not unusual for him to be gone for 5 or 6 weeks at a time. When he returned many times he would receive a quilt, a ham, some small token but very little cash. He carried a pillow case under his saddle that he would have something to carry it in if he were given anything. If he got a little cash, he would make a point to stop by the grocery store and purchase some stick candy for the children. It

made no difference if some feathers stuck to it, they easily washed off and my it was so good!

The church at Central Big Creek is stronger now than ever. It has been kept up real well. It now has electricity, two furnaces and an addition for classrooms. A piano, hardwood floors, new pews and freshly painted walls are new additions. A picture of Rev. Curry hangs on the front wall. They have an active membership of 130.

Rev. Curry died August 28, 1926 at the age of 80.

Isabelle was a widow for 23 years. She continued to live on the farm with the oldest child, Laura. Laura sacrificed her dream of a life of her own to stay with her mother. Even though Isabelle spent her last years in blindness, she never lost her sense of humor and a concern for other people's needs. She died December 2, 1949.



- 1/2 cup seeded and chopped tomato
- 1/2 cup chopped zucchini
- 2 teaspoons olive oil
- 1/2 teaspoon ground cumin
- 1/8 teaspoon ground cayenne pepper
- 1 cup (4 ounces) shredded Monterey Jack cheese

Heat oven to broil.

Line large baking sheet or 18-by-13-by-1-inch baking pan with foil. Arrange tortillas in single layer on pan. Lightly spray tortillas with nonstick cooking spray. Broil about 5 inches from heat 4-6 minutes, or until beginning to brown on one side. Remove from broiler. Carefully turn tortillas over.

In medium bowl, stir yogurt, 1 teaspoon lime juice and garlic powder. Set aside. In another bowl, toss chicken, tomato, zucchini, remaining lime juice, olive oil, cumin and cayenne pepper.

Spread yogurt mixture on unbrowned sides of tortillas. Top with chicken mixture. Sprinkle with cheese. Broil about 5 inches from heat 2-3 minutes, or until hot and cheese melts. Serve immediately.

Senior Farmers Market Nutrition Program Vouchers Now Available

The West Virginia Department of Agriculture has announced Senior Farmers Market Nutrition Program (SFMNP) vouchers are available starting Tuesday, August 2. Vouchers are delivered to county senior citizens centers where they are distributed to eligible seniors. To qualify for the vouchers, you must be over the age of 60 and meet certain financial requirements.

"The issues we have experienced in West

Virginia are similar to what other programs are facing around the country. For the WVDA, it has been a struggle to find banking partners to handle the redemption and printing of the vouchers, but I am proud of our staff for working through these challenges to ensure the program continues," said Commissioner of Agriculture Kent Leonhardt. "We are already working towards a solution for next year."

Senior Farmers Market Nutrition Vouchers will be distributed to all 55 counties in West Virginia by the WVDA to county senior centers through the United States Department of Agriculture's program. Vouchers can be exchanged for fresh, nutritious, unprepared, locally grown fruits, vegetables, honey and herbs from participating farmers markets, roadside stands and community agriculture programs.

Jesus Heals Two Demoniacs

Matthew 8:23-34

The text before us consists of two pictures which reveal the Lord's authority over two very different entities. The first picture was revealed to the disciples; the second was revealed to both the disciples and the keepers of the swine. These two pictures, coupled with all that precedes it, steers the reader of Matthew's gospel to conclude that Jesus is the Christ, the Promised One. All that which is recorded in scripture has been placed there such that God's will may come to be.

Consider the first picture. "And, behold, there arose a great tempest in the sea, inasmuch that the ship was covered with the waves" (v. 24). The word "tempest" is the translation of the Greek word seismos which is translated as "earthquake" in other New Testament scripture. In the instance before us, the sea was disturbed greatly by natural forces as the ground is disturbed by natural forces during earthquakes. In this instance, the natural force that disturbed the waters of the Sea of Galilee would have been the wind. Sudden, violent storms have been recorded in modern times. The fact that Jesus rebuked the wind and the sea in the manner in which He did is revealing. He displayed His authority over the winds and the waves because God the Father wanted this authority which He gave to the Son to be known by them who followed Him. God the Father does not desire that men should be uncertain concerning His Son. The Lord reveals His power and authority such that believers might declare the truth with confidence. It is with boldness that believers are to proclaim that He is "... long-suffering to us-ward, not willing that any should perish, but that all should come to repentance" (II Pet. 3:9).

In verse 26, Jesus mildly rebukes His disciples with the question: "Why are ye fearful, O ye of little faith?" The answer to the question is blared out in its phrasing. The disciples were fearful because they possessed little faith.

In verse 25, the disciples awoke the Lord pleading: "Lord save us: we perish." The disciples called out to Jesus in desperation. They awoke the Lord expecting Him to do something. The something that they expected was not the something which they expected. The Lord rebuked the winds and the sea and there was great calm. They marvelled because the winds and the waves obeyed Him.

The scripture does not record the action that the disciples expected Jesus to take. The text before us reveals what God wants us to know. God the Father wants us to know that we are saved, not by what we may do, but, by what the Son has done. We, like the disciples, have cause to marvel because He has paid the price for our iniquities in full. We did nothing other than call upon Him believing that He could save us. He has quieted the waters; He has given us peace with the Father.

The second picture revealing the Lord's authority (v. 28-34) was witnessed first hand by the disciples and by the keepers of the herd of swine. Both audiences saw two demoniacs rush from a burial area with the intent that "no man might pass that way." The keepers of the swine would have likely witnessed the demoniacs wildly approach would-be passers-by on previous occasions. What they saw this time was different. Looking from afar, the keepers noted the interaction between Jesus and the demoniacs. They saw the wild behavior of the two suddenly quiet and the entire herd of swine plunge into the sea and drown. The keepers did not hear the words which came from the lips of the possessed.

The disciples heard the demons ask: "What have we to do with thee, Jesus, thou Son of God? art thou come hither to torment us before the time?" (v. 29). The disciples heard the request of the devils that they be allowed to enter into the herd of swine. And, the disciples heard Jesus say, "Go."

The disciples witnessed the acknowledgement by the devils of Jesus' authority over them. The disciples saw more than a herd of swine plunge into the sea and perish. The disciples witnessed that which God wanted them to witness. God wanted them to know that His Son possesses power over the demonic realm.

It is God's desire that those who follow His Son should declare the truth to unbelievers with confidence. The Father wants us to know that the gates of hell shall not prevail against His truth. Believers are empowered by the Son who is "the way, the truth, and the life" (Jn. 14:6).

Let us declare the Son in all that we do.
