## Putnam Sheriff's Action Catches Statewide Attention

Sometimes, the act of reporting news becomes the news. Such was the case last week when WCHS-TV reporter Bob Aaron was accosted while reporting on an announcement made by Putnam County Sheriff Bobbie Eggleton.

While videoing what appears to be abandoned or junked vehicles on Coal Mountain, off U.S. 60 for his report on Thursday, August 4th, Aaron was nearly run over by a flatbed wrecker, driven by a man who reportedly jerked the camera out of his hands, broke off the camera light and refused to return the camera until Putnam County sheriff's deputies were called to the scene. The wrecker operator was identified as Clayton Frank Kelley. Kelley, 61, faces battery and destruction of property charges.

The incident became statewide news the next day when WV MetroNews Talkline host Hoppy Kercheval interviewed Sheriff Eggleton. Metro News advertises that its radio stations reach nearly one million listeners statewide.

Eggleton told Kercheval that he requested Aaron to do a story on the crack down on abandoned cars which he had announced in a Facebook post. Eggleton said that his efforts to persuade people to get rid of apparently abandoned cars had produced some progress, but not enough. In his post, Eggleton stated that he was going to enforce state law and crack down on junk cars littering the county's roads and yards.

The state law to which the Sheriff referred is WV State Code §17-24A-3. The law states: "the enforcement agency may employ its own personnel, equipment and facilities or hire persons, equipment and facilities for the purpose of removing, preserving and storing abandoned motor vehicles, junked motor vehicles." The statute defines abandoned and junked vehicles to be those which are not being stored for the purpose of using its parts on other motor vehicles owned by the owner.

Eggleton told Talkline that he does not want to take possession of anyone's vehicle.

## Hurricane Infrastructure Response Team Completes Kentucky Flood Relief Mission

The City of Hurricane Mobile Infrastructure Response Team delivered manpower, equipment and much needed water to Whitesburg, Kentucky, last week.

The City of Hurricane crew of nine worked close to 80 hours between Monday, August 1st and Friday, August 5th. The team cleared roads, fixed water lines, and jetted out storm drains and sewer lines. The team had to build an entirely new road to Whitesburg's water tower because the existing road was destroyed in the flooding.

The team had to cap off about twenty broken lines before city's water service could be restored. Team leader Ronnie Woodall stated that it was necessary to refill Hurricane's 1,000 gallon water buffalo twice before limited service could be restored. Woodall said the only available potable water was in Prestonsburg, a one hour distance. The crew utilized the metal detectors, probe bars, and the City of Hurricane vac trailer in addition to Hurricane's water buffalo

## Meet Some of Hurricane's Oldest Families

In 1988, The Centennial History of Hurricane WV was published to commemorate the town's 100th anniversary. In 1994, the Centennial Committee published a follow up book which included family histories which were not submitted in time for the 1988 Centennial History. This week's selection is the 6th history from The Centennial History of Hurricane WV Continued — 1994.

THE DAVIS FAMILY

Randall Clay (Benny) Davis was born about 1911. I say "about" because there was no public record of his birth. A family friend took him in and cared for him after his mother died and "assumed" his age.

Except for short periods of time, he lived in, or near, Hurricane all his life (until he died February, 1983). One of these times was when he served in the Navy during World War II.

Benny married Ruby Wechselberger on December 7, 1929. From

## State Fair of West Virginia To Start Aug. 11

Gates are set to open for "Mountain Grown Fun" at the 97th Annual State Fair of West Virginia on Thursday, August 11, with gates opening at 9 AM and carnival rides at 11 AM. To celebrate the return of the state's largest multi-day event, catch opening day specials including \$8 gate admission and \$25 all-day ride passes.

"We have a great 10-days lined up and cannot wait to open the gates," CEO Kelly Collins stated. "Whether you are here for the rides, food, concerts, shopping or just plain fun – there is something for all ages to enjoy!"

The 2022 Concert Series features two sold-out concerts this year with Cody Johnson and special guest Randall King (8/11), as well as Zach Bryan and special guest Charles Wesley Godwin (8/18). Tickets are still available for the Buckin' B Bull Ride (8/12), Foreigner (8/13), Clay Walker and Tracy Byrd (8/14), Restless Road (8/15), Chris Tomlin (8/17), and Walker Hayes with special Guest Tigirlily (8/20). My eldest grand girl immediately texted all of us to tell us she sent it to NANA to count here steps... a lovely gift... I hooked it up and started. Wearing that little watch made it easier.


Despite Covid... and maybe because of Covid... I walked over 1900 miles in 2020... step by step by step... I was so happy, but I knew I could not do so many again... each step was painful... and sometimes I just did too many at a time...

For 2021, I set the goal at 1,500 again... Until March, I walked in Indianapolis... around the buildings... and inside to the videos... with Covid still raging, I did not want to go around others... I had been a recluse since March 2020... once a family member had Covid... before the vaccine, the others became so careful... it was not fun... I ended 2021 with 1,500

miles plus... after March, walking in Florida in the area of the condo and at the ocean... step by step... pain... I have lived with this pain since my 20's when Arthritis was first diagnosed... then add other disease... and so on and so on...

This year, I again set my goal of 1,500 miles, and I am on task. Now, living in this paradise with no severe weather, I do not use the cane... I probably should at times, but I don't go to the mall, inside restaurants, or inside churches (I still watch my church online)... so I just don't use it... I am always outside except at my little grocery and the little Dollar General... 1,500 miles... who would think? Who would imagine I walked 1,900 miles? No one who knows me...

I walk short spurts... six to seven times a day... yes, it is hot in the 90's with the heat index over 100... I still do it... one step at a time... if I don't walk around the complex, I go to the little park on the ocean with the trees... and my favorite place is the causeway... on the ocean... not the beach... it is fantastic there.

I drive a mile or so to the causeway... it is rocky... it is breezy... it is wonderful... there are other walkers, but they mostly walk on the concrete path... I prefer the dirt path along the water... the elderly men are fishing or in their little rowboats... there are kayaks... the motor boats are in the distance... the causeway is in Dunedin... I live on the border of Dunedin and Palm Harbor... when I am walking...

I look in the horizon and see Clearwater... in another direction, Honeymoon Island State Park, where we go to the beach... there is Dunedin... and to the other direction, Palm Harbor... beautiful... paradise... quiet... serene... and oh, the birds... the white ones with the long necks are my favorites... several of them love my yard at the condo... there are sea gulls... and little brown birds... it is a fantastic place to walk...

Benches are in abundance... I walk; I rest; I walk... the breeze keeps me cool enough... I go early in the morning, of course... before the crowds and tons of traffic... I love living here... I love the fact that I can get out every single day to walk... people here seem younger... slower

paced... almost everyone is riding a bike... even those older than I... not safe for me... If I were younger, I would have my roller skates on, like those on the concrete path... I would fly...

Walking is the best exercise... I enjoy it so much... yes, I depend on the electric heating pad... but that is a little thing... I am used to pain... it is to be endured... that is what we do... we keep going because we want to live our lives as long as we can, as healthy as we can be...

When I lived in WV, I liked to walk, but others would not leash their dogs... that is a danger to senior citizens... no matter how "friendly" the dog is or no matter how "he won't hurt you" is stated, the falls happen. I know... I have been there and done that... In Indiana and Florida, there have been no dogs running without a leash... it is safer for someone like me who falls easily... (The family has a dog, but he knows to be careful when I am at there house...)

I have to add here that the residents in the building where I lived in Indianapolis were amazed that this "old" lady would bundle up and go out in the cold... they didn't know I rushed back to that heating pad... LOL...

Walking is keeping me going... Dr. Smith, my wonderful, favorite doctor told me that walking was good for me. He saw me walking at the hospital in 1992, when he was Mother's doctor. (When I moved to South Carolina, I walked five miles a day...)

I have gone from five miles a day to four miles a day to sometimes three miles a day... but I average enough to meet my goal... because the way we were is the way we are now... always on the move.

I want to add, in this column, that I lived within walking distance of the mall in Greenwood/Indianapolis, Indiana, where there was a shooting recently. I have been going to that mall since my daughter moved to Greenwood in 1995 or before... the family and I have eaten many meals in that food court where the shooting took place... I have walked to that mall from my apartment... it made me so sad...

To my readers, vaccinate, continue to mask, and stay safe... Covid keeps hitting friends and family...





### Sweetpotato Wedge & Purple Cabbage Salad with Poppyseed Dressing

Servings: 4

2 North Carolina sweetpotatoes  
1/2 head purple cabbage  
1 tablespoon olive oil  
salt, to taste  
pepper, to taste  
6 tablespoons poppyseed dressing, divided  
1 tablespoon chopped parsley  
2 cups grape tomatoes, halved  
3 tablespoons feta cheese, crumbled



Preheat grill to 400 F.  
Scrub and wash sweetpotatoes. Cut each into six wedges. (If sweetpotatoes are long, consider cutting wedges in half.) Parboil sweetpotatoes 5 minutes, drain and cool 5 minutes.

Shred cabbage into thin slices.  
Toss sweetpotatoes with olive oil and salt and pepper, to taste.

Place sweetpotato wedges on grill perpendicular to grates over direct heat; grill about 3 minutes on each side, or until tender-crisp with grill marks on each side. Remove from grill and set aside.

In zip-top bag or large bowl, toss cabbage with 4 tablespoons poppyseed dressing until coated. Add parsley and tomatoes; toss.

To serve, place sweetpotato wedges on bed of dressed cabbage and drizzle with remaining poppyseed dressing then sprinkle with cheese.

Serve warm or cold.



### A Lame Man Healed

Acts 3:1-16

Peter and John went up into the temple (v. 1). This marks the first recorded visit by Peter and John to the temple following their being filled with the Holy Spirit at Pentecost. With the filling of the Spirit, Peter and John received understandings which they did not formerly possess and they were empowered to perform many wonders and signs (Acts 2:43).

It was the ninth hour, the hour of prayer. It was the time of the evening sacrifices, a time which might be viewed as an holy hour. It is a time which the most devote followers of Judaism might choose to go up to worship. It was also the time at which a man, lame from birth, was placed at an entrance to the temple such that he might receive alms of those who entered in.

The miraculous healing that followed is comparable to healings which Jesus performed. The gospels do not record many miracles of Jesus within Jerusalem. The gospel of John does record two such miracles of healing by Jesus (Jn. 5:1-9, 9:1-7). In John 14:12, Jesus said, "He that believeth on me, the works that I do shall he do also." Peter and John most certainly believed. The miracle recorded in verses 1-8 should be attributed to both the belief of Peter and John. Both Peter and John were filled with and empowered by the Holy Spirit. Both Peter and John fixed their eyes upon the lame man. Both believed on the Lord Jesus and were empowered. The miracle was a manifestation of their belief.

Peter commanded the man to rise up and walk in the name of Jesus Christ of Nazareth and the man did. Peter invoked the name of Jesus and declared Him to be the Messiah. God the Father caused the man's feet and ankle bones to receive strength. God responded to their faith.

The man walked, leaped and praised God and entered into the temple with Peter and John. "And all the people saw him walking and praising God" (v. 10). The people saw and wondered. Their wonderment set the stage for Peter to address all who had gathered for prayer at the temple. Peter had just healed a lame man in the name of Jesus Christ and the man continued to hold on to Peter in gratitude. The man who had never walked was well known to the people. They had passed by him daily as he asked for alms at the temple gate. The people now gathered about Peter and John in amazement.

When the people gathered about Peter wondering how that he was able to perform the miracle, Peter set them straight. Peter told them that they were looking at the wrong person. They should not be looking at him. They were not looking at that which was done by human power. They needed to look to the God of Abraham, Isaac and Jacob, the God of their fathers because He had glorified His Son Jesus. Peter declared Jesus Christ to them and many believed (see Acts 4:4).

The book of Acts records the acts of the apostles. Their acts are a recorded of what God did. Because God did what He did, a lame man who had never walked was made whole and about five thousand men repented and believed Jesus was the promised Messiah. God glorified His Son. Peter was the agent of God's choice to make His works known to men. God empowered Peter by producing a setting in which thousands were eager to hear his words. God gave Peter to words to say. Let us look at those words.

Peter declared Jesus to be the Holy One and the Just whom the people had rejected. There were some, perhaps many, who had called out to the Roman governor Pilate to release Barabus, a murderer, rather than release Jesus who had done no wrong. Peter stated that God raised Jesus from the dead and that "we" (Peter and John) were witnesses of His resurrection.

In verse 16, Peter stated that faith in the name of Jesus had made the lame man strong. Note that those gathered about Peter did not know God in the manner that Peter and John knew God. Peter and John knew the resurrected Jesus, the Holy One of Israel. The people did not know the Jesus whom that they had called for Pilate to execute. They had seen a miraculous healing but they did not know God the Father who gave His only begotten Son to die upon the cross in their place until after Peter declared Christ raised from the dead.

God reached out to those who had called for the release of Barabus by empowering Peter because He is not willing that any should perish. The people believed because they witnessed God's power in Peter. May the lost witness His power in us.

Aug. 11, 1844: Emanuel Willis Wilson was born at Harpers Ferry. He served as the seventh governor of West Virginia.

Aug. 11, 1994: The Canaan Valley National Wildlife Refuge became the 500th refuge in the National Wildlife Refuge system. It is one of the largest and most diverse freshwater wetland areas in central and southern Appalachia.

Aug. 12, 1937: Author Walter Dean Myers was born in Martinsburg. In January 2012, Myers was named the National Ambassador for Young People's Literature by the Library of Congress.

Aug. 12, 1997: The Wheeling-Pittsburgh Steel strike ended when 79 percent of the workers approved a new contract. A 10-month walkout by steelworkers at Wheeling-Pittsburgh Steel was the longest steel manufacturing strike on record when it concluded.

Aug. 13, 1900: Railroad mogul and founder of Huntington, Collis Potter Huntington, died. Raised in poverty, Huntington went west when gold was discovered in California. There he became rich, not from mining but by selling supplies to miners.

Aug. 13, 2018: The House of Delegates adopted articles of impeachment against all justices of the Supreme Court of Appeals.

Aug. 14, 1894: Entertainer Ada Beatrice Queen Victoria Louise Virginia "Bricktop" Smith was born at Alderson. She performed in Paris in the

1920s and opened her own club, called the Music Box, in 1926.

Aug. 14, 1943: Astronaut Jon Andrew McBride was born in Charleston. McBride became an astronaut in 1979 and piloted the space shuttle Challenger on an eight-day mission in 1984.

Aug. 15, 1906: The Niagara Movement began a five-day meeting at Storer College in Harpers Ferry. The organization was founded in 1905 by a group of African-American intellectuals, including W.E.B. DuBois.

Aug. 15, 1946: The first FM radio station in the state, WCFC of Beckley, began regular programming.

Aug. 16, 1851: William Hope "Coin" Harvey was

born in Buffalo, Putnam County. Harvey, a social reformer, was nominated for president of the United States by the Liberty Party in 1932.

Aug. 17, 1944: Staff Sergeant Stanley Bender earned the Medal of Honor in southern France. Bender rushed through intense machine gun fire and grenades, and knocked out two German machine guns with rifle fire. His actions inspired the rest of the company to take out a German roadblock, kill 37 enemy soldiers, and take 26 prisoners.

Aug. 17, 1976: The National Mine Health and Safety Academy opened at Beaver, near Beckley. The academy, located on an 80-acre campus, is the world's largest educational institution devoted solely to safety and health in mining.
