County Commission Nitro Antique Car Club Cruise-In Receives Valley Park, Benefits Kentucky Flood Victims Day Report Updates

The Thursday, August 11, Putnam County Commission meeting could be termed as routine business. The routine can be interesting and informative.

The meeting agenda included updates on the Putnam County Homecoming and financial updates from Parks & Recreation and from Day Report. The financial updates provide both a look at the workings of the two entities and an explanation of their operation.

Parks & Recreation Director Justin Williams informed the commissioners that Parks indebtedness was reduced from \$452,000 to \$314,000 during the last year. The indebtedness of Parks stems from a line of credit and expenses associated with the Commons building and the water slide.

Williams said that revenue from increased Conference Center bookings allowed the water slide loan to be retired. The two remaining loans are variable rate with 7-year and 9-year terms. Loan payment is largely dependent upon Conference Center and athletic field bookings. Williams reported that Wave pool revenue was diminished by rainy weather but should be sufficient to break even.

Wave pool operation is dependent upon life guard availability. Williams said that Parks employed close to 60 life guards this summer. The start up of schools has necessitated the closing of the pool on Monday

through Thursdays. The wave pool will remain open on Fridays, Saturdays and Sundays through the Labor Day holiday.

Williams reported that the barn at the park entrance was available for rental.

Williams stated that the current parking arrangement is inadequate and more parking space is needed for wave pool users. He informed the commissioners that removal of green space islands would allow for 50 more spaces. Williams said that his priorities for the coming year are loan reduction and increased parking.

Day Report Director Jamey Hunt told the commission that his agency's case load has increased dramatically since January, going from 60 to 77. Day Report reduces the need of the county to use the Regional Jail in Barboursville.

Hunt stated that his staff was at full strength and prepared to handle the increased number. Hunt reported that Day Report has been able to increase in-house services by employing a contract counselor. Hunt said after-hour counseling needs of individuals employed 8-4 can be met in-house.

Hunt said that Day Care has provide litter pick up as a community service. He stated that there were two pick ups in both Poca and Buffalo and three or four in Hurricane. Hunt reported that Day Care performed litter removal before, during, (Continued on Page 3)

HellaFit, Hurricane's newest fitness center, held its grand opening and ribbon cutting on Monday, August 15. The facility, which is located at 2704 Main Street, features boxing, weightlifting, and cardio classes.

HellaFit was started by trainer Jace Heller of Hurricane. He was the

owner of Boxing Fit behind Walmart, but he closed that facility to open up a new fitness center that would have more options. He worked on renovating the building, which was originally a feed store, for

two months, redoing the floors, painting the walls, and hanging up punching bags.

Hurricane Rush Hour Traffic Relief Countdown Has Begun

Mountaineer Contractors of Kingwood, West Virginia, submitted a low bid of \$1,448,588.06 to construct an additional lane between the intersection of State Route 19 with 34 and Lynn Street in Hurricane a long time ago. Mountaineer's bid

was accepted by the West Virginia Department of Highways in November, 2019 (before Covid-19 was known to exist).

Currently, each and every evening, Monday through Friday, traffic is backed up from the westbound I-64 Exit ramp to the intersection of 19 and 34, a distance of one half mile. When complete,

the additional lane will eliminate two traffic light stops for motorists seeking to reach Virginia Avenue via Lynn Street.

The construction will affect east and westbound traffic on State Route 34 as well as State Route 19 traffic. The project is slated to be completed in February, 2023.

The Centennial History of Hurricane

Meet Some of Hurricane's Oldest Families

In 1988, The Centennial History of Hurricane WV was published to commemorate the town's 100th anniversary. In 1994, the Centennial Committee published a follow up book which included family histories which were not submitted in time for the 1988 Centennial History. This week's selection is the 7th history from The Centennial History of Hurricane WV Continued — 1994.

James Duke was born about 1783 in Pennsylvania and died in 1867 in Missouri. He was married to Elizabeth Lephart who was born about 1790 in Pennsylvania and died October 29, 1867 in Missouri. They settled in Mason County (now a part of Putnam County) in 1829.

On November 16, 1836, a land grant for 185 acres on Charles Creek, the east branch of Mud River and Panther Lick Branch in Cabell County, (Continued on Page 5)

Poll Workers Needed For Fall Election

In preparation for the state's November 8th General Election, WV Secretary of State Mac Warner is asking registered voters to consider becoming a poll worker in their home county.

The U.S. Election Assistance Commission (EAC) has designated August 16th as National Poll Worker Recruitment Day. This day of action is meant to assist poll worker recruitment efforts in communities across the country. August 16th is a special time to draw the public's attention to the need for poll workers and how poll workers strengthen our democracy, inspire greater civic engagement and volunteerism, and help ensure free and fair elections.

"The State of West Virginia is pleased to join the EAC in asking interested individuals to consider becoming a poll worker," said Secretary

Warner. "Trained poll workers are an important part of the election process. In West Virginia, poll workers are paid for their service as well as for training."

Established in 2020 by the EAC, National Poll Worker Recruitment Day is a day of action with the goal of encouraging potential poll workers to volunteer to work on Election Day. Some poll workers are also used for early voting in person.

In West Virginia, executive committees nominate poll workers. When nominated poll workers "call off" for any reason, county clerks' offices must appoint alternates to fill the vacancies before Election Day. Poll workers must be registered to vote.

The Way We Were, The Way We Are

As schools open up... the boys are back in school... the youngest grand girl is in senior year/home school... the middle grand girl in senior year college near her home, the eldest grand girl enjoying her degree and working in NYC. School time... there is a hidden little college in WV that is a school where students can get an education... without going too much in debt. Glenville State... my

alma mater. When I was six, I decided I wanted to be a teacher, just like my first grade teacher, Mrs. Pauley. I made up my mind that year... as I grew, I wanted to be like Mrs. Davis, Miss Irwin, Mrs. Ellis... and then junior high... Mrs. Vaughn was my idol... and high school brought so many good teachers that I could not choose one... but I knew then, English would be the degree I would pursue... Mrs. Chapman was great... I would teach English.

After graduation, I attended WV State for a semester... because our family just did not have the money, I could not continue. I had worked during the summer at the state house, and I paid for my tuition... Mother bought the books... we could not go on like that, so I went back to work for the state. Through the years, I wanted to go back to college, but the money and the opportunity... I must add here that the children's father encouraged me to go, but I knew the cost would be too much while raising our family.

I was deliriously happy as a housewife and a mother... I did work part time jobs after the kids were in school. I worked from age fifteen, and I still work... tutoring online... however, I wanted to be a teacher.

Glenville State gave me the opportunity to fulfill that dream, and in 1994, I graduated as a teacher... thanks to the diligent staff at that school... loans, grants, scholarships... Dr. Craig Etchison did so much for me... it takes a village... that village worked to graduate students who would go into the world and make a difference.

I was never made to feel less at Glenville... I was poor... truly... I mean poor... The professors were some of the best... they cared about us... they knew us by name... we were not just numbers on a computer...

Glenville State is small enough that the buildings can be accessed by walking and/or bikes... one of my favorite buildings was, of course, the one housing my department... However, I did Psychology also... and that building had great professors who helped us.

The first year or so, I lived in Summersville, and I took classes at the extension... eventually, I moved to the campus in Glenville, became serious about a timeline... lived in apartments... graduated quickly...

I have gone back to Glenville only once since I graduated... walked those

streets... sat outside those buildings...my dream of becoming a teacher was fulfilled there... thanks to so many... I liked that college.

When students graduate in Putnam County from Hurricane High, my alma mater, this year, I hope that some of them, and other students, will consider Glenville State. Go there... work... study... enjoy... get to know the staff... come away with a degree for a career...

As soon as I graduated college, I started my five years of teaching in South Carolina because teaching jobs were few in WV... I also started on my Master's Degree a couple of years later... It took me until 2007 to finish that degree. I took classes at Georgetown U. in D.C., Clemson and other schools in South Carolina... a class from WVU... I finished my degree at Marshall U. on the hill... it took a long time because the classes I needed were not offered readily... that was a long time to work on another degree... However, I would suggest that others wanting to work on advanced degrees, consider going to the Marshall campus in South Charleston... small and great staff there also...

I took some classes toward a doctorate... I just got too old too fast... had to stop... my one regret, as far as my college years go...

WV has so many colleges... probably too many for the size of the state. I would like to see Glenville State graduate so many students that they have to expand. My advice is for parents and their kids to visit the campus, meet the professors... find a place to live... go there... enjoy... save money... and choose a graduate school that will complete them... I do believe that the medical school and law school one chooses is important...

I enjoyed my time at Glenville State... I made friends there... I had help... I learned... I became a teacher... I loved my career. It is sad that so many complain which puts students off from wanting to teach... teachers are hired for ten months of the year... the salary is not bad for ten months... the benefits are good... the holidays are great... the rewards are more than one could ever ask for. How could there be another job that is as rewarding as teaching? Every person has a teacher, at one time or another... perhaps Hurricane High needs to start a new club... one I was in long ago... Future Teachers of America... let us make this a career that students want to pursue because the way we were is the way we are... always learning... I have too many parents wanting me to teach their kids online... I only choose one at a time, and I take long breaks in between... HellaFit features stations for boxing, weight lifting, and exercise bikes for interval training. In the future, the center hopes to have both yoga and cycling classes, as well as a smoothie and protein shake bar. Children are welcome at the boxing and dance classes. "Families can exercise together," said Heller, relating that in one class there was a five-year-

old child, a middle aged person, and a seventy-year-old senior citizen. He says that it is his favorite thing to see families working out as a group.

Unlike many gyms, which offer monthly payment plans, HellaFit features weekly ones with the option to pause at any time. By downloading the GloFox app, members can register for classes, set up their plan, and skip days if they are going on vacation. The cost per week for an individual plan is \$20 for two classes; \$25 for three classes; and \$35 for unlimited classes. The partner plan, which can be used by spouses or friends, is \$52 for unlimited classes. The family plan is \$65 per week.


The commission granted Winfield Mayor Randy Barrett's request to provide funding for portable restrooms and power cords for Putnam County Homecoming activities on

Knead dough a few times then shape into 1-inch-tall circle. Cut circle into eight wedges. Transfer wedges onto baking sheet lined with parchment paper. Brush tops of biscuits generously with additional plant cream and sprinkle turbinado sugar on top.

Bake 10-12 minutes, rotating sheet halfway through baking. Biscuits should be golden brown. Cool before assembling.

Split each biscuit in half. Spoon strawberries over half of biscuits. Add dollop of whipped plant cream on top. Layer other biscuit halves on top followed by more strawberries and plant cream.



Virginia was issued to James Duke. It was signed by David Campbell, Esquire, Governor of Commonwealth Virginia in Richmond.

They lived there until 1856, when they accompanied a daughter, Hannah Reed to Missouri. James and Elizabeth Duke were parents of George Washington Duke. ne 1850 Putnam County census lists a child, Ann E. Duke, age 5, born in Virginia and resided with them.

George Washington Duke was born May 26, 1817 in Augusta County, Virginia and died July 11, 1895 in Hurricane, WV. On February 14, 1843 in Kanawha County, Virginia (now WV), he married Mary Hicken Ellis who was born November 6, 1820 in Kanawha County, Virginia, a daughter of Hiram and Jane (Tackett) Ellis.

On April 25, 1849, a land grant for 92 acres located on Panther Lick Creek, Putnam County, Virginia was issued to George Washington Duke. It was siPled by Joseph Johnson, Esquire, Governor of Commonwealth Virginia. In 1868, George Duke built a house on Panther Lick which stands today. Marie (Janey) Duke, wife of George's grandson, Alvin Sherman Duke, resides in the house.

George and Mary Duke were parents of Creed, Elizabeth Jane, Columbus, Nathaniel Vincent, John, Aurilla Wood, Alvin Hargis, James Madison, Sarah Frances, Mary Margaret and Charles Jackson Duke.

Creed was born October 4, 1843 and died

November 11, 1847.

Elizabeth Jane was born September 18, 1845.

Christopher Columbus was born May 13, 1847.

Nathaniel Vincent was born March 13, 1849. He resided is St. Louis, Missouri.

John was born March 7, 1853. He resided in Howell County, Missouri.

Aurilla Wood was born June 27, 1854 and married Joe Burton. She resided in Lincoln County, WV. They were parents of George, Brod and Ida Sabie Burton.

Alvin Hargriss was born March 2, 1856. He resided in Lincoln County, WV. He married Mary Ann Powell. They were parents of Emma Mabelle, James Russell, Arena Maude and Lula Jewell Duke.

James Madison was born January 20, 1858. He married Laura Powell.

They were parents of LaVora Wilson, John W., Effie Blanche, Esther, Nancy Vleera, Charles Grover, and Ethel Duke.

Sarah Frances was born June 5, 1860. She married Henry Clinton Thompson. They were parents of Heber Rufus and Marie Jean Thompson.

Mary Margaret was born October 5, 1861 and married Harry Wyant. They had one child, Goldie Wyant.

Charles Jackson was born August 6, 1864 in Putnam County, WV. He married Jettie Hughes on June 22, 1890. He died July 30, 1943 in Hurricane.

Ananias Heals Saul

Acts 9:10-20

The book of Acts is the history of the early church. The human author, Luke, was moved by the Holy Spirit to include accounts of the happenings which shaped the church's development. Acts 9:10-20 focuses upon a happening which resulted in the transformation of Saul from persecutor of the church to Saul, a preacher of Christ.

On the Damascus road, the Lord Jesus Christ told Saul to go into the city and he would be told what to do (v. 6). The future things which Saul (Paul) was told to do, he did. The Lord would speak directly to Paul and he would become the Apostle to the Gentiles.

In verse 10, the Lord spoke to Ananias in a vision which is related to us in verses 11 through 16. In the vision, the Lord instructed Ananias to go to specific house on a specific street and to inquire for Saul of Tarsus. The Lord then told Ananias the reason that he was to seek Saul. Saul had prayed and the Lord had revealed to him (Saul) in a vision that a man named Ananias would come to him and place his hand upon him such that he might receive his sight.

In Ananias' vision, Ananias witnessed his own reply to the Lord. Ananias testified that he had heard evil things concerning Saul — that he had heard of the many Christians that Saul had imprisoned and of the authority given to Saul to arrest Christians.

Still in the vision, the Lord told Ananias that Saul was a chosen vessel to bear His name to the Gentiles, kings, and the children of Israel. The Lord also told Ananias that Saul would suffer great things for His name's sake.

Ananias did as he was instructed. He went to the house and placed his hands upon Saul and explained why he had come. Paul (Saul) would later carry the gospel of Jesus Christ to many Jews and Gentiles.

There is only one Apostle Paul. Paul was greatly used by the Lord. He brought the gospel of Jesus Christ to Europe and he authored 13 New Testament epistles.

The text before us reveals the role of Ananias in paving Paul's path. The Lord spoke to Ananias in a vision. Ananias heard the Lord call out his name and he responded. His response, "Behold, I am here, Lord", projects a willingness to listen and a willingness to do. Ananias did not know what the Lord would ask of him or instruct him to do. There are no pre-conditions found in "Behold, I am here, Lord". One cannot say these words unless one fully trusts the Lord.

Ananias was ready to respond to whatever the Lord might ask. Ananias was powered by faith. He was ready to put God first. One becomes ready to put God first by letting God make it happen. Ananias was "a devout man according to the law" (Acts 22:12). Ananias trusted God. His trust resulted in faith and his faith produced works — devoutness.

While verses 13 and 14 may be viewed as Ananias questioning the Lord's instruction to go to Saul and to place his hands upon him, the Holy Spirit uses this scripture to reveal the character of the Lord God. In these verses, Ananias is not informing the Lord concerning Saul; Ananias is informing us that he knows of Saul's evil past. The Lord, in His response to Ananias' concerns, stated that Saul was His chosen vessel "to bear my name before the Gentiles" (v. 15). Saul's evil past was of no account. The past is past. It did not count against Saul and the past was to be of no concern to Ananias. Saul was a new creature in Christ. Ananias was called to accept Saul as the Lord accepted him. We, like Christ, are to regard our brothers and sisters as new creatures in Him. We know that Saul's past was of no account to Ananias because he went his way and entered the house and placed his hands upon Saul and addressed him as "brother Saul" (v. 17).

Verse 17 additionally records the words which Ananias spoke to Saul. He told him that the Lord Jesus who appeared to him on the Damascus road had sent him such that he might receive his sight and be filled with the Holy Ghost. Ananias' words were faith-building words because that which Christ revealed to Saul in vision, Ananias delivered in person. Saul came to know Christ on the road to Damascus as a giver of promises but through Ananias, he came to know the Lord as a keeper of promises.

Because Ananias did what he did, Saul's eyes were opened and he was baptized. Saul preached in the synagogues that Jesus is the Son of God.

Saul was chosen by God to be the Apostle to the Gentiles. God the Son used Ananias to make it happen.

All New Testament believers are called. Some are called to declare Christ and Him crucified and risen as Paul (Saul) did. Others are called to be instruments that the Lord uses to build faith in others as Ananias was used. All believers are called to be new creatures in Christ and to walk anew, leaving the evil of past things past. Let us so walk.
