Seven Putnam Schools Selected for Universal Free Lunch

Last week, the Putnam County Board of Education announced its free and reduced-priced meals policy. Children from families that are unable to pay full price for meals are eligible to participate in the National School Lunch Program, the School Breakfast Program, the Child and Adult Care Food Program for Afterschool Snacks/Supper Program, the Summer Food Service Program, and the Fresh Fruit and Vegetable Program.

The 2022-23 school year will be different in that the federal government has not approved free universal meal services for all students throughout the county as the government has during the last two years of the Pandemic. Seven Putnam schools, however, currently qualify to participate in meal benefits through the Community Eligibility Provision (CEP) program.

The CEP program is sponsored by the United States Department of Agriculture's Child Nutrition Meal Programs and provide free universal meal services to children in high-poverty areas.

Putnam's CEP schools for the 2022-23 school year are Buffalo Elementary, Confidence Elementary, Hometown Elementary, Lakeside Elementary, Poca Elementary, Poca Middle and Rock Branch Elementary.

Students enrolled at these schools will receive FREE school meals (one breakfast and one lunch at no cost each day throughout the school year). There is no need for parents to complete a meal application form to receive benefits for students at these schools. If students in the same household attend a school that was not

32nd annual Great Kanawha River Cleanup set for September 10th



Putnam County is much more than a bedroom community for Charleston and Huntington. The county is also home to some of the most productive soybean fields in the USA.

West Virginia is not a big producer of soybeans because the state lacks flat ground. The top soybean producing counties are

Jefferson and Berkeley in the eastern panhandle and Mason and Cabell along the Ohio River. The wide river bottoms along the Kanawha provide enough soybean acreage for Putnam to rank 5th in the state in production.

While West Virginia

soybean production ranks low nationally, the yield per acre is high, averaging more than 50 bushels per acre. USDA records between 2012 and 2018 reveal that West Virginia had the highest per acre soybean yield in the entire country in 2012.

E. R. AND RUTH H. EDDINS

E. R. and Ruth H. Eddins residence on Hodges Road off of Route 60, Route 3 - Box 219-A, Hurricane, West Virginia. This house was originally owned by Lewis Paul at the west end of Mynes Road at Route 60.

According to the Assessor's records in the Putnam County Court House, it was built in 1904. There were four rooms downstairs and two rooms upstairs and two porches. From all appearances, at the time city water became (Continued to Page 5)





Scott Depot Native Enters Class Of 2026 at the U.S. Naval Academy

Nicholas W. Lanham, a graduate of Winfield High School in Winfield, was inducted into the Naval Academy Class of 2026 on Thursday, June 30, and will begin six challenging weeks of basic midshipman training as part of Plebe Summer.

Approximately 1,200 candidates are selected each year for the Academy's "plebe" or freshman class, and each student is required to participate in Plebe Summer. Last year, the Naval Academy received over 16,000 applications for the Class of 2026.

During this time, plebes have no access to television, movies, the internet, and music and also have restricted access to cell phones. They are only permitted to make three calls during the six weeks of Plebe Summer.

The pressure and rigor of Plebe Summer is carefully designed to help plebes prepare for their first academic year at the Naval Academy and the four years of challenges that awaits them.

As the summer progresses, plebes rapidly assimilate basic skills in seamanship, navigation, damage control, sailing, and handling yard patrol craft. They also learn infantry drill and how to shoot 9mm pistols and M-16 rifles.

Other daily training sessions involve moral, mental, physical, and professional development and team-building skills. Activities include swimming, martial arts, basic rock climbing, and obstacle, endurance,

and confidence courses designed to develop physical, mental, and team-building skills. Forty hours are devoted to the instruction of infantry drill and five formal parades.

Founded in 1845, the U.S. Naval Academy today is a prestigious four-year service academy that prepares midshipmen morally, mentally, and physically to be professional officers in the naval service. More than 4,400 men and women representing every state in the U.S. and several foreign countries make up the student body, known as the Brigade of Midshipmen. Each year, approximately 1,200 young men and women are admitted to the Naval Academy's incoming class.

U.S. News and World Reports has recognized the Naval Academy as a top five undergraduate engineering school and a top 20 best liberal arts college. Midshipmen learn from military and civilian instructors and participate in intercollegiate varsity sports and extracurricular activities. They also study subjects such as leadership, ethics, small arms, drill, seamanship and navigation, tactics, naval engineering and weapons, and military law. Upon graduation, midshipmen earn a Bachelor of Science degree in a choice of 25 different subject majors and go on to serve at least five years of exciting and rewarding service as commissioned officers in the U.S. Navy or U.S. Marine Corps.

BASIC BIBLE

Miracles on Malta

Acts 28:1-10

The ship carrying Paul to Rome made an unscheduled stop (at least not scheduled by man) at the island of Melita when it ran aground upon a sand bar. In Acts 27, it was made known to Paul by an angelic vision that the ship was destined to wreck upon a certain island (Acts 27:26) and that he would eventually be brought before Caesar (27:24). The text before us reveals that which transpired on the island.

In verse 1, Paul and the others learned that the name of the certain island to be Melita. It had been the intent of the ship's crew to sail from Fair Havens to Phoenix on the isle of Crete, a distance of about 35 miles, and dock until the winter was past. The ship was blown off course and into the open sea before running aground on Melita, 450 miles away. The island is small (about 120 square miles) and is located 50 miles south of the island of Sicily.

The people of the island were described as barbarous. They were not barbarous in the sense of blood thirsty barbarians, but in the sense that the islanders were removed from the main culture of the Roman Empire. As a barbarous people, the natives of Melita were given to superstitions. On his missionary journeys Paul often spoke in the synagogues, declaring Jesus to be the Promised One of which the prophets spoke. There were no synagogues on Melita. There was no knowledge of the scriptures. God would use Paul to reach out to the natives of Melita but it would not initially involve the scriptures.

God used a venomous viper. Paul was introduced to the island dwellers as the prisoner who was bitten by the venomous viper. The snake that bit Paul was known to the natives. They knew that when one was bitten as Paul had been that his arm would swell and he would fall dead. They wrongly concluded that Paul was a murderer receiving his just reward. When Paul experienced no ill effect from the bite, their opinion changed. They thought him to be a god. Both their initial assumption and their ensuing conclusion reflected their superstitious views.

The chief man of the island, Publius, received Paul (and Luke, who traveled with Paul) and lodged them in his home. Paul, a lowly prisoner, was now Paul, the honored guest. Paul in his epistle to the Romans declared: "And we know that all things work together for good to them that love God, to them who are the called according to his purpose" (Rom. 8:28). God used something bad—the bite of a deadly viper—to work for good. God placed Paul in the home of the chief man of the island.

God's purpose in placing Paul in this home was not that Paul might enjoy the luxury of the setting. Paul was placed where he was placed so that men might know God through him. The house of Publius came to know Paul as one whom God had given the power to heal.

Verse 8 details Paul's testimony to the house of Publius. Paul entered into the room where the man lay and prayed. He then laid his hands upon him and he was miraculously healed. The house of Publius and the natives of the island now knew Paul, not as a god, but as one who called upon God.

They recognized Paul as one who had been given the power to heal. Many suffering with disease came to Paul seeking help and were healed.

It was characteristic of Paul to preach the gospel in all places and he most certainly would have done so while on Melita. There is, however, no record that Paul preached the gospel during his stay. The testimony that Luke recorded is that Paul received the ill, he prayed to God, he laid hands upon them, and they were healed. In short, Paul demonstrated the power of God and his dependency upon God.

The islanders came to Paul because they had a physical need to be healed. Before satisfying that need, Paul communicated through prayer that that power belonged to God. Paul's testimony was not of what Paul could do, but of what God does.

There is a message in Paul's giving that some need hear. Paul was not motivated by some need to feel good about himself. Paul's only motive was to share that which God had given him. In giving, one can give amiss. Paul did not give amiss. He gave, not of himself, but of that which he had received. He did not fail to communicate to a barbarous people that all that he had to give came from God.

The miracles on Malta did not just happen. The miracles were of God and were used by God such that men might know Him.

Increasingly, we, like Paul upon Melita, find ourselves in a barbarous world that does not know God. God has not changed. He would have all men know Him as Lord and Savior. Let us, like Paul, share and declare that which God has given us.

August 25, 1903: Soprano Susanne Fisher was born in Sutton. Fisher was the first West Virginian to sing at the Metropolitan Opera.

Aug. 25, 1921: Miners began to arrive at Blair Mountain near the border of Logan and Boone counties. Sheriff Don Chafin, a hated symbol of anti-unionism in southern West Virginia, met them with a combined force of deputies, mine guards, civilian volunteers, and others.

Aug. 25, 2000: The Robert C. Byrd Green Bank Telescope was dedicated. It is the world's largest fully steerable radio telescope.

Aug. 26, 1863: Union and Confederate forces collided in what became known as the Battle of White Sulphur Springs. The next morning, with ammunition nearly depleted, Union Gen. William Averell decided to retreat to his base without accomplishing any of his objectives.

Aug. 26, 1918: Mathematician Katherine Johnson was born in White Sulphur Springs. For 33 years, Johnson worked for NASA doing calculations for manned space flight, including the Apollo 11 moon landing. In 2015, she received the Presidential Medal of Freedom.



Volunteers Work to Make Shelter Dogs Adoptable

greater number of cats in the shelter at this time of year, but this year, the dog population is up. Many of these pets have been there for months. While the Putnam County Animal Shelter is a kill shelter, many times animals are not euthanized unless space to house them becomes limited. Finding these cats and dogs permanent homes is a critical matter.

Around six to eight loyal volunteers dedicate several hours a day to work and play with the animals. They try to make sure that each dog has time to exercise and socialize with both people and other dogs. There is a mile-long trail behind the shelter, and many volunteers enjoy taking the dogs on walks through the woods. "It is very therapeutic," says Brandy Adkins of Scott Depot, a volunteer. Many of the dogs are leash trained and enjoy going on walks.

Charlotte McClanahan, owner of Alpha and Omega Dog Training, comes by several times a week to work with the dogs.

In addition to the regular volunteers, high school students often come to the shelter to get credit for community service projects.

While many of the dogs in the shelter are

mixed breeds, there are also purebred dogs. Purebreds in the shelter right now include Walker Coonhounds, pit bulls, and a husky. The majority of dogs that are surrendered to the shelter are unneutered males. Little dogs usually get adopted faster than the larger ones.

To encourage adoption and make the process more affordable, businesses can sponsor an animal. The cost for sponsorship is \$40 for a dog and \$35 for a cat. When an animal is sponsored, customers can adopt it for free. Customers have to pay a deposit if the animal is not spayed or neutered, but this deposit will be returned when the customer gives the shelter proof that the animal has been sterilized.

The Putnam County Animal Shelter is located at 12908 Charleston Road in Red House.
