Hurricane High Buffalo Octoberfest Grad Named Marshall CFO Designed for Seasonal Fun

Marshall University President Brad D. Smith announced on October 5, that Matt Tidd will become Marshall's new Chief Financial Officer effective November 7th. Tidd is a graduate of Hurricane High School with graduate and undergraduate degrees from WVU. Tidd, a licensed certified public accountant, worked for Mylan Pharmaceuticals and Marriott International before joining WVU in 2017 as chief university budget officer.

"These experiences are critical as we navigate our next chapters at Marshall University. An agile and enterprising leader, Matt will be a significant and important addition to Marshall's administration."

Smith said Tidd's hiring comes after a national search. Marshall's chief financial officer provides leadership to multiple offices and services in the Finance Department ranging from managing the budget down to student financial aid.

In a personal note to Tidd, WVU President Gordon Gee wrote, "I received a note from Brad Smith, the President of Marshall, who says he has stolen you from (Continued on Page 3)

The Putnam County Animal Shelter held its first ever costume contest for pets and their owners this past Saturday, October 15. The event, which also featured a craft and vendor fair and flea market, was organized as a fundraiser for the shelter.

Categories for the costume contest included Best Former Shelter Pet, Scariest, Funniest, Most Original, and Group Costume. The shelter also hosted two Halloweenie dog races. One was open to wiener dogs only, and the other, called "I Want To Be A Weiner," was open to mixed breeds. In addition to the

costume contest and dog races, there were also fall-themed pet photographs, pumpkin decorating, animal pawprint artwork, homemade dog treats from Dog Barkery, and plenty of opportunities to interact with shelter pets.

A total of \$753 was raised for the animal shelter, and all those funds went to sponsor the adoption fees of all the dogs and seven of the available cats. This increases their chances of adoption, as the animals are free to adopt. Four dogs were adopted during the event.

Putnam County Juvenile Drug Court Celebrates 100th and 101st Graduates

The Putnam County Juvenile Drug Court held graduation ceremony for the 100th and 101st teens to complete the program at 5:30 p.m. on Thursday, October 13, in the Judicial Building in Winfield.

Supreme Court Chief Justice John Hutchison spoke at the event in courtroom of Putnam County Judge Phillip M. Stowers.

"I want to congratulate the Putnam County program for reaching this important milestone," said Chief Justice Hutchison.

"Juvenile drug courts make a huge difference in the lives of the participants, their families and their communities," said Chief Justice Hutchison. "Juvenile drug court participants come to court with their families, and their families are as much a part of the process as the other treatment team members. Stopping a teen's drug use and related criminal activity before

they become entrenched behaviors improves the odds that a teen will become a productive member of society."

"Presiding over a Juvenile Drug Court is the most rewarding work I do as a circuit judge," said Judge Stowers. "Juvenile drug courts decrease drug abuse among children and families; they increase the high school graduation rate; they increase the chance of a juvenile being successful long-term at life; and, most importantly, they decrease the chance of a juvenile being returned to court for a criminal charge after graduation."

The Putnam County Juvenile Drug Court began operating in February 2011. Since then, 207 teens have

participated, including 21 who are in the program now. Of the 207, 57 withdrew or did not finish the voluntary program, which is more than a 50 percent completion rate.

Only two youths have committed a crime within two years of graduation.

It costs about \$5,500 per participant to run the drug court, Judge Stowers said. That compares to \$100,000 to place a juvenile in a Department of Health and Human Resources (DHHR) placement or shelter for six to nine months.

"These kids stay home and get drug rehabilitation and counseling in the community," Judge Stowers said.

Meet Some of Hurricane's Oldest Families

In 1988, The Centennial History of Hurricane, WV was published to commemorate the town's 100th anniversary. In 1994, the Centennial Committee published a follow up book which included family histories which were not submitted in time for the 1988 Centennial History. This week's selection is the 16th history from The Centennial History of Hurricane WV Continued — 1994.

John T. Harbour was born 10, October, 1831, in Teays Valley, the oldest child of David Harbour Jr. and Elizabeth McCallister Harbour. His father died when he was only 19 years old leaving him to help his mother with the six young children.

John T. married 13, July, 1852, Adaliza Roberts born January, 1833, in Virginia, daughter of Thomas and Susan Petty Roberts. Adaliza died 30, April, 1903, at the home of her son, Thomas. She is buried (Continued on Page 3)



Tidd replaces Mark Robinson, who informed the university of his decision to retire by the end of 2022. Lamar University in Beaumont, Texas, announced in August that Robinson would be its new CFO, effective October 1st.

There, Robinson joins former Marshall University provost and now Lamar University President Jaime Taylor and former Marshall associate athletic director Jeff O'Malley, who is now serving as Lamar's athletic director.

"It is the community volunteers and local churches that have sustained the Putnam County Juvenile Drug Court. This local support, combined with the resources of the West Virginia Supreme Court of Appeals, the DHHR, the Bureau for Juvenile Services, Pretera Center and the National Youth Advocacy Program (NYAP) has allowed us to reach the goal of 100 graduates," Judge Stowers

said. "Reaching this milestone of 100 graduates was difficult to fathom more than a decade ago. The drug abuse crisis, overlaid with family drug use and poverty, fight us in

every case. This drug court treatment team has never given up despite these obstacles. It is because of this treatment team that this program has been a success," Judge Stowers said.

in Hurricane, possibly in what is known as Burton Cemetery where three of their infants are buried.

This cemetery was started by her father, Thomas Roberts. It is mentioned in his will when he wills the land to another daughter and son-in-law, John & Elizabeth Burton. John T. is possibly also buried there since he died 10, September, 1881, in Teays Valley.

There is record of ten children of John T. and Adaliza Harbour.

1. James M. Harbour born 1853, married Mary Susan Billups 27, April, 1872. They had four children before he disappeared at the young age of 25.

2. Charles W. Harbour born 3, December, 1854, died 15, July, 1877. He is possibly buried in Burton Cemetery.

3. Loutitia Harbour born 1856, married Peter Davis 24, October, 1873 in Gallia County, Ohio.

4. Thomas Marion Harbour born in 1858, died 1909. Married 3, October, 1881, Jennette Kirtley. They had two daughters. He had an uncle named Thomas Marion Harbour who was an outstanding citizen of Hurricane.

5. Black Moore Harbour born 1860, died 1936, married Virginia Chapman. They had several daughters and one son, Blackburn Harbour. Black and Virginia are buried on top of the hill on their family farm a few miles north of Hurricane.

6. Molly Harbour born 1863, died 1865.

Obedience in Offerings

Leviticus 22:17-25, 31-33

New Testament believers read God's instruction to the children of Israel with the help and guidance of the Holy Spirit who shall teach us all things (John 14:26). In the text before us, God gave Moses instruction concerning offerings which were to be offered up to Him by both the priests and the children of Israel. This instruction spells out that which is acceptable and that which is not acceptable to God.

In verses 18-21, four offerings are listed: offerings to satisfy vows, freewill offerings, burnt offerings, and peace offerings. A burnt offering is an integral part of votive (pertaining to vows), freewill, and peace offerings. When presenting a burnt offering, the sacrifice is totally burned upon the altar such that the smoke ascends as a sweet savor to God above. In both the votive and freewill offerings, the burnt offering is totally consumed. The difference between a votive and freewill offering is the motive which prompts the offering. A votive offering is the promised response to the fulfillment of a prayer. A freewill offering is given in anticipation of the fulfillment of a prayer request.

Verse 21 addresses a different kind of offering. The peace offering involves both a burnt offering that is totally consumed upon the altar and an offering that is consumed by the priests and by the giver of the offering. An animal sacrificed for a peace offering is divided. The fat and two kidneys are offered as a burnt offering to the Lord. The flesh of the sacrifice is divided between the priests and the offering giver. The breast and right thigh are consumed by the priests and the remainder by the giver (Lev. 7:31, 32). Leviticus 7:34 makes it clear that the priests' portion is given to them by the Lord. The entire sacrifice is offered to the Lord. The returning of a portion to the giver which is to be eaten by the giver signifies peace between God and the giver.

In verse 19, God specifies that the animal to be sacrificed, either a votive offering or a freewill offering, may be a bovine (beef), a sheep or a goat. The animal must be a male without blemish. An animal that is blemished in any way is not acceptable. That which is presented to God must be perfect because God is perfect. Anything less than perfect is not acceptable. A perfect animal is required for both offerings — offerings given because of vows and offerings given in anticipation of fulfilled requests. The acceptable offering is totally consumed upon the altar from where it ascends to God.

God's chosen people (the children of Israel) are required to present the same acceptable offering both for that which God has done and for that which God shall do. The same offering is required for both past fulfillment and future fulfillment. God is eternal. He is the great I AM. The same sacrifice is sufficient for both the past and the future.

New Testament believers know that God the Father has provided the perfect sacrifice for us. Jesus was and is without sin. He died upon the cross and ascended to the Father. His sacrifice is sufficient payment of both our past and future failings. It is by the Comforter that we know these things.

The peace offering involves three parties: God, the priests, and the giver. The same sacrifice is consumed by all three parties. The peace offering was to be consumed in the same day that it was given (Lev. 7:15). It is given for the present.

Note that the peace offering can also be given in recognition of that which God has done (votive — the past) and given in anticipation of that which God shall do (freewill — the future) [see v. 21]. It is by way of the peace offering that God's people enjoy their relationship with Him.

We, as New Testament believers, know that the same sacrifice which satisfied our past and future debts also is the Father's provision by which we may enjoy a privileged relationship with Him. Jesus is our peace offering.

Verse 23 would seem to be a contradiction in offering requirement of that stated in verse 20. It is not. The offering that satisfies past and future sin debt is the sacrifice without blemish. The peace offering is for the present, both the present today and the present of every tomorrow which shall come. The freewill peace offering is to be offered in future present days.

New Testament believers are of these future days. We are called to present our peace offering which is our bodies, holy and acceptable, to God as a living sacrifice as our reasonable service (Rom. 12:1). Our peace offering is not perfect — we have yet to receive a body like unto His (I Cor. 15:52).

New Testament believers of today are called to testify of His perfection. Let us be about our Father's business. Let us do that which is acceptable.

The following events happened on these dates in West Virginia history. To read more, go to e-WV: The West Virginia Encyclopedia at www.wvencyclopedia.org.

Oct. 20, 1990: The current USS West Virginia was commissioned. The USS West Virginia is an Ohio Class Trident ballistic missile submarine that is 560 feet long, 42 feet wide, and displaces 18,750 tons when submerged.

Oct. 21, 1865: Bishop Matthew Wesley Clair Sr. was born in Union. He was one of the first African-Americans elected as a bishop in the predominantly white Methodist Episcopal Church.

Smith was born in Beckley. In the 1964 gubernatorial primary Smith carried 53 of the state's 55 counties, receiving more votes than his three opponents combined.

Oct. 22, 1693: Lord Thomas Fairfax was born in Kent, England. He inherited five million acres in Virginia, land that included much of the present Eastern Panhandle of West Virginia.

Oct. 22, 1821: Collis P. Huntington was born in Harwinton, Connecticut. In 1869, Huntington purchased the Chesapeake & Ohio Railway and set about extending its tracks from Richmond across southern West Virginia to the Ohio River. There, in 1871, he established a new

city bearing his name.

Oct. 22, 1977: Construction of the New River Gorge Bridge was completed after three years of work. The New River Gorge Bridge in Fayette County is one of West Virginia's best-known landmarks. It is the third-highest bridge in the United States.

Oct. 23, 1943: German prisoners arrived at Camp Ashford in White Sulphur Springs. Built by the U.S. War Department, Camp Ashford was one of two camps in West Virginia that housed prisoners of war during World War II.

Oct. 24, 1929: Composer George Crumb was born in Charleston. In 1968, Crumb was awarded the Pulitzer Prize for "Echoes of Time and the River: Four Processionals for Orchestra."

Oct. 25, 1918: Athlete

Marshall "Biggie" Goldberg was born in Elkins. He led the Chicago Cardinals to the NFL championship in 1947, and was elected to the NFL Hall of Fame in 1958.

Oct. 25, 1951: Writer Denise Giardina was born in Bluefield and raised in neighboring McDowell County. She is best known as a novelist and also has a long history of community activism, including a run for governor.

Oct. 26, 1801: Jefferson County was established from a portion of Berkeley County by the Virginia General Assembly and named for Thomas Jefferson.

Oct. 26, 1934: Athlete Rodney Clark "Hot Rod" Hundley was born in Charleston. Hundley earned first team All-American recognition his senior year at West Virginia
