Amendment 2

November General Election is projected to be low. Reason — There is not a single statewide political contest. The only contests of national interest are the two seats in the U. S. House of Representatives. Despite the lack of interest, approximately 20 to 25% of West Virginia's registered voters will vote and each vote will count.

When the votes are counted, West Virginia's Congressional are expected to remain in Republican hands. Current projections have the GOP winning the U.S. House of Representatives nationally and possibly the Senate. Some look for the greatest Republican victory since 1920.

In 1920, West Virginia represented by fewer than six congressmen. All six candidates republican were elected. In 1922, the tables turned with voters electing four democrats and two republicans. West Virginia's representation House Representatives remained at six seats until 1962 when it dropped to five Representation fell to four seats in 1972, and then to three seats in 1992, and to just two seats this year.

There reasons (mostly employment opportunities) that state's population

decreases or increases. West Virginia has not kept The turnout for the pace with surrounding states because better employment opportunities exist elsewhere. Other states have done a better job of making do with their resources than has West Virginia.

West Virginia's political clout was three times greater in 1920 representatives) than it is today. While both republicans and democrats promise more jobs, neither party has produced. Perhaps republicans deserve a pass since they were the minority party until 2014. While republicans and democrats, not actual jobs, are on the ballot, both parties receive a pass.

On November 8, voters will not receive a pass on job policy. Amendment 2 is all about jobs. If Amendment 2 is approved, personal property taxes on vehicles and property tax on business properties will disappear. If approved, all businesses in West Virginia will be on the same footing as businesses in other states. Amendment 2 eliminates the business franchise tax; the business personal property tax on equipment, machinery, vehicles, and inventory. Passage will promote job growth and foster a business environment which will make West

That Should Have Been **Printed 20 Years Ago** By Ron Allen

A Legal Advertisement

On Page 8 of this week's Breeze, readers will find a legal advertisement that should have been printed twenty or more years ago. The West Virginia Division of Highways is advertising that it has applied for a West Virginia National Water Pollution Control Permit. advertisement is required because construction of the I-64 Culloden Interchange is about to begin.

West Virginia Department of Highways purchased the necessary land for the Culloden Interchange more than 60 years ago. When plans for the construction of I-64 were unveiled in the late 1950's, there was no provision for a Hurricane exit. The only I-64 interchange serving Teays Valley would be Exit 9 (the current Exit 39). The first eight I-64 exits were all in Cabell County with Culloden designated as Exit


Hurricane businesses and Putnam politicians protested. Public meetings followed and the Culloden interchange was canceled. Hurricane Creek Road became Exit 8. All I-64 exits were renamed in the late 70's to that of the closest mile

Increased traffic proved

to be too great for the Hurricane exit. Access to and from State Route 34 required widening of State Route 19 to 5-lanes in the 1990's. Construction of a continuous right turn lane on to 34 and Lynn Street is ongoing and is slated for completion before spring.

While the new lane will help relieve Hurricane's rush hour woes, the Culloden interchange will prove to be a lasting answer.

In-person Early Voting Period Runs Through November 5

In-person early voting throughout West Virginia started Wednesday, October 26th, according to WV Secretary of State Mac Warner. Early voting will be available to eligible voters for ten days.

All 55 counties offer early voting for those eligible voters wanting to cast a ballot in person prior to Election Day. A registered voter can vote early at any early voting location in their county. According to Secretary

Warner, early voting runs from October 26th through Saturday, November 5th. The county courthouse or its annex in each county serves as an early voting location. Many of the state's counties also offer additional community voting locations. A complete list of community voting locations can be found at GoVoteWV.com, viewed on the Interactive Map for Voting Precincts and Districts at GoVoteWV. com, or by calling the local county clerk's office.

During weekdays, early voting will take place at the same time that the county's courthouse is open. On Saturdays, early voting locations will be open from 9:00 am to 5:00 Warner encourages

voters to check their registration status at GoVoteWV.com and

contact their county clerk with any questions before they go to vote. In addition, he encourages citizens to be educated voters before they cast a ballot. Sample Ballots for the November 8th General Election can be found at GoVoteWV.com. The General Election ballot also includes four constitutional amendments for voters to consider. A summary and full text of each amendment can also be found at GoVoteWV.com.

"The General Election is upon us, and thousands of registered West Virginia voters will vote early," Warner said. "We ask citizens to be mindful of our election laws and to report any irregularities that they may see or experience." Citizens are also asked

to report any possible irregularities or election fraud directly to the WV Secretary of State's Office or their County Clerk. Citizens can call 877-FRAUD-WV to make a report. They can also participate in the WVSOS "See Something, TEXT Something!' initiative. This allows a citizen to take a photo of a potential violation and text it directly to our investigations unit. To use the text-to-report technology, text "WV" to 45995.



2022 West Virginia Governor's Cup Marching Band Series Finals to Conclude at Marching Band Invitational The 2nd annual West Grand Champion Class В

Virginia Governor's Cup Marching Band Series Finals, sponsored by the West Virginia Department of Arts, Culture and History (WVDACH), conclude during 2022 West Virginia Marching Band Invitational (WVMBI) Championship on Saturday, Oct. 29, 2022, at Laidley Field, University of Charleston Stadium in Charleston

The series consisted of 12 local marching band competitions across the state, plus the WVMBI Championship. collected points by competing in at least four of the local competitions, along with the Virginia Marching Band Invitational Championship and Governor's Cup Series final on Oct. 29 to be eligible to win the overall Governor's Cup and more prize money. Forty-three bands competed in the series and are eligible to win prizes. The Governor's Cup final will award \$3,250 to the grand champion; \$2,000 to the 1st runner-up; \$1,000 to the 2nd runner-up; \$750 to the 3rd runner-up; and \$500 to the 4th runner-

The 2022 Governor's Cup Series helps promote the department's educational Save The Music Foundation program, which provides free musical instruments to middle schools throughout West Virginia and allows the department to distribute prize money to high school

bands. 'The WVDACH looks forward to the WVMBI each year and we are very excited about the second year of the Governor's Cup Series. Our hope is to continue awarding funds to help with success in promoting marching bands across the Mountain State," said WVDACH Curator Randall Reid-Smith. "We also are proud to continue our partnership with the Save The Music Foundation to provide instruments to middle schools across the state, which subsequently keeps students' involved in music and helps build band programs at the high school level."

For each Governor's Cup event, the grand champion received 5 points; 1st runnerup received 4 point; 2nd runner-up received 3 points; 3rd runner-up received 2 points; the 4th runner-up received 1 point; and 1 point for each class champion - A, B, C and D. The results from each of the 12 preliminary competitions and the final point tally going into the WVMBI Championship and Governor's Cup Finals are





Obedience in Feasts

Leviticus 23:33-43

The last of the seven feasts which the Lord instructed Moses to proclaim was the feast of tabernacles, also known as the feast of booths. This feast was to be observed in remembrance of the time in which Israel dwelled in temporary shelters (v. 43). This would be the forty years between the exodus of the children of Israel from Egypt and their crossing over Jordan into the promised land under the leadership of Joshua (Josh. 3:16, 17). Observance of this feast, like the feast of first fruits and the feast of weeks, would not take place in Moses' lifetime. In addition to serving as a remembrance to Israel's wandering in the wilderness for forty years, the feast was to be a celebration of the fall harvest (v. 39).

The nation of Israel was required to keep the seven feasts listed in Leviticus 23. New Testament believers are not under the law and do not keep these feasts. That is not to suggest that these seven feasts do not hold special meaning for New Testament Christians. The Holy Spirit moved the Apostle Paul to declare Christ to be our passover lamb (I Cor. 5:7) and Christ to be the first fruits of them who shall rise from the dead (I Cor. 15:20). New Testament saints most certainly will witness the keeping of the feast of booths in a future day. The prophet Zechariah proclaimed: "And it shall come to pass, that every one that is left of all the nations which come against Jerusalem shall even go up from year to year to worship the King, the Lord of hosts, and to keep the feast of tabernacles" (Zech. 14:16). Zechariah is speaking of Christ's yet future reign. New Testament saints shall be part of the Lord's administration during His one thousand year reign upon the throne of David in Jerusalem.

Because the seventh and final feast marks the completion of the last harvest of the year, it marks the beginning of a period of rest for the land. Rest, coupled with remembrance of years of wandering, is a picture of that which shall be realized when the Lord rules upon the throne of David in Jerusalem. Israel shall be at rest in the land which God promised Abraham.

If the feast of booths were to be reinstituted in the present day nation of Israel, the remembrance would not be for the forty years of wandering in the wilderness alone. It would also be in remembrance of the many, many years (almost two thousand) in which the sons of Abraham, Isaac and Jacob were separated from their home and found temporary shelter in foreign lands.

Because both the keeping of the first feast and the keeping of the last feast are pictures of future events (one fulfilled and one to be fulfilled) that are found in scripture, some New Testament believers look upon all the feasts of Leviticus 23 and see a larger picture of prophecy. Each feast involves the Lord Jesus Christ.

The prophecy of the first three feasts was fulfilled in the space of three days. Jesus is the passover lamb who was sacrificed such that men might enjoy a new and pure relationship (unleavened) with God. The certainty of man's new relationship with God was confirmed when Christ arose upon the third day to be the first fruits of them who shall rise from the dead.

The fourth feast, the feast of weeks, marks the falling of the Holy Spirit upon believers — an event which was dependent upon Christ's presence with the Father (see Jn. 15:26). The coming of the Comforter (the Holy Spirit) marked the beginning of the church (Acts 2:2-4). The church age shall end with the coming of the fifth feast, the feast of trumpets. When the trumpet sounds, the church will be taken up to be with Christ (I Cor. 15:52). The feast of trumpets is set by the beginning

of the seventh month (seven signifying completion). Following the removal of the church, Israel shall experience great tribulation that shall not end until the sixth feast. On the day of atonement Christ shall pour "the spirit of grace and supplications" upon Israel and Israel shall "look upon me whom they have pierced"

(Zech 12:10). As previously noted, the seventh and final feast coinsides with the Lord's reign from the throne of David in Jerusalem.

God moved Moses to record the seven feasts of the Lord in the manner that He did such that both Old and New Testament believers might be His testimony. The Lord shall return after He has finished preparing places for all who believe upon Him. New Testament believers are not called to sit and wait for the trumpet to sound. The harvest is not quite gathered. We are to declare His love until the end.
