HMS Teams Honored, HHS State Champion Recognized

Hurricane City Council chambers were filled on Monday, December 5, as the council honored Hurricane Middle School Tennis, Cross Country and Volleyball Teams for their outstanding seasons. The boys' and girls' tennis and cross country teams and the HMS Volleyball Team all won Mid Valley Athletic Conference (MVAC) championships.

Prior to congratulating the teams, Mayor Scott Edwards briefed parents and team supporters on the ongoing construction at Hurricane Bridge Park. Edwards said that the base for three ball fields is nearing completion but financing of the all-weather turf has yet to be worked out. Edwards also announced that the Street Scape project involving new sidewalks on Main Street has been completed and advised attendees that the City will be hosting horse and carriage rides on Saturday, December 17, from 4 to 7 p.m.

Mayor Edwards also presented a Certificate of Recognition to Hurricane

High sophomore Ty Steorts for his first place finish in the State High School Cross Country Meet. Ty is ranked top 10 nationally and is All-State and All-American.

In the regular business session, council held the first reading of an ordinance which will change the date of city elections. Current city officials were elected to four year terms in June of 2019. If the changes are approved at the next council meeting, mayor, recorder and council members will be elected to a three and one-half year term. When 2026 rolls around, the city election will coincide with the November General Election and city residents will vote at their regular precincts. From 2026 forward, city officials will be elected to four year terms.

Fire Chief Michael Hoffman informed council that his department has obtained grants of \$4,900 and \$5,945 for a portable fan and portable lights, respectively. Hoffman reported that the Annual Fire Department Boot

Putnam County Clerk Announces Likely Run for Secretary of State Office in 2024

Putnam County Clerk Brian Wood has announced that he is

likely to seek candidacy for the Republican nomination for Secretary of State in 2024. Wood made the announcement on radio station WCHS in Charleston on Thursday, December 1.

Wood said his decision depends on what current Secretary of State Mac Warner plans to do. Warner announced on November 29 that he is "giving every consideration" to running for governor in 2024.

Wood has served as Putnam County Clerk since January of 2004 and was reelected to a fourth six-year term in the November General Election. Wood will be running on his record of service to the county and service to all county clerks in the State in his capacity as the head of County Clerks Association.

Wood is well versed on the operation of the Secretary of State's office. The Secretary of State is tasked with numerous filings and charged with overseeing elections. As Putnam Clerk, he has 26 elections under his belt

and 25 years of clean audits with no critical findings. Wood said that he has received positive feedback from county clerks throughout the State since making his intentions known.

The First Baptist Church of Hurricane hosted their annual Christmas cantata on Sunday, December 11. The production, titled "I

Notice of Increase in Subscription Rates

The single copy cost of the Breeze is now 75¢ and effective January 1, 2023, the cost of print subscriptions will increase (excepting the Hurricane 25526 zip code).

It has become necessary to pass on the increased cost of mailing and printing the newspaper. There will be no increase in subscription cost to the OnLine Edition.

The new rates will be \$25 per year for all Putnam County addresses, \$40 per year for West Virginia addresses, and \$45 per year for out-of-state addresses. The \$20 per year rate for Hurricane (25526 zip code) will remain unchanged.

The steep \$10 per

year increase for out-of-county subscriptions is an adjustment which reflects the real cost of USPS mailings. The mailing rate to the closest out-of-county address (Culloden) is 5 times the Hurricane rate. Most in-county rates are twice the rate for Hurricane. Out-of-state rates range from 7 to 9 times that of Hurricane.

The per copy cost of distributing the Breeze to locations throughout the county remains greater than in-county mailing cost totals.

The OnLine Edition cost is \$2.50 per month (\$30 per year) and is available at hurricanebreezenews.com.

STEWART SIMS KIRTLEY (1871-1911)

Stewart Sims Kirtley, called "Simi" or "S.S." by family and friends, was born on Charleys Creek Putnam County, West Virginia, 25 April, 1871. Following the deaths of his father and mother, C.J.S. and Maggie Kirtley, Sim and his brother continued to live in the household of their grandparents, Jeremiah S. and Mary Elizabeth Matthews Kirtley.

The little boys make my days so great... they are ingenious... I laugh so much. They call this the "laughing condo"... one asked his dad why Nana laughs so much... because I am with loved

Prior to Jeremiah's death in 1883, he deeded over his land (300 acres "more or less" on Charleys Creek) to his wife...and in 1887 Mary Elizabeth Matthews Kirtley deeded the land as follows:

1887 — To Stuart Sims Kirtley "North one-half and M. O'Kee Kirtley" of 300 acres

1887 - To C.L Harbour (Kate "South one-half" Kirtley Harbour) of 300 acres

To the grandsons, thereby, was deeded their father's half of the family property; to her daughter Clarisse Lucinda Amanda (Kate) Kirtley Harbour, her rightful half of the property. Sim was at this time sixteen years old and Oak was twelve. Kate, her husband, Charles Harbour and their children were living in the family home, as well as the boys. Some friction arose between Sim and his Aunt Kate and Sim went to live with his grandmother's brother, Uncle John Matthews.

When Sim reached twenty-one, he deeded over his portion of the property to Kate (in 1893) and, in due course, when Oak reached legal adulthood in 1896, he did the same. Family lore relates that "the boys" sold their birthright for a saddle and a feather bed!!

Sim married Lutilla Alice Roberts, the youngest daughter of Captain Jones Roberts by his second marriage to Matilda Rachel Rowsey Jimison, 1 February, 1894, in Culloden, Cabell County, West Virginia. He clerked at various stores in

the Kanawha Valley and, eventually, Huntington. Children born to them were: Clairo Love (legally changed to Karl King) in 1894; Charles Roy Kirtley in 1896; Jewel Matthews Kirtley in 1901; and Gordon Stewart Kirtley in 1904.

The death of his brother, Oak, in 1910 was a terrible loss to Sim. He suffered from severe depression and died by his own hand 25 January, 1911. Alice Roberts Kirtley married Don Jamison in 1920, widowed in 1933. Affectionately known to her grandchildren as 'Grandma J', she was a much loved, devout Christian, who lived to be almost 90 years of age. (She, Sim and Oak are buried in the old Hurricane Cemetery, Hurricane, West Virginia).

*Mahlon Oak Kirtley (known as "Oak" or "Oakkie")

Epilogue

Although there are no Kirtleys of this line presently living in Hurricane or Putnam County, the roots are deep. Each May the cousins from Ashland, Kentucky and Dandridge, Tennessee, Charles R. Kirtley, Jr. and Gordon S. Kirtley, Jr. - and their families' journey "homeward", to Hurricane, to decorate the known family graves and to continue the search for the old family burial site. Some twenty-three Kirtleys, including Joseph and Elizabeth, Jeremiah S. and Mary Elizabeth, C.J.S. and Maggie, repose somewhere along Charleys Creek or in the county, fondly remembered - ALL!

Attorney General Morrissey Asks FCC to Put Anti-Robotext Protections in Place

West Virginia Attorney General Patrick Morrissey announced Monday this week his support of the Federal Communications Commission's proposal to help cut down on unwanted text messages by requiring mobile wireless providers to block texts from invalid, unassigned or unused numbers, and from numbers on a Do Not Originate (DNO) list.

"These texts and calls are not only annoying, they are used by bad actors to dupe people into different kinds of scams," Attorney General

Morrissey said. "The FCC's proposal, I believe, will quell these intrusions and stop scammers from taking advantage of consumers."

Attorneys general work to protect consumers in their states and have long been at the forefront of fighting to reduce the number of robocalls that plague Americans. But scammers are shifting to using robotexts to run the same scams.

Just like spam calls, spam texts are an irritation and can result in people losing millions through phishing texts, imposter

scams and links containing ransomware. In 2021, the FCC received more than 15,000 consumer complaints about unwanted texts and, in 2020, scammers stole more than \$86 million through frauds perpetrated via scam text messages.

The bipartisan coalition of 51 attorneys general support the FCC's proposal to require mobile wireless providers to block unlawful text messages at the network level if they originate from fraudulent numbers.

Further, the attorneys general are asking the FCC to continue pushing the wireless industry to develop call authentication technology for text messages so people can know if the texts they receive are from spoofed numbers and law enforcement can investigate where these texts are coming from.

Attorney General Morrissey joined his counterparts in 50 states and the District of Columbia in sending the letter to the FCC.

- 4 tablespoons butter, cut into 1/2-inch cubes

- 4 tablespoons butter
- 2 pounds Envy apples, cut into 1/4-inch slices
- 1/2 cup light brown sugar

- 1/8 teaspoon grated nutmeg

- 1 teaspoon vanilla
- 3 tablespoons flour

- 1 deep dish frozen pie shell

Preheat oven to 375 F.

To make streusel topping: Mix flour, chopped pecans and light brown sugar. Stir in butter using fingertips until incorporated with small lumps of butter visible. Refrigerate.

To make filling: In large skillet over medium heat, melt butter until amber, stirring often. Set aside to cool. In large bowl, stir sliced apples, brown sugar, cinnamon, nutmeg, salt, vanilla and flour using spatula. Pour brown butter over apples and mix, scraping skillet with rubber spatula to incorporate brown butter bits.

Place frozen pie shell on baking sheet. Add 2 cups apple mixture into shell, gently pressing apple slices for even base. Add remaining apple slices and gently press. Sprinkle streusel topping evenly over apples.

Bake 30 minutes then reduce oven temperature to 350 F and bake 35-45 minutes until topping is golden and apples feel tender when pierced with fork.



God's Promise of a Savior

Luke 1:26-38

The Holy Spirit moved Luke to record the purpose for which his gospel was written: that we might know with certainty of the things which we have been instructed concerning Christ (1:4). As believers read the verses before us, the still, quiet urgings of the Holy Spirit of God speaks and moves us toward the inescapable conclusion that Jesus is, indeed, the One promised from the beginning.

The angel Gabriel was sent to Nazareth (v. 26) — not the place which the scriptures declare that the Promised One should be born (see Micah 5:2); and not a place which one would expect to find many of the lineage of David (see II Sam. 7:12). The Lord chooses to do the unlikely. He chooses the weak to defeat the strong; He chooses the foolish things of the world to confound the wise (I Cor. 1:27).

The angel Gabriel spoke to Mary, a virgin, who was engaged to Joseph, a descendant of King David. Gabriel told Mary that she had been blessed and would conceive a son whose name would be JESUS. Jesus would be called the Son of the most High and would sit upon the throne of his father David.

The first thing which we note concerning Mary is that she was a virgin (v. 27). Seven hundred years earlier, the prophet Isaiah declared that a virgin should conceive (Isa. 7:14). Mary was the virgin of whom the prophet spoke. Christians of today are very familiar with Isaiah 7:14; it is a verse which often appears upon Bible verse Christmas cards. Far fewer Christians realize that the words of Isaiah 7:14 were a sign given to the wicked and unbelieving King Ahaz. The virgin birth was a sign given to an unbelieving king who would never see its fulfillment. Surely, God, in His omniscience, knew that the sign of the virgin birth would not be seen until a distant future time. Why such a sign to Ahaz? Ahaz represented not just himself, but all unbelievers. The virgin birth was a sign that would be given to an unbelieving world. Jesus' virgin birth is rejected by unbelievers of today and was rejected by the unbelievers of His day. The virgin birth is a sign of certainty only to them who believe. We can be confident that Jesus is the promised Messiah because He satisfies every requirement of God's word.

The mystery of Genesis 3:15 is resolved by the virgin birth. In this verse God states that the seed (a word of the masculine gender) of woman shall bruise the serpent's head. The word "seed" must have a masculine origin. In child birth, Eve bore the seed of Adam. Only one born of a virgin can be the promised seed of woman. Christ is the promised seed who would destroy the head (the power) of the serpent when He was bruised for our sins upon the cross.

Mary's child was to be called, "Jesus." This name means "Savior." This name was not selected, by Mary or her espoused husband Joseph; it was specified by Gabriel who stands in the very presence of God. The prophet Isaiah specified that the Messiah, the one born of a virgin, would be called Immanuel, meaning God with us. Gabriel, in stating that Jesus would be called the son of the Highest, identified Jesus as Immanuel.

Bible believers of the present day know that Jesus shall return to rule the world from the throne of David in Jerusalem after a seven year tribulation period. The first century Christians who read the gospel of Luke would have instantly realized that the One who was nailed to the cross at Calvary never sat upon the throne of David. How then can Gabriel's statement of verse 32 lead one to "know the certainty of those things, wherein thou hast been instructed" (1:4)? It would not unless early converts were taught from the start that Jesus would return to rule from the throne of David. Indeed, this is the case. The Apostle Paul found it necessary to correct the Thessalonians because they were sitting and waiting upon His return rather than presenting themselves as a living sacrifice, a reasonable service to their Savior.

Mary was overwhelmed and confused by Gabriel's greeting. She was even more perplexed when Gabriel informed her that she would conceive and bear a son. She asked, "How shall this be, seeing I know not a man?". Gabriel's answer can be paraphrased in five words: God will make it happen. With God, nothing is impossible.

God could have caused all of Isaiah's prophecies concerning the coming of His Son to be fulfilled without informing Mary of the role that she would fill. God sent Gabriel to deliver the message that the "holy thing" which Mary would bear would be of God and it "shall be called the Son of God" (v. 35) so that all believers might know with absolute certainty that Jesus is the Promised One. God desires that we be confident possessors of His truth.

It was for this cause that Gabriel announced to Mary that her cousin Elisabeth (her aged and barren cousin Elisabeth) was in the sixth month of pregnancy. Mary responded to Gabriel's message with the words, "... be it unto me according to thy word."

Mary then went with haste to Elisabeth. Elisabeth dwelled in a city of the hill country of Juda (v. 39). The hill country of Juda is 37 miles in length extending from Jerusalem to past Hebron in the south. It may have required a full week to travel from Nazareth to the city where Elisabeth lived.

Mary did not doubt the words which Gabriel delivered. She left in haste so that she might share the good news which Gabriel had delivered.

All believers are, like Mary, possessors of good news that the Lord would have us share. Let us boldly proclaim Christ to others.




