## It is 90 Seconds Before Midnight

As of Tuesday of this week the Doomsday Clock displayed a time of 90 seconds before midnight. The Doomsday Clock was invented in 1947 by the scientists who developed the atomic bomb. The clock was created to register the danger of mankind destroying himself and the planet in a nuclear war. The clock was set at seven minutes before midnight. Time on the clock was shortened to three minutes before midnight in 1949 when it was learned that the Soviet Union had detonated its first atomic bomb. It was shortened again to just two minutes when the Soviet Union conducted a successful test of a hydrogen bomb in 1953.

Since 1953, time on the clock has been shortened in response to events which could trigger the sudden reduction of human population and lengthened when events transpire that might delay sudden destruction. In total, the minute hand of the clock has been shifted 25 times. The most distant positioning of the minute hand from midnight was in 1991 when the clock registered 17 minutes from sudden doom. The event which caused the hand to be moved backward to 11:43 p.m. was the collapse of the Soviet Union.

Since 1991, the clock's hand has been moved forward some 10 times because additional nations have come to possess destructive technology, the failure of treaties to stem nuclear weapon development, the

development of biological weaponry, and the failure of nations to unite in a battle against climate change.

The current 11:58:30 positioning of the hand reflects the perception that the present danger of human self destruction is greater than at any previous point in the history of the clock.

Is the 90 seconds to midnight setting justified? Maybe, maybe not. The Bulletin of Atomic Scientists state the main reason for repositioning the clock's minute hand to be the Russia-Ukraine War coupled with bio-threats, nuclear proliferation, climate crisis, state-sponsored disinformation, and disruptive technology. All of these except climate change appears to be a valid reason to move the minute hand forward. Climate change has the potential reduce the habitability of the planet but not to destroy it come midnight.

The experts who set the hand of the Doomsday Clock believe that failure to reduce greenhouse gases is a measure of unwillingness to cooperate. Failure of nations to cooperate is seen as a stumbling block to the establishment of a world government which can restrain biological weapons, nuclear warheads, harmful disinformation, and cyber warfare. The experts believe that a one world government is the answer.

Only time will tell if the experts are right but I think it unwise to trust the creators of biological weapons, nuclear

## THIS WEEK IN THE HOUSE OF DELEGATES

For the week ending Jan. 20, 2023

Members of the West Virginia House of Delegates have passed five of its bills to the Senate for consideration, the first being House Bill 2526, which would gradually reduce the personal income tax by 50 percent over three consecutive years.

"It's a very safe plan," said House Finance Committee Vice Chairman John Hardy, R-Berkeley. "We're doing this with no tax shifting, which is very important."

The bill passed the full House Jan. 18 by a vote of 95-2.

A bill that passed the full House Thursday by a unanimous vote would leverage the state's position in the fast lane for digitally titling vehicles. House Bill 2506 allows the DMV to create a title clearinghouse for businesses not based in West Virginia.

"The bill takes advantage of that e-titling process, which we've heard in the committee has taken a 40-day process on paper to a four-day process," said House Technology and Infrastructure Committee Chairman Daniel Linville, R-Cabell. "The result of that makes West Virginia one of ... if not the fastest place in the country to title vehicles."

Linville said the titling fee is \$15 at a bare minimum, so the state road fund will

get a \$15 boost every time a non-resident business titles a vehicle in West Virginia.

"We heard in committee that there were more than potentially 9 million additional titles that could come through the state of West Virginia," he said. "If you do the math, this easily, within two years, could be \$100 million for the road fund."

The first full week of the regular session also saw the first completed legislation. Senate Bill 161 and Senate Bill 162 both go now to the executive for action.

Senate Bill 161 would allow the West Virginia Division of Natural Resources to sell, lease or dispose of any obsolete or unused property under its control. If the land is in a state park or state forest, the Legislature first would need to grant approval. Senate Bill 162 would allow the DNR to lease tiny pockets of underground open areas so energy producers who liquify the carbon they capture are able to pump it down into those spaces to keep carbon from being released into the atmosphere.

A total of 890 bills have been introduced in the House. The 60-day, regular legislative session ends at midnight March 11.

born July 1828. His older sisters had married soon after arriving in Putnam County, so running the farm was left to William, John, and the 2 slaves they had brought with them. Little is known of the male slave, but the female slave

(known as Aunt Viney) lived her life out on the farm. When the Civil War began, the sympathies and convictions of the Matthews family was with the Confederate States.

The slavery issue was not the main reason for their loyalty to the south. Like most Southerners, they resented the people up North telling them how to run their affairs and they certainly intended to defend their homes and families. John could not serve in the army as he only had vision in one eye, but he found other ways to serve. The Yankees stationed at Hurricane Bridge made periodic trips into the area during the course of the war to "forage" as they called it.

Mostly, that meant stealing anything they could use, and in some cases they burned the homes of suspected Confederate sympathizers. As a counter measure, some of the men in the area formed a group that became known as "Bushwhackers." They retaliated by going north of Hurricane Bridge (known as Yankee Country) and devising their own mischief. Also, at least two Yankee lieutenants never returned from foraging on Sycamore Creek - one was shot, one was hanged. Some of the bushwhackers became known to the Yankees and spent a lot of time hiding out. One of their hideouts was under a large rock overhang up the hollow from the Matthews home. John would further ensure their safety by keeping sheep sheltered at the opening and gave them such provisions as he could. For instance, when he milked the cows, he would take two buckets - one for the family and one for the bushwhackers.

He apparently was never suspected of giving aid to his friends, as the Yankees never bothered the family. Some say that the reason he wore such a long beard was because he swore never to shave until the Confederacy came back into power.

Grandpa John was a small man, about the same height as my Dad, five feet eight inches tall. He had dark hair and in the pictures we have of him, a long white beard. He was of Welsh descent.

I do not know how close Grandpa was to his children, but I do that my father, Bill, had a lot of respect for his father. Grandpa John had an old horse-hide trunk that was stored in one of the upstairs bedrooms. It contained his black suit, and a lot of old letters. The handwriting on the letters was stylish and beautiful, the ink faded to brown, and the subject of some of the letters referred to some activity of the state legislature. Unfortunately, the trunk has been lost.

John was 52 years old when he married Margaret Paul on August 14, 1880. She was 26 years old (b. 1854) and was the daughter of Joseph and Elizabeth Johnson Paul of Trace Fork, Putnam County. Grandma "Marg" did a lot to improve the house. She raised chickens and used the eggs as barter to obtain necessary household items. She was a noted weaver and made rugs and bedspreads. Her spinning wheel was always busy. The large brass bed in the front room was a gift to Grandma from my Dad. It had a huge, soft, fluffy "featherótick" mattress that was like sleeping on a pillow. Grandma was neat and clean about herself. She had a black silk dress for church and special occasions. On weekdays she wore a cotton dress covered by a large white apron. She was very religious and attended Sycamore Baptist Church. When she grew older and could not walk the distance to church, my cousin Virginia says that she must

Grandpa was active up to his last illness which occurred as a result of getting wet while riding his horse about the farm. He took a chill which developed into pneumonia and he died February 3, 1910, at age 81.

After Grandpa died, Grandma leased the field on a share-crop arrangement and I can remember Great Uncle Charles Tackett "dragging" the fields before planting tobacco. He would bring his grandsons, Waldo and Arnold with him and he would let all of us ride the drag.

Grandma Matthews died in February 1937,

just a month short of her 83rd birthday: A few days before she died, all of us in the family walked 7 miles from the hard road at Hurricane to Uncle Charlie Tacketts. He took us by wagon on to Grandma's house. We couldn't drive the car because of the cold and snow covered roads. In spite of the weather, the number of neighbors and friends who came to help, to stay through her illness, and sit with the family at the "wake", was truly amazing. It certainly showed the respect they had for "Aunt Marg" Matthews. She was buried in the Sycamore Cemetery beside Grandpa.




- 6 quarts water
- 16 ounces linguine or penne pasta
- 2 tablespoons unsalted butter
- 1/2 cup thinly sliced onion
- 1 cup thinly sliced carrots
- 1 cup thinly sliced sweet bell pepper
- 1/2 cup grape tomatoes, halved
- 1 teaspoon kosher salt
- 1/4 teaspoon black pepper
- 2 cloves garlic, peeled and minced
- 1 cup reserved pasta water
- 1 teaspoon finely grated lemon zest
- 1/2 cup smoked provolone cheese, shredded
- 1/4 cup chopped fresh parsley (optional)
- Parmesan cheese (optional)

Bring water to rolling boil and prepare pasta according to package directions for al dente texture, reserving 1 cup pasta water.

In large skillet over medium heat, melt butter. Stir in onions, carrots and sweet bell peppers. Saute vegetables about 5 minutes, or until they brighten in color and begin to soften. Add tomatoes, salt, pepper and garlic. Cook and stir 1 minute to allow tomatoes to release juices.

Pour reserved pasta water into skillet, stirring well. Bring sauce to boil. Reduce heat to medium-low and simmer 3 minutes. Taste sauce and adjust seasonings, as desired.

Transfer drained pasta to skillet along with lemon zest and smoked provolone cheese, tossing well to coat. Serve immediately with fresh parsley and Parmesan cheese, if desired.



### Blessing of Belonging in Christ

I Corinthians 12:14-31

"Now ye are the body of Christ, and members in particular" (v. 27). Paul uses "ye", the plural form of you, to address the church at Corinth. In his epistles to the Romans, the Ephesians, and the Colossians, Paul also states that believers are the body of Christ. The words of this epistle are not for the believers at Corinth alone. Paul is speaking to believers in every church of every era.

The church at Corinth was a diverse congregation made up of both Jewish and Gentile converts. In his opening words to the Corinthians, Paul described the church as "them that are sanctified in Christ Jesus." The body of Christ is all who are set apart His purposes.

Paul's words are not his own. Paul speaks words which are of God the Father and God the Son (see II Pet. 3:15-16). The Holy Spirit moved Paul to state that the spiritual body which is Christ is composed of many members which are different from one another. Some members are feeble (v. 22); some are perceived to be honorable and others less honorable (v. 23); and some viewed as comely and some uncomely (v. 23). The members, while different, all exist for one purpose: making the whole body function in efficient manner. The Apostle Paul uses the make up of a physical body to illustrate the make up of the church. A physical body has many parts. Each part is different but each is necessary. The church, likewise, is composed of many parts with each part performing an integral function. If one part fails to perform, its failure hinders the functioning of the entire body.

In verse 18, Paul states: "But now hath God set members every one of them in the body, as it hath pleased him." In the physical body, the head did not make himself the head nor the eye make himself the eye. It is with the body of Christ as it is with the physical body. Each member of the body of Christ is to be directed by God's will. Every member of the body is sanctified by believing. Not one member has sanctified or can sanctify himself. All are saved by grace through faith given by God (Eph. 2:8). Every part of the physical body from head to toe is dependent upon the Lord. Not one is an independent entity. All are part of the body.

God has given more abundant honor to that part which lacked honor (v. 24). Sometimes we do not hear what God would have us to hear. The Lord has said, "It is more blessed to give than to receive" (Acts 20:35). Christ gave it all. He has given His righteousness to every member of His body. He has commanded us to love one another as He has loved us.

In verse 25, Paul states that God did not fashion the body for purpose of division. The body is fashioned as it is so that members should have the same care one for another. Again, no member is independent. When one suffers, all suffer with that member. When one member is honored, all members rejoice in it. Such is the body of Christ, the church of God's design.

Divisions existed within the church at Corinth. There is no division in the church which God designed. When members care for one another, when we love one another as He loves us, there is no division. The church of God's design cannot be identified by an inscription on the side of a building or upon a signpost on the road. The church of His design is without schism. The church of His design keeps His commandments. Members of His body love one another as He loves us.

Loving others as He loves us requires a righteousness which no man, save Jesus, possesses. No one can love as Christ unless Christ live in him. All must believe and receive. Believe, receive and be blessed. The poor in spirit shall be poor no more (Matt. 5:3). Those who mourn shall be comforted (Matt. 5:4). The meek shall be blessed (Matt. 5:5). Those who seek righteousness shall be satisfied (Matt. 5:6). The merciful shall obtain mercy (Matt. 5:7). The pure in heart shall see God (Matt. 5:8). Peacemakers shall be called the children of God (Matt. 5:9). All who are persecuted and reviled for His sake shall receive great reward (Matt. 5:10-12). His promised blessings belong to them who reveal the righteousness which He has freely given.

In verse 28, Paul reveals the organizational detail of the body of Christ. God has chosen some to do one thing and others to do different things. The Lord did not designate anyone to do all things. The first in ranking are apostles, followed by prophets (those who deliver inspired utterances), then teachers, miracle workers, gifts of healing, helps (helpers), governments (directors), and, lastly, diversities of tongues. Paul was an apostle because the Lord Jesus spoke directly to him.

In verse 31, Paul implores believers to earnestly desire the best gifts. The best gifts are to be chosen to receive the word of God, to deliver inspired messages, and to teach the word. In the close of verse 31, Paul states that he (an apostle) will show the Corinthians (and us) a more excellent way. Paul reveals that way in I Corinthians 13. More excellent than being a vessel chosen by God to hear His voice or to deliver or to teach His word is to love one another as He loves us. When we abide in Him, His love shall be seen in us.
