## High Wind Gusts Knock Out Power Throughout County

Appalachian Power reported that more than 58,000 customers lost power on Saturday, March 25, following the extreme wind gusts that downed many trees and power lines statewide.

Putnam was among the hardest hit counties. The lights went out in Hurricane a little after 1 pm, shutting down the pumps at Sheetz while close to ten customers were filling their tanks. The outage also disrupted the West Virginia State Show Choir Festival which was in progress at the high school.

The outage occurred at the very moment the Hurricane High "Heat Wave" was performing. Hurricane Mayor Scott Edwards said, "I was standing in the gym, watching these amazing

young ladies perform when everything went dark, but they continued pushing forward with their performance. And as they continued, the fear of them getting hurt in the dark was real, but they kept on until they were finally told to stop."

At 10:51 p.m. Saturday evening, 2,980 Putnam customers remained without power. Appalachian listed the following to be without power: Hurricane - 1,961, Fraziers Bottom - 502, Winfield - 231, Poca - 222, Liberty - 120, Scott Depot - 30, Buffalo - 28, Red House - 18.

Appalachian reported that more than 1,000 workers, including 600 line workers, 250 tree removal workers and 150 damage assessors were involved in the effort to restore power statewide.

## Poca, Hurricane Receive \$510,000 in Grants

Gov. Jim Justice announced on Friday, March 24, that the Town of Poca will receive \$325,000 for the design and construction of the Poca Laurel Avenue Sidewalk Extension. Justice also reported that the City of Hurricane will be receiving \$185,000 for design and construction of a project at Hurricane Meeks Mountain Trails.

The two grants are part of 38 Transportation Alternatives and Recreational Trails Program grant projects totaling \$9,734,552 statewide for projects in 22 counties. The program is administered by the West Virginia Department of Transportation (WVDOT) and funded by the Federal Highway Administration to help towns and cities build and improve sidewalks,

lighting, walking paths, rail trails and more.

"We've learned that investing in our cities, towns, and beautiful parks is one of the best ways to attract tourists and improve the daily lives of our residents," Gov. Justice said. "This program provides millions of dollars to make some of the best places in West Virginia more accessible, which will also enhance visitation throughout the state. The positive economic ripple effects will be off the charts, and I couldn't be prouder to approve these well-deserved initiatives."

The City of Hurricane will use the funds to build a pump track in the open bowl area at the head of the Meeks Mountain Trail System. Jason Steorts of Meeks Mountain Trails Alliance stated that the pump track would be

## Blood Clot Awareness Month Is Every Month

Deep venous thrombosis (DVT), blood clots of the deep veins of the body, affects people of all ages and genders and can quickly become life-threatening if left untreated.

Blood clotting is an important way the body responds to injuries to prevent blood loss. However, sometimes these clots can form in the veins of the legs or pelvis causing a DVT, which can block the flow of blood back to the heart. If DVTs are not treated, the clot can break free and travel through the blood vessels to the lungs, causing a pulmonary embolism (PE), a blockage of the blood vessels in the lungs.

DVTs and PEs require immediate medical attention. Many can be treated with the use of blood thinners to break up the clot, but some require a minimally invasive surgical procedure to remove the blockage. Interventional radiologists at WVU Medicine have performed more than 100 DVT and PE cases using the minimally invasive Inari system to remove blood clots.

"Treatments for DVT and PE blood clots have greatly improved in recent years," Robert Grammer, M.D., WVU Medicine interventional radiologist, said. "Prevention through lifestyle change is key,

but you should also familiarize yourself with the symptoms of blood clots so you can get to the hospital in time for us to treat you."

Symptoms of DVT include leg swelling, leg pain, cramping, or soreness that often start in the calf, a change in skin color on the leg, and a feeling of warmth on the affected leg. Symptoms of PE include shortness of breath, chest pain, and fainting.

"There are things you can do to help prevent blood clots from forming," Dr. Grammer said. "If you have to sit for an extended period because you are traveling, you should stand up every one-to-two hours and walk around to stretch your legs if you are able. If you are hospitalized, discuss a prevention plan with your medical team that fits your needs. Lifestyle changes, including weight loss and smoking cessation, can also help reduce your risk."

Risk factors for the formation of blood clots include:

- Hospitalization for illness or surgery
- Major surgery, particularly of the pelvis, abdomen, hip, or knee
- Severe trauma, such as a car accident
- Injury to a vein that may have been caused by a broken bone or severe muscle injury

- Hip or knee replacement surgery
- Cancer and cancer treatments

- Use of birth control methods that contain estrogen

- Pregnancy, including three months post-partum
- The use of hormone therapy that contains estrogen

- A family history of blood clots
- Obesity
- Confinement to bed or wheelchair

- Sitting too long, especially with legs crossed

- Smoking and vaping
- Age 55 or older

- Long-term diseases, such as heart and lung conditions and diabetes

about the size of a football field and designed to accommodate BMX and mountain bikes. Steorts said that a section of the pump track would be designed for and devoted to use by less experienced and younger users.

Mayor Scott Edwards said the pump track will be located in open bowl area at the head of the Meeks Mountain Trail head. "I am very excited about this project. It is a huge addition

which will make Hurricane a leader in recreational opportunities," Edwards stated.

Steorts reported that the track will feature both asphalt and dirt sections with the course of the track repeatedly traversing the small stream which runs through the center of the location. Steorts said that he is not aware of a pump track in West Virginia which can come close to matching what the finished Meeks Mountain Trails track will offer.

The following events happened on these dates in West Virginia history. To read more, go to e-WV: The West Virginia Encyclopedia at www.wvencyclopedia.org.

March 30, 1837: The Virginia legislature granted a charter to establish a private academy at West Liberty, in Ohio County. The first class of 65 students met in the home of the Rev. Nathan Shotwell in 1838. The school is now known as West Liberty State University.

March 30, 1926: Actor, singer and game show host Peter Marshall was born Ralph Pierre LaCock in Clarksburg. His career includes Broadway, television and more than 5,000 episodes as host of The Hollywood Squares.

March 31, 1919: Governor John Jacob Cornwell signed legislation that created the West Virginia State Police. He appointed Jackson Arnold, grandnephew of Gen. Thomas J. "Stonewall" Jackson and former executive officer of the 1st West Virginia Infantry, as first superintendent.

April 1, 1884: Nurse Florence Aby Blanchfield was born in Shepherdstown. She served in the Army Nurse Corps during World War I, oversaw expansion of the corps from 1,000 to 57,000 during World War II, and became the first woman to hold a permanent commission in the regular army.

April 1, 1934: A sales tax went into effect in West Virginia for the first time. The two-percent tax helped fill the revenue void caused

West Virginia to Pittsburgh and then explored, hunted and trapped through much of the Ohio Valley.

April 3, 1908: Samuel Starks died in Charleston. Starks was the first African-American in the United States to serve as a state librarian when he was appointed to the position in 1901 by Governor Albert B. White.

April 4, 1980: Musician Red Sovine died in Nashville. Sovine, born Woodrow Wilson Sovine in Charleston, gained country music fame for his recitations, especially those incorporating sentimental truck-driver themes.

April 5, 1856: Booker T. Washington was born a slave in Virginia. In 1865, he moved with his family to Malden, in Kanawha County, to join his stepfather, who had escaped from slavery during the war.

April 2, 1900: Marlinton, the county seat of Pocahontas County, was incorporated. The town is generally considered to be the location of the first white settlement in the Greenbrier Valley.

April 3, 1755: Frontier scout and "long hunter" Simon Kenton was born in Fauquier County, Virginia. Upon leaving home, Kenton first traveled north through present

## BASIC BIBLE

### Crucified for Sinners

Matthew 27:38-54

"Then were there two thieves crucified with him" (v. 38). Pictured is Jesus upon the cross. He had been scourged (v. 26), stripped of His clothing (v. 35), and nailed to the cross (Jn. 20:25). Above His head was the inscription, "This is Jesus the King of the Jews."

The purpose of the inscription was informational. It announced the reason for which Jesus was crucified. Jesus was the king which the Jews rejected. A traveler from a distant land and lacking knowledge of Judea and its culture might read the sign and ask: "Why was this king rejected?" This question is answered in verses 39-44.

Those who passed by cried out, "If thou be the Son of God, come down from the cross." These words are strikingly similar to those issued by Satan when he tempted Jesus in the wilderness (Matt. 4:3). In verse 40, the condition imposed upon Jesus by the passersby is in diametric opposition to the word of God. Some seven hundred years before the cross, God said, "... he hath poured out his soul unto death: and he was numbered with the tressorsors" (Isa. 53:12). The passersby ignored the word of God. They would not accept Jesus as the Son of God unless Jesus, too, were to ignore God's word. The passersby did not know the God who so loved the world that He should give His Son for all who should believe.

In verse 42, the chief priests, the scribes and the elders also imposed the come-down-from-the-cross condition upon Jesus. They said that they would believe that Jesus was the promised King of Israel if Jesus would come down. They would not accept the Promised One unless the Promised One would refuse to pour out His soul unto death. They looked upon the three crosses and beheld three transgressors. They did not see the promised king who was numbered with the transgressors. They would only accept a king who would ignore God in the same manner in which they ignored God. They would bow only to a king of their own creation. They did not know God. No man can know God unless he look upon the Son and see the Father (Jn. 14:9).

"Now from the sixth hour . . ." (v. 45). Darkness was over all the land. The sixth hour is noon and the noon time is significant. Noon is the hour of God's judgment against Israel (see Amos 8:2, 9). It is likely that the passersby, the chief priests, the scribes and the elders thought the darkness to be God's judgment against Jesus. The future destruction of the temple and scattering of Israel, however, is cause to infer the darkness was God speaking to His chosen people.

"And about the ninth hour Jesus cried . . ." (v. 46). The words which Jesus cried out were those of Psalm 22:1, a psalm of David. The words of Psalm 22, however, describe things which David never experienced. David's bones were never pulled out of joint (v. 14); David's hands and feet were never pierced (v. 16); and David's clothes were never parted and lots cast upon them (v. 18). Why did David lament "But I am a worm, and no man; a reproach of men, and despised of the people" (v. 6)? David answered this question upon his death bed (II Sam. 23:2, 3). David's words were not David's. The words of Psalm 22 were given to David by God the Father. The words which were given to David are the very words which God the Son should speak when the passersby, the chief priests, the scribes, and the elders would mock Him whom they had crucified.

Jesus cried out, "Eli, Eli, lama sabachthani," such that all men might know that He was the Promised One of whom the scriptures speak. Verse 47 reveals that some did not hear. They thought Jesus was crying out to Elijah to save Him. They did not hear the Son crying out to them through the scriptures. There are none so blind as them who will not see.

Jesus cried again and "yielded up the ghost" (v. 50). It was the ninth hour (v. 46). The ninth hour was the time of the evening sacrifice. Day in and day out, a lamb was sacrificed at this time in the manner prescribed in Exodus 29:39. The completion of the sacrifice was announced by a blast from a shofar. The blast served notice that the required sacrifice had been satisfied.

Jesus was the required sacrifice for sin. God gave notice that the required sin offering was complete with the renting of the veil in the temple and a great shaking of the holy (v. 51). The veil in the temple served as a barrier separating the most holy area of the temple (representing the presence of God) from the sanctuary. It was a barrier which no one could pass except the high priest on one day, the day of atonement. The physical renting of the veil is symbolic of Christ's removing the veil that hid Old Testament truths from the chief priests and the scribes and elders (see II Cor. 3:14).

The Gentiles present (the Roman centurion and them with him) saw that which the Jews refused to see. They said, "Truly this was the Son of God." Psalm 22 closes with the promise of a seed which will declare the righteousness of Him who was crucified to a people who shall hear. Christ has removed the veil. Let us declare the word of Him who spoke to David.

of 538 state winners nationwide. The 2022 contest participation included 6,337 entries from 46 states. Of the state winners, 27 growers – three from each of nine classes – were named national winners, representing 12 states.

The average yield among national winners was more than 340.7245 bushels per acre – more than double the projected 2022 U.S. average of 172 bushels per acre. While there is no overall contest winner, yields from first, second and third place farmers' overall production categories topped 262.7586 bushels per acre.

"Year after year, farmer participants contribute to building a better crop for tomorrow. By exploring adaption, innovation, and the tools new technologies offer, farmers sharpen their game and set new standards for the industry", said Tom Hagg, a Minnesota Farmer and current President of the National Corn Growers Association. "One thing I know about corn farmers is how much they love to push themselves to be their best. The 2022 NCYC winners' class is no exception, this group grew corn like champions."

Farmers are encouraged through the contest to utilize new, efficient production techniques. Agronomic data gleaned from the contest revealed the following:

- Average harvest population for the national winners was 37,164 seeds per acre, compared to 34,386 for all entrants.

- National winners applied an average of 203 pounds of nitrogen, 50 pounds of phosphorus and 50 pounds of potassium per acre.

- Average commercial nitrogen use per bushel of yield was 0.85 pounds for the national winners and 0.82 pounds for all entrants.

- 44 percent of the national winners applied trace minerals, compared to 49 percent of all entrants.

- 22 percent of national winners applied manure, compared to 24 percent of all entrants.

For more than half a century, NCGA's National Corn Yield Contest has provided corn growers with the opportunity to compete with their colleagues to grow the most corn per acre, helping feed and fuel the world. This has given participants not only the recognition they deserved but the opportunity to learn from their peers.
