## Annual Vandalia Gathering to be Held May 26-28

On Memorial Day weekend, May 26-28, the Culture Center and State Capitol grounds will set the stage for the 46th Vandalia Gathering – the state's annual celebration of the traditional arts, music, dance, stories, crafts and food of West Virginia. The free festival's unique blend of ethnic and cultural heritage combines an atmosphere as comfortable as a family reunion with the excitement of a state fair.

The 2023 Vandalia Gathering kicks off at 6:30 p.m., Friday, May 26, in the State Theater with an awards ceremony for quilt and wall-hanging winners and presentation of the 2023 Vandalia Award, the state's highest folklife honor, at 7 p.m. A concert following the award ceremonies, emceed by Bill Kimmons, will feature the Long Point String Band, Ben Townsend, Roger Bryant, Robert Shafer, The MacAbre Brothers, and The State Birds. A Saturday evening concert, emceed by Bill Hairston, starts at 7 p.m. in the State Theater and will feature performances by Gerry Milnes and Mike Miller, The Mack Samples Band, Ginny Hawker, Val Mindel, Emily Miller, Kanawha Tradition, Lady D, and Steadfast.

The Vandalia Gathering creates new memories each year for the thousands of visitors who flock from across the Mountain State and around the country to celebrate traditions passed from generation to generation. The festival pays tribute to West Virginia's mountain culture and ethnic heritage by showcasing a variety of craftspeople and

performers. For those who love the sounds of traditional music or would like to be introduced to it, Vandalia Gathering fits the bill. Concerts and contests fill the weekend, and impromptu musical jam sessions spring up all over the grounds. At any moment, a shade tree becomes the site of a lively performance as strolling musicians stop to join in on a favorite tune.

Outside activities begin on Saturday at 10:30 a.m. Events include old-time fiddle, bluegrass banjo, and mandolin contests, with half-hour concerts by Jenny Allinder, Chance McCoy and Tessa Dillon, Tery Vaughan, Buck and Company, Brayden Williamson, and Robin and Dan Kessinger. Sunday's events begin at 10:30 a.m. with a one-hour gospel set by Angie Richardson at 11:30 a.m., followed by old-time banjo, lap dulcimer, and flat-pick guitar contests, with half-hour concerts by Andy Fitzgibbon and Rory Mullenex, Andrew Dunlap and Friends, Southridge, and Sawyer Chapman. The fiddle and guitar competitions have a youth category for musicians 15 years of age or younger. Traditional dance offerings range from demonstrations of ethnic and square dancing to flat-foot dancing in the Great Hall of the Culture Center where spectators are encouraged to jump in and kick up their heels.

The popular Liars Contest returns on Sunday in the State Theater at noon (with registration beginning at 11 a.m.) as

The first part of the recital featured a production inspired by "Hinds' Feet on High Places," an allegorical book by Hannah Hurnard. The tale, which bears similarities to Pilgrim's Progress, follows the journey of a handicapped orphan girl who flees from her abusive family and goes on a journey to find the high places, where she dreams of being able to dance like the deer.

On Thursday, May 18, members of Marine Corps League Detachment #1474 gathered at Forest Memorial Park in Milton to honor the memory of Cpl. William Bradley Fulks who died from wounds suffered in Iraq on May 18, 2006.

Detachment #1474 was chartered in honor of

Cpl. Fulks in a ceremony conducted at Hurricane City Hall in December of 2019. The detachment remains true to the Marine Corps motto, Semper Fidelis, with the playing of 'Taps' at Cpl. Fulks' gravesite each May 18th.

William Bradley Fulks graduated with honors from Cabell Midland High School in 2001 where he excelled in

basketball, football, and track. After determining that college was not for him, Brad enlisted in the United States Marine Corps in 2004. In April 2005, he shipped out to Al Anbar, Iraq, with the 2nd Reconnaissance Battalion.

On May 1, an improvised explosive device (IED) detonated beneath his Humvee. The blast inflicted massive internal injuries

and second and third degree burns to over 60 percent of his body. He died in a military hospital in Germany 17 days later.

John W. Smith was born March 9, 1905, the son of John H. and Victoria Stanley Smith. He moved to Hurricane in the late 1930's and in 1944 was married to Mildred Kirby. They lived on W. Main Street and were the parents of Sharon, Fred and Teresa. Johnny served the City of Hurricane as Chief of Police and held that office longer than any of his

To make an appointment, simply download the American Red Cross Blood Donor App, visit [RedCrossBlood.org](http://RedCrossBlood.org), call 1-800-RED CROSS (1-800-733-2767) or enable the Blood Donor Skill on any Alexa Echo device to make an appointment or for more information. A blood donor card or driver's license or two other forms of identification are required at check-in. Individuals who are 17 years of age in most states (16 with parental consent where allowed by state law), weigh at least 110 pounds and are in generally good health may be eligible to donate blood. High school students and other donors 18 years of age and younger also have to meet certain height and weight requirements.





predecessors. In the early years of his career he was the only policeman the town had. In that capacity, he obviously became one of the better known citizens of Hurricane.

Much could be said of his contributions to the town, but we would only submit a view of Johnny as through the eyes of a daughter. Admittedly, it is a personal view.

March 9, 1905 - March 28, 1986

His name was "Johnny Smith". He was a husband, father and grandfather but above all he was a patriotic citizen, even before he had a title with city government he was involved. Sitting in on City Council meetings, being active in the American Legion, driving the streets late at night to be certain children were inside and safe and always there lending a helping hand at civic activities. Teenagers and children

knew him well. He was the chaperone at dances and the policeman to ensure all children's safety. Children from the ages of 1 to 18 looked up to him. He was always available, not to criticize the youth of Hurricane but to help them in any way he possibly could by sponsoring a teen activity or even lending a listening ear.

If he was needed by a friend, a stranger of the City, he was there. It didn't matter the time of day or night. He was always reliable.

Today, his friendly smile, soft voice and gentle wave of his hand are very much missed. No more can you walk the main streets of Hurricane and hear his soft & friendly Hello. Within himself he stood for honesty, integrity and dignity. He had love for his home town and fellow man. Indeed, he was a true American Citizen.

This facility is more than four times the size of our previous Poca facility and it serves as a critical hub



## BASIC BIBLE

### Jesus' Prays for Believers

John 17:6-21

Before us is a portion of the prayer which Jesus prayed just prior to crossing over the brook Cedron and entering into the garden of Gethsemane. In John 17, Jesus requests: (1) that He be glorified, (2) that His disciples have the same relationship as exists between the Son and the Father, and (3) that all who would ever believe on the Son be one as the Father and Son are one. Verses 6 through 19 is that which Jesus asks for His disciples. In verses 20 and 21, Jesus requests that all future believers be one with Him and the Father.

Jesus spoke to the Father saying: "I have manifested thy name unto the men which thou gavest me out of the world" (v. 6). Jesus had delivered the words which the Father had given Him to the disciples (v. 8). Jesus, however, had not yet made the love of the Father fully known to them. Full manifestation of the Father's love would wait until the only begotten Son should give Himself upon the cross as the sin payment for whosoever should believe in Him (Jn. 3:16).

In verse 11, Jesus, using the present tense, stated: "And now I am no more in the world." The disciples heard these words when Jesus was present with them.

In verse 12, Jesus, continuing to address the Father, said, "While I was with them in the world, I kept them in thy name." Again, the disciples heard these words when Jesus was in the flesh and was present among them.

We know and the disciples knew that Jesus was physically present among them when He spoke these words. Through His prayer, however, we see Jesus in the presence of the Father. We hear Jesus pray the words of a high priest. We see Jesus interceding for the disciples.

The passage of scripture before us reveals that which the disciples heard and when they heard it. Our understanding of the picture before us is dependent upon the teaching of the Holy Spirit. The disciples saw that which the Father intended. They saw Jesus pray to the Father on their behalf. Their full understanding of that which they saw, however, would wait until Pentecost (Acts 2:1-4) when the Father would send the Holy Spirit to teach them all things and cause them to remember all the words which Jesus had spoken (Jn. 14:26).

Believers know the Father through the Son. The Son reveals the Father in this prayer. In verse 6, Jesus identifies the disciples as men which the Father gave to Him. Those which the Father gave to the Son heard Jesus say "Follow me" (see Matthew 4, Mark 1, Luke 5, and John 1). Whom did the Father give to the Son? The Father gave the Son them who would hear the Son and follow Him. The Father gave the Son them who would keep the Father's word (v. 6). The Father knew the disciples before they knew Him. It is through the Son that we know the omniscience of the Father.

The Father would give to the Son them who would come to know with certainty that all that Jesus said and did was of God the Father (v. 7). The Father would give them who would surely know that Jesus came from God the Father and that God the Father had sent Jesus (v. 8). Through Jesus' prayer, we know the Father chooses them who shall hear and obey.

Through Jesus' prayer, we know that those who belong to the Son belong to the Father and those who belong to Father belong to the Son (v. 10). Through Jesus' prayer, we know the oneness of the Father and the Son. The Father chooses them who shall glorify the Son (v. 10).

In His prayer, Jesus makes the Father's will known to the disciples (and us). Because the Father and the Son are one, the will of the Father is the will of the Son and vice versa. It is the will of the Father that the disciples be one "as we are" (v. 11). The Father and the Son exist in perfect harmony. It is the will of the Father that the disciples (and all believers) be of one accord.

In v. 13, Jesus makes the reason known to the eleven why that He goes to the Father. Jesus would have the fulfillment of His joy be realized in them. The fulfillment of His joy is dependent upon the Son going to the Father. The fulfillment of His joy is dependent upon Jesus' sending the Comforter. The Comforter (the Holy Spirit) will not come except Jesus be with the Father (see Jn. 16:7). Without the presence of the Holy Spirit, the disciples (and all believers) cannot have oneness with Christ. Oneness with Christ is the fulfillment of His joy.

Believers are in the world but are one with the Son who is in heaven with the Father. The disciples and all believers are made one through and by the Holy Spirit. Believers are no longer of the world but have become one with Jesus by the Holy Spirit (v. 16).

The world "hath hated" (past tense) [v. 14] the disciples because they are (present tense) not of the world as Jesus is not of this world. The rules of the earth do not apply to them who are born of the Son.

Jesus, in the very presence of the Father, asks Him to protect the disciples from the evil one (v. 15). Jesus asks the Father to sanctify them through "thy truth" (v. 17).

Would that all men hear the truth that the Comforter teaches. Would that all men know the love of God the Father.
