in the area were visited by circuit riders and young preachers from Morris Harvey College at Barboursville.

Following the organization of the first society, the congregation worshipped in the Hurricane Baptist Church for a number of years-each congregation having part-time ministers.

The Methodist Church, North, worshipped in a building on Main Street on one of the lots now used as a parking lot for the A-Z grocery store. The church was later moved about one mile east in Teays Valley and was known as the Rock Cut Church.

The Liberty Methodist Episcopal Church, South, located on upper Cow Creek, was in our community area. Many of our past and present members originally were members of the Liberty and Rock Cut Methodist Churches.

Mr. and Mrs. Thomas (Vaturia Conner) Harbour deeded the lot on Putnam Avenue to the Methodist Church, South, on November 30, 1899.

On June 6, 1915, the first Sunday School was organized with Forrest Gordon Burdette as the Superintendent. With seventy-six members, the Sanctuary was completed in 1915 at a cost of \$4,000.00. Money was raised for the Sanctuary in many ways. One of the most unusual was conducted by the ladies who had a "Sock Social." It was held at the residence of Mr. and Mrs. C.M. Woodworth on Saturday, January 31, 1914. Socks were given out and the person was asked to multiply their sock size by two and place


the cents inside the sock. The Ladies Aid pieced and quilted quilts, tacked rags and wove rugs, had dinners, and sold bottles of flavoring to do "their" share in paying for the new church.

On November 10, 1918, when the church was dedicated to the memory of young Forrest Gordon Burdette, Bishop U.W. V. Darlington stated, "I feel that I am a better man by having known Forrest Gordon Burdette." Burdette had died a short time before at the age of 22 years in World War I at a hospital in Gettysburg, Pa., from the "1918 flu."

1936-The former Liberty Methodist Church was moved from the country, repaired, and joined to the main building of the new Hurricane church. Rev. I.N. Fannin was the Pastor. That building was then named Epworth Hall and served as Sunday School classrooms and provided for church dinners with a small kitchen. The building was later sold to Mr. and Mrs. Walter Clark and moved to a location on Virginia Avenue.

1938-The Rock Cut Church, located on the South side of Teays Valley Road in front of the new Hurricane High School, was destroyed by a severe storm and was not rebuilt. 1940-A new addition containing classrooms and a choir loft was added to the west side of the former Sanctuary. Concrete blocks were sold to members and friends of the congregation to pay for the new addition. Rev. W.L. Phillips was Pastor. Ladies made and sold doughnuts to purchase an organ for the church.

A house on the corner of Virginia Avenue

and Conner Street was purchased to be used as the church parsonage. Rev. Ralph T. McCord was Pastor. That property was sold in 1962.

1953-During the pastorate of Rev. Ira Mentz, an educational addition was begun. Pledges totaling \$43,291.00 were made for the new structure. The addition provided classrooms, multi-purpose hall, and kitchen.

1962-Additional classrooms were added, new heating system installed, and a new parsonage at 304 Ada Dell Avenue was purchased. Rev. Allen Parrish was Pastor.

1967-The Ada Dell Avenue parsonage was sold and the Dr. Erwin property, one of the oldest houses in town, adjacent to the church property, was purchased to provide additional parking and to serve as a parsonage. Rev. Joseph Byrd was Pastor.

1974-The original Forrest Burdette United Methodist Church Sanctuary was razed. A tremendous increase in attendance and membership made it necessary to erect a new and larger Sanctuary. With the new construction of brick and beautiful stained glass window facing the highway, the church added a nursery, offices, narthex, basement with social hall and kitchen, and restrooms. The new Sanctuary speaks to all who enter and all who pass b that God in Christ is at the heart of the contemporary society. Rev. Charles Hinkle was Pastor.

1978-The former Qualls-Hodges property located on Virginia Avenue was purchased with five "Faith Partner Pledges" received for down payment. This now serves as the parsonage. Rev. William D. Slates was Pastor.

1980-A Pre-School was opened for three and four year-old children. Teachers and aids were employed and a Board of Directors was elected. The school operates under the supervision of the Church and is located on and in church property.

1981-The first Assistant Pastor, Mrs. Jan Oldham,

was sent to us by the W. Va. Methodist Conference. She later became a Pastor of the United Methodist Church.

Others who have been led into the ministry of serving God are: Ervin Conner, Leo Pauley, James Burdette, James Dumire, Mike Amory, Darrell Sovine and Frances Kiff.

The Church received recognition from the United Methodist Conference of W. Va. It was named the Conference Church of the Year. Rev. Bill Deel was Pastor.

Our first Educational Director, Miss Chris Wagner, was employed.

The Church purchased the Dakota Taylor Rice property adjacent to the Sanctuary to be used for parking.

1983-The Dr. Sam Henson property on Putnam Avenue was purchased. It is adjacent to the Rice property. This property will be razed and used for future expansion.

1986-The education building and Byrd Hall were renovated.

1987-The Alice Hall and James Dunlap properties on either side of the church property were purchased for additional parking plus future expansion. Rev. Robert Johnson, Pastor.

1987-1988-Our membership is now 612. The challenge is ours. As we approach our Diamond Anniversary in 1990, in God's name we will work toward all things to His glory. Submitted by Mrs. Grace Boggess

## Origin of Teays Valley

planet Earth. Its origin is believed to have preceded the formation of the Appalachian Mountains. Evidence suggests that the Teays began as a westward flowing stream in what is now the mountains of North Carolina. As the Appalachian chain was elevated from its marine origin, the stream chewed out and cut into the bedrock producing the New River Gorge.

The Teays followed the present day course of the New and Kanawha Rivers until it reached the present location of Scary Creek in Putnam County. The Teays carved out a valley that averaged one and a half to two miles in width from Scary to the approximate location of Huntington where it was thought to join the Ohio River.

Geologists now know that the Ohio formed much later. The Teays River of that early pre-glacial era actually continued northward into what is now the state of Ohio through Chillicothe, Circleville, and Columbus. In the Marion, Ohio area it turned westward and followed the approximate course of what is now the Wabash River across Indiana and then followed a meandering path across Illinois where it turned southward along the course of today's Mississippi until it reached the Gulf of Mexico which extended inland to the western tip of present day Kentucky.

The building boom which accompanied the construction of I-64 in the late 1950's revealed a heretofore unknown sediment found only on lake bottoms. Alternating deposits of light and dark sediment, indicating seasonal difference in sedimentation, were discovered. The layers,

called varves, are believed to have been formed during the great ice age.

Geologists state that the great continental glacier which covered much of North America, blocked the flow of the Teays in the approximate location of the Chillicothe, Ohio, causing a great lake to form. This lake, Lake Tight (named for a Dennison University professor), covered an estimated 10,000 square miles in western West Virginia, southeastern Ohio, and northwestern Kentucky. It extended from Chillicothe, Ohio, to the New River Gorge in Fayette County, West Virginia. The overflow from the lake carved out the present Ohio Valley west of Ironton. In 2018, geologist James Erjavec created a map of Lake Tight which would have held 268 cubic miles of water, more than twice the volume of Lake Erie. The average depth was estimated to be 140 feet, with pockets as deep as 300 feet.

The lake gradually filled in and the glacier melted leaving present day Teays Valley high and dry. There are 180 feet of lake sediments in the Scott Depot area. The waters which once followed the course of the Teays, flowed northward from the present location of Nitro to form the Kanawha Valley. The runoff from the melting glacier joined the Kanawha and Pt. Pleasant to form the present river system.

When the new Hurricane Post Office was built in 1995, construction delays were encountered because builders hit a deposit of ground water trapped in the gravels of the longa go Teays River. Some oldtimers believed that builders had actually tapped into the still flowing waters of Teays River.

Aug. 17, 1944: Staff Sergeant Stanley Bender earned the Medal of Honor in southern France. Bender rushed through intense machine gun fire and grenades, and knocked out two German machine guns with rifle fire. His actions inspired the rest of his company to take out a German roadblock, kill 37 enemy soldiers, and take 26 prisoners.

Aug. 17, 1976: The National Mine Health and Safety Academy opened

at Beaver, near Beckley. The academy, located on a 76-acre campus, is the world's largest educational institution devoted solely to safety and health in mining.







## BASIC BIBLE

### God's Gracious Rewards

Matthew 20:1-16

The text before us is a parable which firstly illustrates the kingdom of heaven (v. 1) and secondly explains Jesus' answer to a question asked by Peter (see Matt. 19:28-30). Peter had asked Jesus what reward could be expected by those who had forsaken all to follow Him. Jesus had answered that they would receive 100 fold and everlasting life but that there would be many who had been first which would be last and that the last shall be first.

The kingdom of heaven is like a particular householder. The householder's actions present a picture of his desires and his guiding principles.

In verse 1, we see the householder as one who desires laborers to work in his vineyard. In verse 2, we see him as one who has contracted to provide a day's wage for a day's work. In verse 3, we see that the householder returned to the marketplace in search of more laborers at the third hour of the day. There is a reason for the householder's action. Maybe he failed to estimate the human resources needed to complete the task in a single day. Perhaps the laborers that he hired at the first hour were sluggards. We only know that the householder desired more laborers. In verse 4, we see the householder as one who promised to reward his new hires with "whatsoever is right." In verse 5, we see the householder sought more laborers at the sixth hour and at the ninth hour of the day and repeated his promise to pay "whatsoever is right" to them.

In verses 6 and 7, we see an enhanced picture of the householder. It is the 11th hour. There remains but one hour of daylight to finish the task. The householder finds men standing about and inquires, "Why stand ye here all the day idle?" With this question, we see the householder as one who appears to disapprove of idleness but is not quick to condemn them who are idle with cause. After learning that their idleness was not of their choosing, the householder instructs them to go into the vineyard and he will pay "whatsoever is right."

In verse 9, we see that which the householder considered "whatsoever is right." The 11th hour hires did not receive that which they deserved. The late hires deserved one twelfth of a day's wage. They received a full day's wage. They received that which was right in the eyes of the householder.

In verses 13-15, we see the response of the householder to the laborers who complained because they did not receive more than their agreed upon wages. The householder thought it right to give those who had labored 12 hours the wage that they contracted for and no more. He paid all laborers the wage to which they agreed to accept. The householder did not make a single exception. Such is the kingdom of heaven; there are no exceptions.

They which had labored 12 full hours murmured against the householder because he (in their eyes) rewarded the single hour of labor with a full day's wage. The householder reveals that he regards time in a far different manner than the laborers. The householder was aware that his eleventh hour hires had waited for 11 hours for some man to come and hire them (see v. 7). It is also apparent that the householder knew that his hires of the third hour waited 3 hours, hires of the sixth hour waited 6 hours and his hires of the ninth hour had waited 9 hours for someone to employ them. All laborers spent time in the marketplace and time in the vineyard. All spent 12 hours total. The householder's actions reveal that he rewarded hours of waiting and hours of labor in the manner of his choosing.

In verse 8, the householder called for his steward to pay the eleventh hour hires first and the first hour hires last. The householder made the first last and the last first.

Who are the first who were made last? They are the presumptuous (v. 10). They were self-righteous. They thought their work to be of greater value because they had endured the heat of the day (v. 12). They saw the householder as evil (unfair) because he was good (gave whatsoever he thought right). The first who were made last are them who thought wrongly of themselves and of the householder.

Who are the last who were made first? The last were persistent (they remained in the marketplace). The last thought their labor not to be worthy of negotiation (subject only to the whim of the householder). The last who were made first were them who set no pre-condition upon their hire. Those that were made first are those who thought correctly of themselves and correctly of the householder.

In verse 16, Jesus explains why the last shall be first and the first shall be last: many are called but few are chosen. The householder called many to work. The householder called them who thought more highly of themselves than they should have and the householder called them who thought their worth to be little. The householder chooses them who think correctly of him and themselves. The householder knows the hearts of all.

The goodness of the householder is seen in all who esteem others to be more deserving. May believers put all self-righteousness aside such that the goodness of the householder be seen in undiminished brightness.


WVGA folks did a great job with this event. We look forward to having them back next year."


