Parades, Parades And More Parades!

September is the season for area parades this year. The first parade was the Putnam County Homecoming Parade on September 10.

Last Friday, both Hurricane and Buffalo High Schools held homecoming parades that drew crowds of spectators.

This Saturday, September 30, Buffalo will be the site of an All Horse Parade. The 10:00 a.m. parade will start and end at the Buffalo Gazebo Park on State Route 62. There will be a public auction at noon. The event will feature concessions, fried pies,

carriage rides and more with all proceeds going to Hospice Care.

Also on Saturday, Main Street in Poca will host the Poca Heritage Day Parade at 11:00 a.m. Other Poca Heritage Day events include a cruise-in on Friday evening from 5:00 p.m. until dusk.

The parade scene shifts to Milton on Sunday, October 1st, with the West Virginia Pumpkin Festival Grand Parade with at 2 p.m. start time. The West Virginia Pumpkin Festival will be October 5-8 at Pumpkin Park in Milton.

Making Hay While the Sun Shines

On Friday, September 22, the weather forecast called for four days in which hay could be cut, cured, raked and baled. It rained on Sunday. Making hay while the sun shines is the only way that it can be done. A 4-day window of favorable weather is necessary for typical hay fields.

The inaccurate forecast did not hinder the Grady and Parkins families who lease about 75 acres of hay field and 125 acres of pasture on Bowles Ridge because they began cutting hay on Monday, September 18, and had completed the

balancing before Sunday's rain on the 24th.

Harvesting 75 acres of hay in a 5-day period requires more than one baler. The Dencil and Judy Grady and Brian and Jennifer Parkins employ three tractors, two for baling and one for raking.

The two families took advantage of a stretch of favorable weather in early June to harvest a mix of 75 4x4 and 4x5-foot round bales off the same fields. This last week's second cutting produced about half that number.

The hay will be used to feed 25 head of cattle this winter.



Hurricane High School 'Redskins' Are Latest Target of Liberal Cancel Culture

In response to a recent op-ed advocating for the "canceling" of the moniker "Redskins" used by Hurricane High, as a 23-year veteran of the United States Army, I felt it important to present the facts and statistics as to why such rhetoric to cancel Native Americans from history is not only racist, but dangerous.

The term "Redskins" is a reference to the elite Indian warriors who would paint themselves in red

paint in preparation for death prior to going into battle. The truthfulness of this fact won out in State and Federal Court when the Supreme Court of the United States ruled that the term "Redskins" is not a derogatory term.

The students, alumni and Hurricane community identify with their mascot and what it represents - Indian warriors who were prepared to fight to the death to protect their families and communities. Honoring that Indian heritage and the Native American's important role in our nation and our communities should be celebrated, not canceled.

In fact, a 2016 Washington Post poll even shows that 90% of Native Americans do not find the term offensive. Even now, Native American participation in the military remains at 19% versus an average of 14% of all other ethnicities since 9/11. The Navajo Code

Talkers played a critical role in winning World War II.

The recent opinion article by Elliott Namay perfectly illustrates the radical left's agenda to cancel any culture or entity that does not agree with them or that they are threatened by. Imagine a conservative making such remarks about another

race, ethnicity or culture to be canceled. This is racism at its core definition.

Mr. Namay's words are not just derogatory, they are disrespectful to veterans and those serving our nation - specifically Native Americans. Native Americans are proud of their contributions to our great nation and West Virginia has deeply rooted Native American history of which we should all be proud. West Virginia has more veterans per capita than any other state, including the late National Medal of Honor recipient Woody Williams.

The Centennial History of Hurricane Hurricane Area Church Histories

In 1988, The Centennial History of Hurricane, WV was published to commemorate the town's 100th anniversary. The publication included the histories of 16 Hurricane area churches. This week's selection is the 11th of the church histories which were published in 1988.

MT. MORIAH MISSIONARY BAPTIST CHURCH
Mt. Moriah Missionary Baptist Church was organized on July 4, 1858. The first church was logs and stood a short distance from the present church location, just up on the hill where the old tall cedar trees are, and the oldest part of the church cemetery is, which I am told, was still the state of Virginia. There is still an old church pew, put together with wood pegs, kept from the original log church, in the present church.

The annual fall migration of blackbirds through Putnam County did not wait for autumn's official arrival at 2:50 a.m. on Saturday, September 23. A large swarm on blackbirds

arrived in Hurricane just prior to dark on Wednesday, September 20.

A large swarm of blackbirds is called a murmuration. Murmurations are typically

composed of large numbers of red-winged blackbirds with smaller numbers of starlings and grackles mixed in.

Birds of the feather truly flock together.

Help Is Available For Those Struggling With Mental Health

September is Suicide Prevention Month, a time to raise awareness about suicide and prevention efforts. In West Virginia, suicide is the second-leading cause of death for those age 10 to 24. West Virginia also ranks 10th in the nation for suicide mortality.

"Any change of behavior is notable and concerning," Ja'me Brandish, M.A., WVU Rockefeller Neuroscience Institute Healthy Minds licensed psychologist, said.

Suicide warning signs include:

Talking about suicide
Talking about being a burden on others
Feeling hopeless
Feeling like there are no other options
Withdrawal from social groups or family
Cutting off all positive supports

"People are afraid to ask the question or to say the wrong thing," Brandish said. "And I

know that I worked with Coach Tinsley... he was always supportive... and maybe Coach Burdette, everyone loved... my memory escapes me... football was big at NHS... Friday nights found me at the games.

I taught in Putnam at the high schools... I attended the games... when I moved to Hurricane High, it was such fun to go to my Alma Mater's games... new field... new bleachers... huge crowds... I did NOT like the kids running around everywhere instead of watching the games, but time changes things... not my business, I guess...

Friday nights are fun... they should be... they should not be excruciatingly painful for the losing team and the parents of those players... watching the score soar... do something... do not let that happen again... there is nothing learned by that happening... I hope someone in charge changes that... but I do know, if I were living in Hurricane, I would not attend another game if that became the norm...

Oh, I can see my readers shaking their heads... asking "what does she know???" I can seem them chuckling... laughing... but let me tell you, I do know football... I enjoy football... and more importantly, I know the kids... they work hard in class... they practice... they do their best... and they deserve the best... I might not be a coach... I might not be teaching at the school anymore... but I REMEMBER Monday mornings... whew... and as I continued to tell those players (of all teams)... shake it off... move on... in a few years, you won't remember all of this... it is a game...

Now, I can really see my readers shaking their heads... lol... but this is how I feel... this is what I know... because the way we were is the way we are... I married the captain of the football team, way back when, and I bet he doesn't remember what happened at his games.

everything tells you to ask the question and let them talk and just listen nonjudgmentally. They're often relieved that someone asked. Talk to them, connect them with resources, be there for them, and reach out after. That's the most important thing."

Mt. Moriah sits high in the beautiful hills of Curry District, near the spot where Turkey Creek empties into Mud River, some call it Trace. It is about ten miles southeast of Hurricane. It is thought, by some members, that the name was given to the church in memory of Mary Moriah Burdette, who was the first person buried in the cemetery. She died in 1855, three years before the church was organized. The land on which the first cemetery was started was originally part of the Burdette farm. The name of the church, however, could have been derived from the Book of Genesis. The first members of the church were W.J. Hayslette and wife. The old log church served the community for almost three decades, after which it was decided a new

larger church was needed to serve the needs of the growing community. At a business meeting in July, 1885, a committee was appointed to see if enough money could be raised to construct the new church. The work began! The carpenters employed were William Keifer and Bill Watts. Timber was cut from surrounding countryside, nothing but poplar and oak was used. The lumber was hand dressed on the church lot by many helpful hands. The size was 54 x 40. It was completed in March, 1891. The church has been served by forty-five pastors, the first, Rev. B.F. Perry, and the one that pastored the longest over a period of years was the now deceased Rev. Homer Curry, greatly loved by all who knew him. He married more people and preached more funerals than anyone else.

Those pictured in the old photograph just after the church was completed are, left to right: Frances Amos, Florence Elkins, Lorenza Griffith, Noah Allen, Tom Allen, William Hayslette, Mose Carpenter, Charlie Kinnison, William A. Burdette, Herbert E. Burdette, Willie Carpenter, Timmy Hayslett or Rev. Perry (it is not known). The small boy in the picture was Herb Burdette, who passed away a few years ago, at the age of near one hundred. The church has held its annual homecoming since 1935. The church is surrounded by three well-kept cemeteries, with soldiers from all the wars buried there. The church has undergone extensive remodeling over the years. It is truly a sacred and beautiful place, a great light and asset to the community! Submitted by Mairlis Johnson Edwards

- 1 teaspoon salt, plus additional for salting pasta water, to taste
- 1 tablespoon butter
- 1 block (8 ounces) cheddar cheese
- 1/2 cup raw pecan pieces
- 15 ounces part-skim ricotta cheese
- 4 tablespoons sour cream
- 1/4 teaspoon ground pepper
- 1 large egg, lightly beaten

Preheat oven to 375 F.

Cook cavatappi in salted boiling water. Drain, reserving 1/2 cup pasta cooking water. Return pasta to pot and stir in butter.

Using box grater, shred cheddar cheese.

Using food processor, combine 1/4 cup shredded cheddar cheese with pecans. Process to coarse breadcrumb consistency.

Add remaining cheddar cheese, ricotta, sour cream, 1 teaspoon salt and pepper to warm pasta. Stir until thoroughly combined. Add egg; stir. Add 2-4 tablespoons reserved pasta water to loosen mixture; stir until smooth.

Pour into buttered 9-inch square or round casserole dish and top evenly with pecan topping.

Bake 30 minutes.

Substitutions: Use pre-shredded cheese in place of cheddar cheese block. Use pasta of choice in place of cavatappi.

Superfood Pecan Energy Bars

Cook time: 40 minutes

Servings: 14

- 15 Medjool dates (9 ounces)
- 1 cup pecan pieces
- 1/2 cup gluten-free oats
- 1 tablespoon chia seeds
- 1 teaspoon vanilla extract
- 1/2 teaspoon cinnamon
- 1/4 teaspoon kosher salt

Preheat oven to 200 F.

In food processor, process or pulse dates until chopped and rough texture forms. Add pecan pieces, oats, chia seeds, vanilla extract, cinnamon and kosher salt; process about 1 minute until crumbly dough forms.

Line baking sheet or jelly roll pan with parchment paper. Dump dough into center of parchment paper and use rolling pin to roll into 6-by-10 1/2-inch rectangle. Cut dough into 14 bars about 1 1/2-by-3 inches or into desired shapes.

Bake bars 30 minutes. Cool bars to room temperature then refrigerate in sealed container between sheets of wax paper.

To package for on-the-go snacking, cut 4-by-6-inch rectangles of wax paper, wrap around bars and secure with tape.

God Confirms Gideon's Mission

Judges 7:2-4, 13-15; 8:22-25

A full three chapters of the book of Judges is devoted to Gideon's tenure as judge. God raised up Gideon to deliver Israel from the oppressive hand of the Midianites. During this seven-year period of oppression, a Midianite hoard would sweep into Israel following the harvest and confiscate every bit of food which they could find. God let this happen because Israel sought the blessings of pagan gods. When Israel cried out, God responded.

There is a reason that three full chapters were recorded and preserved as scripture; and that reason is partially revealed in the text before us. In verse 2 of chapter 7, God tells Gideon that he has gathered too many men of Israel to fight against the Midianites. Why are there too many? No general in Gideon's day, no general of today, and no general in history of warfare has ever complained that he was commanding too many troops. Warfare, then, now, and at all times in between, was, is, and has been an exact science in which a superior force defeats a weaker force. Generals know that a larger force is superior to a smaller force if all else is equal. In the text before us, Gideon is the general who commands the smaller force. Gideon commanded about 32,000 men (see 7:3) and the Midianites numbered 135,000 men (see 8:10). So why does Gideon, outnumbered by more than four to one, have too many men?

God told Gideon that he commanded too many men because Israel would credit itself, not God, when the Midianites were defeated. It would be God, not Israel, who would rout the Midianites. Warfare is an exact science even when God is involved. The stronger force always defeats the weaker force. Gideon was in command of the stronger force because God was on his side. Let there be no misunderstanding. God wants men to know Him. God wants His people to know that He is their protector and that He delivers them from their enemies (In this case, God delivers the enemies of Israel to them).

As both armchair generals and believers, we know that God and 300 men is vastly stronger than 135,000 men without God. God wants us to know that with Him all things are possible. If we know these things, we know what God wants us to know.

Bible commentators tend to be critical of the 22,000 fearful men that Gideon sent home and the 9,700 men who lapped water upon their hands and knees. It can be said in defense of the 22,000 fearful that they were honest. They admitted that they were afraid. And in defense of the 9,700 men, it can be said that they were brave and willing to fight. God had a special role reserved for the 300 who vigilantly lapped water from their hand, but God also had a role for the 31,700 men that He had Gideon send home. The 31,700 were to witness and to proclaim what God did. They were to proclaim that it was God who crushed Israel's enemies. They would not participate in the decisive battle which would result in victory over the enemy but they would be the benefactors of that battle.

As believers in Christ Jesus, we proclaim a personal salvation earned, not of works but, by grace through faith. Believers in Christ Jesus have no boasting rights. Believers, like the 31,700, are the recipients of God's grace. And what of the 300? It was by God's grace and His grace alone that God delivered the Midianites to the 300.

God devised a plan by which Gideon and 300 men would destroy the Midianites. The account before us reveals how that God convinced a hesitant Gideon that His plan would be successful. God sent Gideon and his servant on a mission to personally spy out the Midianite camp. While in their midst, Gideon learned of a dream and of its interpretation that was circulating among the Midianites. The dream and the interpretation of the dream foretold of the victory that God would give Gideon. The Midianite force consisted of 135,000 terrified men waiting for the sword of Gideon to fall upon them. God emboldened Gideon. Gideon and his 300 "surrounded" the Midianites in the dark of night, the confused Midianite force lashed out one against another, and the tribes of Israel then destroyed the remaining Midianites in what military tacticians of today would term a mop up action.

In the closing verses before us, the people called out to Gideon requesting that he and his sons and his son's sons rule over them. In making this request, the people were attempting to reward Gideon for the victory over the Midianites. Gideon knew that it was God and God alone who had delivered Israel. He knew to refuse the offer to rule as king. He knew that God, and God alone, was Israel's king. While he would not accept the throne offered to him, Gideon did accept a gift of gold. The gold was willingly given as a reward, a payment for services rendered. Israel had received God's grace and thought it sufficient to give Gideon gold. God does not want gold. God is a God of grace and He deems it to be a reasonable service that we should present our bodies unto Him as a living sacrifice, holy and acceptable (Rom 12:1). Israel did not know God and did not respond to His grace in an acceptable manner.

Born again Christians are without excuse. Let us present our bodies as willing vessels to Him. Let His rule be established in us.

Sept. 28, 1955: Labor activist Sarah "Mother" Blizzard died at age 90. Blizzard was deeply involved in the United Mine Workers of America, from the organization's beginnings in

the late 19th century.

Sept. 29, 1861: The Kanawha Valley experienced severe flooding. The Kanawha River reached 46.87 feet in Charleston, more than 16 feet above flood stage.

Sept. 30, 2010: Facing an economic downturn and foreign competition, Wheeling-La Belle Nail Company closed. The company was founded in 1852 as LaBelle Ironworks. By

1875, Wheeling was known as the Nail City, and La Belle was the city's leading nail producer.

Oct. 1, 1896: Rural Free Delivery began in West Virginia's Eastern Panhandle. Before this, there was no rural mail delivery, although more than half the country's citizens lived in rural areas.

Oct. 2, 1923: Hershel "Woody" Williams was born in Quiet Dell. During World War II, Williams neutralized seven concrete pillboxes at the Battle of Iwo Jima. Prior to his death in 2022, he was the last surviving Medal of Honor recipient from World War II.

Oct. 2, 1949: The first class began training at the State Police Academy in Institute. The 20 cadets graduated on Dec. 20, 1949.

Oct. 3, 1935: A patient at Weston State Hospital started a fire in the main building

that destroyed six men's wards and caused a cupola to fall through the roof. The building was repaired, and the hospital remained in service for nearly

60 more years.

Oct. 4, 1934: Sam Huff was born at Edna, near Morgantown. Huff was part of a fearsome defense that led

West Virginia University to a 38-7 record between 1952 and 1955, including three consecutive wins over rival Penn State.



Two Putnam High School Students Named National Merit Scholarship Semi-Finalists



The National Merit Scholarship Corporation announced more than 16,000 semifinalists in the 69th annual National Merit Scholarship Program on Wednesday, September 20, including two Putnam County School students.

Jacob Holtzapfel and Brayden Marshall of Winfield High School were among the West Virginia semifinalists to be selected.

National Merit Semifinalists will compete for approximately 7,140 National Merit Scholarships worth nearly \$28 million. Scholarships are awarded in the spring. More than 1.3 million juniors from approximately 21,000 high schools entered the 2024 National Merit Scholarship Program by taking the 2022 Preliminary SAT or the scholarship qualifying test. The nationwide semifinalists represent

fewer than 1% of United States seniors. Of the more than 16,000 semifinalists, about 95% are expected to achieve finalist standing, and approximately half of the finalists will win a National Merit Scholarship.

Finalists will be notified in February 2024, and National Merit Scholarship winners will be announced in four nationwide news releases beginning in April 2024 and concluding in July.

To become a finalist, the semifinalists and a high school official must submit a detailed application that provides information about the student's academic record, participation in school and community activities, demonstrated leadership abilities, employment, and honors and awards received. In addition to an outstanding academic record, the semifinalists must be endorsed and recommended by a high school official, write an essay, and earn SAT or ACT scores that confirm the student's performance on the qualifying test.
