Nucor Steel Breaks Ground for New Mill

Friday, October 20th, was groundbreaking day for Nucor Steel's mill in Mason County. The event was a big deal. U.S. Senators Joe Manchin and Shelley Moore Capito were among the Guinness record setting 545-plus to take shovel-in-hand at the ceremony.

The steel sheet mill at \$2.7 billion is the largest investment in the history of Nucor. The mill will have the capacity to produce 3 million tons of steel sheet annually and will employ approximately 800 full-time employees after it begins commercial operations. In addition, approximately 1,000 temporary construction jobs will be created during the building of the steel mill, which is estimated to take 2 years. Production at the mill is slated to begin before the end of 2026.

The new mill will be one of the most technologically advanced sheet mills and will also have one of the lowest carbon footprints of any sheet mill in the world. The new mill will have advanced steelmaking capabilities, including a high-end automotive galvanizing line and construction-grade line that will allow Nucor to further grow sales of value-added products into these two important end-use markets for sheet steel.

Nucor Corporation, based in Charlotte, North Carolina, is the largest steel producer in the U.S. and the largest recycler of any material in North America. The company operates 25 steel mills that produce approximately one-quarter of America's raw steel using scrap metal as its primary raw material, and more than 250 facilities that produce raw materials or finished steel products for non-residential construction, infrastructure, automotive, heavy equipment, renewable energy and other applications. Nucor is ranked #149 in the 2020 Fortune 500 largest public

companies in America and employs approximately 28,000 teammates.


"Today is an incredibly exciting occasion, and proves the progress that we can make in West Virginia by working together across all levels of government and the private sector. Nucor's establishment in Mason County will put our state at center stage in supporting critical infrastructure and national security efforts in the future. As I was helping negotiate and craft the Infrastructure Investment and Jobs Act that is now law, this is the impact that I knew it could make in our state, and I'm thrilled to see it coming to fruition today," Senator Capito said. "Since the announcement in January 2022, I have worked alongside Nucor's leaders throughout the process and advocated on their behalf. Today's groundbreaking is the culmination of that work."

In prepared remarks, Senator Manchin said, "West Virginia's steel industry was started in Wheeling in 1884. Before and since then, we've mined the coal that forged the steel that built the guns and ships that turned the United States of America into the world's superpower. That would not have been possible without the people of West Virginia. This little state of West Virginia has given everything she has to this great country of ours — but for a while, we've felt like the returning Vietnam Veteran. West Virginians did the dirty work, but we were cast aside. Now, we have arrived, and we are here today to show the rest of the world what our state can do for the infrastructure and energy our country needs and our world needs. Today's groundbreaking is an opportunity to take that legacy to the next level."



through the week were a real effort. This group was a most active one in the church and provided real support as choir members, Sunday School teacher s, etc. at St. Marks. It seemed quite logical that, with the growth of the Teays Valley area, the establishing of a mission would be a reality.

Quite excited over the concept, John, Jim, and I discussed it with Lib Fletcher, and on January 25, I called Bishop Camp bell to present our idea. At the time fifteen families were involved, representing 30 children. On a very icy night, January 30, 1963, a meeting was held at Lib Fletcher's home, attended by 27 adults, and the mission of St. Timothy's (the name chosen by Bishop Campbell) became a reality. On February 21, Lib Fletcher was appointed Diocesan Missioner and was to serve in essence, as vicar of St. Timothy's. On May 5, at a congregational meeting, John Embleton, Richard Paff, and John Slaughter were named as trustees, and an original committee to head up the endeavor was Jim Holliday, Dana Embleton, John Slaughter, William Garwin and Richard Paff. Services were first held at the Hurricane Middle School Gymnasium. It was not the least unusual for a mouse to scurry out of the piano as Miss Libby Embleton played the hymns. We attempted to hold Sunday School in the locker rooms, but the aroma proved stronger than the gospel lessons and we had to admit defeat. It was something to see the little girls in their Sunday dresses, tumbling on the wrestling mats during services. Lay readers and clergymen from Charleston and Huntington conducted the services. It was soon evident that we really needed to find more adequate facilities Bill and Sharon Garvin, though not Episcopalians were attending services. I'm not quite sure how it evolved, but they agreed to have services in their basement in a large laundry room. Some wooden benches were donated, a few discarded kneeling pads, a small wooded alter, and St. Timothy's continued to worship. The Garvin's washer and dryer provided a stand where we had baptisms (also first confirmation). It was quite a shock one Sunday, when the first parishioners arrived to find Bill, still in his pajamas, having forgotten to turn his clock back for daylight savings time! In the meantime, Sunday School was held at the Hollidays' house, across the street. With five

little Hollidays, it provided a good start. A childrens alter was set up for services, and little tables and chairs made one feel we were really official!

In April, Rev. Mycoff looked at several pieces of property, in the valley, and soon after, Lib and Carroll Fletcher agreed to provide the land, a part of their farm, for the church to be built. On February 29, 1964 the "Ground-breaking Ceremony" was held. Rev. Birk Stathers was appointed the previous summer to serve St. Timothy's and Cross Lanes.

It was quite an adjustment for Mr. Stathers to come out of General Seminary in New York, to serve a basement congregation in Hurricane, WV! His collar was quite a novelty to the people in Putnam County, who had had little exposure to Catholicism or Episcopal tradition. They all felt we were a little weird, putting on our hats to go into Garvin's basement! The Cornerstone was laid in April of 1964 and the church really began to take shape. It was thrilling moment in June (9th) that St. Timothy's was officially dedicated. Many of the original accoutrements were given by early members and remain in the church today.

The rural nature of the church was a real asset, and many happy events were held at the Fletcher 's pond or in the enormous hayloft of their barn in back of the church. Sunday School was often held at either site, barn dances, picnics, and pageants were all exciting. An Ordination was held for the Rev. Charles E. Adams, the Rev. Samuel W. Allinder, Jr., the Rev. Custer Ruhey, Jr. and the Rev. Robert S. Smith in March of 1966. Rev. Allinder remained to serve as St. Timothy's next vicar. It was during his stay that the addition was made to the undercroft.

The Rev. Duncan Dormor came as our next vicar with his wife, Mary. He was from England, having first served in the U.S. at Parkersburg. Duncan brought a real depth, with his Church of England background, to our little mission. He was then followed by Peter Scheow and Betty. Dr. William Kirkland served as vicar for 11 years, followed in 1986 by the Rev. Arlie R. Turner. These years were full of church oriented events. Progressive dinners, Halloween parties, services held at the park and pond, Bible School, Miss Libby's dancing classes, a kindergarten, puppet shows, barn dances, teenage "coffee house", guitar lessons, scouts,

thanked Capito and Manchin for their support. "As one of the strongest and most diversified industrial manufacturers in the United States and one of the top five recyclers in the world, Nucor is proud to bring this transformative project to the State of West Virginia. Once operational, our new facility in Mason County will supply the clean, American-made sheet steel products that will be needed to build our nation's economy for decades to come," Topalian said.

TOPS, art classes, AA, Youth Improvement Council (YIC) Inter Community Council (InterComm) and even a horse show sponsored by the church. It has always been a haven for those in need and when a family was burned out, Sc. Timothy's became their temporary home. The Putnam County Pickers used to undercroft for their first practice sessions. A "Blessing of the Animals" was officially held by Duncan Dormor, but it wasn't the least unusual to find a pup or kitten wandering in.

St. Timothy found itself host to a group of Sioux Indians which was a follow-up to a missionary outreach program. The Rev. Francis Apple, his wife and three children and eight Sioux young people from Rosebud Indian Reservation, South Dakota, arrived in a pickup truck to spend a week in Hurricane. Parishioners opened their hearts and homes to them and jointly provided a summer Bible School for all the children.

A year later, two more young people arrived. Steven Joseph Thunderhawk and Bernedine Little Whitman came to Hurricane to start a "new life". The church participated, providing living arrangements, jobs, etc. It was quite an experience, a real story unto itself!

On May 15, 1983, St. Timothy's held a "homecoming" celebrating its 20th birthday. It has been a productive and good 20 years, full of many and varied experiences. 
The church has always had a reputation for having community concern and many members are very active in activities related to this concern. It has been a caring church and service-oriented.



Chocolate Covered Pumpkin Pretzels

Prep time: 10 minutes
Cook time: 5 minutes
Yield: about 36 pretzels

3/4 cup orange candy melts
1 bag (16 ounces) mini pretzel twists
1/4 cup mini green coated chocolate candies

Line baking sheet with parchment paper and set aside.

In medium microwave-safe bowl, melt candy melts 30 seconds then stir. Working in 15-second intervals, continue microwaving until melted and smooth, stirring between intervals. With fork or dipping utensil, dip 36 mini pretzel twists, one at a time, into melted orange chocolate and gently tap side of bowl to remove excess.

Lay each covered pretzel on parchment paper. Using remaining pretzel twists, break apart enough to equal 1/4 cup.

Place one mini green chocolate candy (to form leaf) and one broken pretzel piece (to form stem) on top of each dipped pretzel. Repeat with remaining pretzels and chocolate candies.

Let set until solid. Pretzels can harden on counter about 30 minutes, or placed in refrigerator or freezer 5-10 minutes.

Joshua's Final Exhortation

Joshua 24:1, 14-24

The picture before us, the gathering of the elders and the heads of the tribes of Israel before God prior to the death of Joshua, is somewhat like the gathering which preceded the death of Moses (see Deut. 31:28). The audience is the same. The message is very similar in that both Joshua and Moses expressed doubt concerning Israel's future faithfulness to the Lord.

In verse 14, Joshua urges Israel to serve God in sincerity and in truth. To serve God is to do what God wants done. God told Israel what He wanted in Deuteronomy 6:5 and Leviticus 19:18. Israel was to love the Lord God with all thine heart, soul and might. Israel was to love their neighbors as themselves. They were to do this with sincerity and in truth. Sincerity is free of pretense, deceit, or hypocrisy. Truth is that which is in accordance with that which is known. God had made Himself known to Israel by bringing them up out of Egypt, by sustaining them in the wilderness for forty years, and by driving out the inhabitants of the land before them — the land which He had promised to the seed of Abraham.

"... and put away the gods your fathers served on the other side of the flood, and in Egypt; and serve the Lord" (v. 14b). The gods which the fathers served on the other side of the flood are the gods which Abraham left behind in Ur (see 24:2-3). The gods which the fathers served in Egypt were exposed when Aaron's rod swallowed up the rods of the magicians of Egypt and the plagues which followed (Ex. 7:12-12:29). Israel was to serve the one true and only God.

"And if it seem evil..." (v. 15a). Joshua implored the people to choose between the one true God and the false gods that their fathers had served and the false gods of the Amorites. "... but as for me and my house, we will serve the Lord" (v. 15b). "And the people answered..." (v. 16). The people answered with all of the right words. The people acknowledged all that the Lord had done. The people said, "... therefore will we also serve the Lord" (v. 18).

Joshua answered, "Ye cannot serve the Lord" (v. 19a). Stop! Stop reading! Joshua and his family would serve the Lord. Joshua is speaking the words which God has given to him. Why does God state that the people cannot serve Him? Joshua cites three reasons: God is holy; God is a jealous God; and God will not forgive their transgressions nor their sins.

Israel could not serve God because God is a holy God. Why does God's holiness prevent Israel from serving Him? God reveals the reason in Leviticus 19:2 — "Ye shall be holy; for I the Lord your God am holy." To serve God, one must be holy as God is holy. No one, not even born again believers, can serve God by virtue of their own holiness. New Testament believers are empowered to serve God by the holiness (the righteousness) which has been given to them by grace through faith.

The second reason that Israel could not serve God is because God is a jealous God. Lexicographers equate jealousy with envy. God has a different meaning. Read Exodus 20:5. Israel was not to bow down before graven images or to serve graven images. A graven image is a representation of something which God has created. God requires men to bow down to and serve the real thing. One cannot serve the real thing unless one knows the real thing. New Testament believers know the real thing. Jesus said, "... he that hath seen me hath seen the Father" (Jn. 14:9). Believers know the real thing because the Son has revealed Him to us.

The third reason that Israel could not serve God is because "... he will not forgive your transgressions nor your sins" (v. 19b). This statement is NOT contrary to I John 1:9 — "If we confess our sins, he is faithful and just to forgive us our sins, and to cleanse us from all unrighteousness." Why not? God's word states "... by his knowledge shall my righteous servant justify many; for he shall bear their iniquities" (Isaiah 53:11). God the Father did not forgive our sins. God the Father placed all of our sins upon the Son who suffered death for us. The Son paid the full price of our iniquities. We are cleansed of unrighteousness because God is just. God is merciful; He counts believing for righteousness. Israel could not serve God because Israel believed in their own righteousness, a righteousness that they did not possess.

Israel heard the words which the Lord gave to Joshua but chose not to believe them. Joshua had told them why that they could not serve the Lord. They replied, "Nay; but we will serve the Lord" (v. 21). The people placed trust in themselves over the word of the Lord God. They would become witnesses against themselves. They testified of a righteousness that they did not possess.

"... put away, said he, the strange gods which are among you, and incline your heart unto the Lord God of Israel" (v. 23). These are the words which God gave to an unbelieving people through Joshua. God reached out to Israel with these words. God reaches out to men of today in like manner. All who incline their hearts to Him and believe shall be saved.

God would have all to hear and come to repentance.

The following events happened on these dates in West Virginia history. To read more, go to e-WV: The West Virginia Encyclopedia at www.wvencyclopedia.org.

Oct. 26, 1801: Jefferson County was established from a portion of Berkeley County by the Virginia General Assembly and named for Thomas Jefferson.

Oct. 26, 1934: Athlete Rodney Clark "Hot Rod" Hundley was born in Charleston. Hundley earned first team All-American recognition his senior year at West Virginia University. He averaged 24.5 points per game and scored 2,180 points over his college career, ranking second in WVU history.

Oct. 27, 1879: Howard B. Lee was born in Wirt County. He was elected state attorney general in 1924, and served for eight challenging years. His term saw the impeachment of a state auditor, the lawlessness of Prohibition, and labor

troubles in the coalfields.

Oct. 28, 1972: Brad Paisley was born in Glen Dale. Paisley has received the Entertainer of the Year award from the Country Music Association and 14 Academy of Country Music Awards.

Oct. 29, 1861: Confederate commander Robert E. Lee ended his ill-fated western Virginia campaign. His three months in the region were marked by rain, mud, inexperienced officers, diseases among the troops, and rampant criticism of his leadership.

Oct. 29-30, 2012: Following Hurricane Sandy, heavy wet snow fell across West Virginia. With accumulations approaching 40 inches, it surpassed all previously known October snowstorms.

Oct. 30, 1825: Randolph McCoy was born in Logan County. In 1878, McCoy's accusation against a cousin of Anderson "Devil Anse"

Hatfield for stealing a hog set off a deadly series of events in the Hatfield-McCoy Feud.

Oct. 31, 1877: Herman Guy Kump was born in Capon Springs, Hampshire County. He was the 19th governor of West Virginia, serving from 1933 to 1937.

Oct. 31, 1940: Gale Catlett, West Virginia University basketball player and coach, was born in Hedgesville. Catlett coached WVU to 13 20-win seasons before he retired in 2002.

Oct. 31, 1946: Labor leader Cecil Edward Roberts Jr. was born on Cabin Creek, Kanawha County. A sixth generation coal miner and a fiery orator, Roberts has served as president of the United Mine Workers of America since 1995.

Nov. 1, 1688: Morgan Morgan was born in Wales. For many years, Morgan was traditionally considered the first white settler of West Virginia. He settled in the Bunker Hill area in 1731, building a log house that still remains.

Nov. 1, 1848: Israel Charles White was born in Monongalia County. White was West Virginia's first state geologist, appointed in 1897 and serving until his death in 1927, working without pay for all but two of those years.
