## City Council to Consider Water, Sewer Rate Increases

 The December 4th City of Hurricane Council meeting was a time of recognition for Hurricane Middle and Calvary Baptist athletic teams and a time to act upon several new business issues.

Council honored the Calvary Baptist Academy soccer team for winning the WVCAT Championship. The Brian Ray coached team finished the season with a 12-7 record against a schedule that included public schools. The Soccer Championship was the school's first since 2009.

The Hurricane Middle Cross Country and Boys Tennis teams were recognized for winning Mid Valley Athletic Conference championships. The HMS Cross Country Team posted a perfect record against West Virginia competition. The Boys Tennis Team's MVAC Championship was quite an achievement as six of the nine members had never played tennis prior to this year.

Council held the second reading of an ordinance which expands the boundaries of Hurricane's TIF (Tax Increment Financing) district to include areas near the I-64 Culloden interchange that is under construction.

Council set January 2nd public hearings dates for water and sewer rate increases and held the first reading of "Ordinance of Council Amending,

Modifying and Re-enacting Article 939.03 of the Codified Ordinances of the City of Hurricane, as revised, Regarding Water Rates and Charges" and first reading of "Ordinance of Council Amending, Modifying and Re-enacting Article 939.14 of the Codified Ordinances of the City of Hurricane, as revised, Regarding Sewer Rates and Charges." The proposed rate increases are projected to be more than 50% for minimum water users.

Council granted approval for city officials to approach the WVDOT regarding the possible purchase of DOT property at the junction of State Routes 19 and 34. The purchase would allow the city to lease the property to Mountain State Waste.

Hurricane Police Chief Mike Mullins reported that a locker search conducted at Hurricane High School during November by the Department's K-9 officer turned up several jars of marijuana and some counterfeit money. Drug seizures during the month were 9.7 grams of marijuana, 5.5 grams of Meth, 4.3 grams of yellow Fentanyl, 1.7 grams of Blue Fentanyl.

HPD made 8 arrests which were charged to the State and 16 charged to the City. The City arrests included 14 for shoplifting and one for possession of marijuana. The Department issued 146 citations and 157 warnings during the month.

 This year's Hurricane Christmas Parade featured a Whoville theme and was projected to be the largest and best ever. It was all this and more.

The Grinch of Dr. Seuss' *How the Grinch Stole Christmas* was present but was not able to steal Hurricane's parade because Mayor Scott

Edwards and the Hurricane Police Department chased the rascal on the parade route from First Baptist Church to the city limits beyond Hurricane Bridge Park.

The more than 140 entries easily made the parade the largest in Hurricane's 135-year history. Entries were not limited to a single float.

Dancing Unlimited entry required seven vehicle drawn floats. While five horse entries were registered, more than twenty horses preceded Santa's arrival in his sleigh.

Other entries included churches, schools, civic organizations, businesses, political office seekers, healthcare providers, clubs, fire trucks, and individuals.

The parade was an area event with participants from Cabell County joining the Whoville parade.

Unlike many of Putnam County's parades, Hurricane's parades, both 4th of July and Christmas, move rapidly. That said, State Route 34 was closed down an hour and 15 minutes and Main Street much longer.

Hurricane City offices will be closed on Monday, December 25th and January 1st for Christmas and New Years. The next council meeting will be Tuesday, January 2nd at 6:30 p.m.

## The Centennial History of Hurricane Hurricane Area Organizations

In 1988, The Centennial History of Hurricane, WV was published to commemorate the town's 100th anniversary. The publication included the histories of 7 Hurricane civic organization. This week's selection is the 6th of these histories which were published in 1988.

AF & AM was chartered in November 1908 by the Grand Lodge of West Virginia.

The membership rented a hall in the Putnam County Bank Building on Putnam Avenue and met there until 1935 when they purchased the old Reynolds store building nearby. That building was remodeled to serve as a

## Voters Asked to Respond to Residency Information Request

Voter list maintenance has been a priority for the WV Secretary of State's Office since Warner first took office in 2017. By working closely with all 55 county clerks to provide the tools necessary to operate a uniform, non-partisan voter registration list maintenance process, Warner reports that over 400,000 deceased, duplicate, out-of-state, convicted-felon voter, or otherwise ineligible registration files have been removed from the Statewide Voter Registration System since the 2016 election, as indicated by the most recent Election Administration and Voting Survey (EAVS). At the same time, more than 333,000 new voters have been registered to vote, which includes more than 100,000 high school students.

Over 109,000 instances of possible abandoned voter registrations in West Virginia have been identified by an updated address comparison with the United States Postal Service (USPS), the WV Department of Motor Vehicles (DMV), or by official election mail that was returned as undeliverable. These addresses will soon receive an important confirmation postcard from their county clerk's office.

"West Virginia and federal laws require election officials to send a postcard to each address of a voter who is identified as possibly abandoning their registration. These voters were identified when they provided a newer address to the USPS, DMV, or when official election mail was returned which indicated a voter may have moved," said Secretary Warner. "If the voter moved to another West Virginia county, we can help them update their registration," Warner continued. "If they moved out of state, they are no longer eligible to vote and we encourage them to cancel their voter registration."

These postcards are expected to arrive in voters' mailboxes in the coming weeks. The postcard asks the voter to confirm that they are still a resident of the state and county at the address on their voter registration record.

Secretary Warner encourages every voter who receives the confirmation postcard to confirm that they reside at the address on file or update the address by scanning the QR code on the postcard with a mobile device and follow the easy steps to keep their registration in "active" status. Voters can also check and update their registration information online at [ovr.sos.wv.gov](http://ovr.sos.wv.gov), or by returning the pre-paid postage postcard to their county clerk.

Regular maintenance on voter registration lists is mandated by the National Voter Registration Act and West Virginia law. Voters who confirm their address by returning a postcard will remain "active."

Voters whose postcards are not returned, or are returned by the USPS as "undeliverable," will be categorized as "inactive." Voters who are "inactive" still remain eligible to vote in the next two federal election cycles. However, if a voter's registration address remains unconfirmed for the next two federal general elections after receipt of the confirmation notice, and the voter fails to vote in any state or local election during that time period, state law mandates that the registration be canceled.

"The law is in place to make sure voters on West Virginia's voter registration rolls are still residents of West Virginia at the address on file with their county clerk. Many times, we find that these voters moved and simply forgot to cancel their registration," Warner said.

- 1 1/2 tablespoons pure maple syrup
- 1/2 teaspoon kosher salt
- 1/4 teaspoon ground nutmeg
- 1/2 cup dried cranberries
- 1/2 cup dark chocolate chips

In large, microwave-safe bowl, add pecans, rice squares cereal and pretzels. In small, microwave-safe bowl, add butter, brown sugar, maple syrup, salt and nutmeg. Microwave butter mixture 1-2 minutes until melted then pour over dry mix. Toss well to combine.

Microwave snack mix in 45-second intervals, about 4-5 intervals total, until mix is fragrant, golden and toasty.

Cool mix completely then stir in cranberries and dark chocolate chips.

### Learning Contentment

Philippians 4:4-18

"Rejoice in the Lord always . . ." (v. 4). In verses 4 and 5, Paul directs the Philippian believers to rejoice continually in the Lord and to let their moderation be known unto all men. The Greek translated here as "moderation" is *epieikes*, meaning moderate in the sense of letting one's patience and gentleness be known.

This instruction follows a plea from Paul to Euodias and Syntyche to be of the same mind in the Lord (v. 2). Who were Euodias and Syntyche? They were two women who had labored with Paul to communicate the gospel of Jesus Christ but now found themselves to be in disagreement over a matter that they considered to be of personal importance. Once united in the cause of Christ, they had strayed from the path.

Paul's instruction to "Rejoice in the Lord" and "Let your moderation be known" directs and informs all believers upon the manner in which we are to approach fellow believers who are of different mind. It is instruction given to the Philippians on how to re-establish the unity in Christ that once joined Euodias and Syntyche. There is no division in Christ (1 Cor. 1:10). We are to maintain unity by focusing upon Him who knew no sin. We are to destroy barriers that separate by rejoicing in Him and displaying the moderation that He has shown to us.

"Be careful for nothing . . ." (v. 6). We are not to hold back. We are to fully trust in Him. We are to ask, believing that He will supply all things according to that which He has promised. All things work together for good when we love Him as we should (Rom. 8:28). He shall deliver the peace that passes understanding, the peace that keeps our hearts and minds in Him (v. 7).

In verse 8, Paul instructs believers to think upon things which are true, are honest, are just, are pure, are lovely, are of good report. While his words may sound to some as though Paul is advocating the power of positive thinking, he is not. All that Paul implores us to think upon are found in Christ. Paul is instructing us to think upon those things which are of God, things which the Son has made known to us, things which are exceedingly greater than our works which are as filthy rags (Isa. 64:6). Paul elaborates upon the things which we are to think in verse 9. They are things which the Philippians had learned, had received, had heard and seen. We, like the Philippians, have learned things of Christ through instruction and through having received (accepted and taken hold of) them. We also have experienced Christ in that which we have heard from and seen in other believers. We can abide in Him and He in us when we do as Paul has instructed.

Paul shares an example of his own rejoicing. He rejoiced because ". . . at the last your care of me hath flourished again" (v. 10). The care which Paul cites is that which Epaphroditus delivered to him on behalf of believers at Philippi (see 2:25). This was not the first time that the church had sent gifts to Paul. The church at Philippi was among the churches of Macedonia (see II Cor. 8) that had previously provided financial assistance to Paul's ministry.

Paul states that their care (their thoughtful mindfulness of his needs) is the cause of his rejoicing. Paul is not rejoicing because of benefit received. Paul is rejoicing because the Philippians related to his afflictions (see v. 14). Their actions testify of their love for their Lord and Savior. Paul rejoices because they shall be rewarded for the love of Christ which is evident in them.

As for his personal needs, Paul states, "I have learned, in whatsoever state I am, therewith to be content" (v. 11). Paul has learned from experience. It is by experience that one learns to trust the Lord in all things. The Lord fulfills His promises time after time without fail. The book of Acts lists the many learning experiences which gave Paul cause to trust the Lord. God uses believers to reach out to the unbelieving. Paul was content because he had learned that the Lord is all sufficient. He had learned that he could stand upon every promise of the Lord.

Paul knew how to be abased (belittled) and how to abound (v. 12). Paul had learned to trust in the Lord in every situation and on every occasion. Paul had learned from experience. It is by and through experience that he could state: "I can do all things through Christ which strengthen me." Paul could do all things through Christ because His word is true. Jesus said: "And whatsoever ye shall ask in my name, that will I do, that the Father may be glorified in the Son" (Jn. 14:13). Paul did not hold back in trusting the Lord. He sought to glorify the Son.

In verse 18, Paul states that he has all, that he abounds. He is full because he has received that which Epaphroditus has delivered — an odour of a sweet smell, a sacrifice acceptable, well-pleasing to God. Paul is not speaking of cologne; the odour of sweet smell is the spiritual sacrifice that is well-pleasing to God. Paul finds himself to be full because their act of giving is a fruit deposit (v. 17) into an account that produces eternal reward. Paul is filled with joy because God rewards the faith of them that diligently seek Him (Heb. 11:6).

Paul's message is not for the Philippians alone. It is for all would let the power of God's love be seen in them. Let us "rejoice in the Lord always" and let our moderation be known. May His love abound in us.


